- Any reference to area/rohe moana means the area beginning on the coastline approximately 2 kilometres south-west of East Cape (37° 42.2' S 178° 32.5' E), then generally east to a point beyond the Ranfurly Bank (37° 38.3' S, 179° 00.0' E), then generally north to a point (37° 31.5' S, 179° 00.0' E), then generally west to a point (37° 33.1' S, 176° 28.4' E) in line with Matakaoa Point, then generally south-west to the mouth of the Awatere River (37° 38.0' S, 178° 22.6' E), then generally south-east following the coastline to the point of commencement (derived from WGS84 datum).

**3. Appointment of Kaitieki**—The Associate Minister of Fisheries (acting pursuant to a delegated authority) hereby confirms the appointment of the Matahi-o-te-Tau Marae trustees and committee members for managing mahi kaimoana within the area/rohe moana.

**4. Confirmation of tangata whenua**—Te Whanau-a-Hunaara is confirmed as the tangata whenua of the area/rohe moana to which the appointment of Kaitieki relates.

**5. Power to authorise taking of fisheries resources for mahi kaimoana**—The Kaitiaki may authorise any individual to take fisheries resources managed under the Fisheries Act 1996, other than those fisheries resources that are taken in fresh water, for mahi kaimoana purposes from within the whole or any part of the area/rohe moana. No mahi kaimoana of fisheries resources may take place in the area/rohe moana without authorisation from the Kaitiaki.

**6. Area of shared management**—Te Whanau-a-Hunaara and the Kaitiaki acknowledge there will be shared management of, and responsibility for, mahi kaimoana with Nga Whanau Hapū o te Riu o Waiapu for an area around Whangaokeno (East Island) once this collective has had its Tangata Kaitiaki/Tiaki confirmed by the Minister responsible for the Fisheries (Kaimoana Customary Fishing) Regulations 1998.

“trust deposit” means a deposit held on trust:

(i) for persons not of full age or capacity; or

(ii) for beneficiaries not entitled to payment at call; or

(iii) otherwise than at call (not being a special deposit).

(2) Expressions defined in the Act have the same meaning in this notice as they do in the Act.

**3. Rates of Common Fund interest**—(1) The rate of Common Fund interest payable on a deposit (other than an investment deposit repayable at the end of a fixed term) shall be that specified in Schedule 1 for the appropriate type of deposit.

(2) The rate of Common Fund interest payable on an investment deposit repayable at the end of a fixed term shall be that specified in Schedule 2 for the appropriate term and dollar range.

(3) Despite subparagraph (1), the rate of Common Fund interest payable on a deposit made pursuant to an enactment shall be the rate (if any) specified in the enactment.

(4) Despite subparagraph (1), in particular cases or classes of case, Public Trust and the depositor may agree on a rate of interest payable on a special deposit that is different from the rate specified in Schedule 1 and the agreed rate then applies.

**4. Revocation of notice and transitional provisions**—(1) The Public Trust Common Fund Interest Rates Notice 16 May 2002 is revoked.
