# Disciplinary Tribunal of the Institute of Chartered Accountants of New Zealand—Notice of Decision (Member Suspended)—Russell Charles Sears

At a hearing held on the 13th day of March 2002, the Disciplinary Tribunal of the Institute of Chartered Accountants of New Zealand considered an *ex parte* application from the Professional Conduct Committee of the Institute to suspend a member.

The Tribunal resolved unanimously, pursuant to Rule 21.20 of the Rules of the Institute of Chartered Accountants of New Zealand issued under the Institute of Chartered Accountants of New Zealand Act 1996, to suspend **Russell Charles Sears** from membership on the terms that:

- (a) The Tribunal is satisfied that it is necessary and desirable, having regard to the interests of the public, that Russell Charles Sears be and is suspended from membership of the Institute of Chartered Accountants of New Zealand pending the further order of the Tribunal.
- (b) Following the expiration of 14 days from the giving of notice of this decision to **Russell Charles Sears**, notice of suspension be published in *The Dominion*, the *Wanganui Chronicle*, the *New Zealand Gazette* and the *Chartered Accountants Journal of New Zealand*.

# Persons Ineligible to be Trustees

A person cannot be a member of a school board of trustees who:

- is a permanent employee of the school board (except by being elected as the staff representative); or
- is a mentally disordered person; or
- is a bankrupt who has not yet obtained a discharge; or
- is not a New Zealand citizen (unless they have been given approval, or are entitled to reside in New Zealand for more than 12 months); or
- has been convicted of an offence (for which the person could have been sent to prison) and has not been sentenced for the offence, or has been sentenced for it and has not:
  - i received a full pardon; nor
  - ii suffered the penalty imposed.

A returning officer is ineligible to be nominated as a candidate in the election they are the returning officer for.

A person who has a contract, or contracts with a board which exceed/s \$25,000 in a financial year [unless the board obtains the approval of the Secretary for Education] is also ineligible to be nominated as a candidate for the board they have the contract/s with.

# Notice of Intention to Declare a Major Maritime Event

Pursuant to section 200A (3) (d) of the Maritime Transport Act 1994, I give notice that I have received from the Auckland Regional Council an application to declare the Louis Vuitton Cup 2002/2003, the Thirty-first America's Cup Match and the Defender's Internal Racing Campaign to be events to which section 200B of the Maritime Transport Act 1994 applies for the period from 1 October 2002 to 6 March 2003 inclusive, and that I intend to make a declaration to that effect by notice in the *New Zealand Gazette*.

# **Proposed Areas, Conditions and Requirements**

It is intended that the following conditions and requirements will apply to the areas as described:

# America's Cup Village Area

This area is defined as those waters which lie to the south of a line joining the northernmost ends of Wynyard Wharf and Princes Wharf.

Within this area, the following conditions and requirements will apply:

- 1. All vessels are restricted to a maximum speed of 5 knots.
- 2. No vessel may approach within 100 metres of vessels transferring fuels or chemicals at Wynyard Wharf.
- 3. All vessels must obtain clearance from Viaduct Control on VHF Channel 73 before entering this area or leaving any berth in this area.

#### **Inner Harbour West**

This area is defined as that sea area lying to the east of the Auckland Harbour Bridge and to the west of a line drawn between Point Resolution and the south-eastern end of Devonport Wharf.

Within this area, the following requirement applies:

All vessels, excluding those plying registered ferry operations, are restricted to a maximum speed of 10 knots.

### **Inner Harbour East**

This area is defined as that sea area bounded to the west by a line drawn between Point Resolution and the south-eastern end of Devonport Wharf, to the south by No. 8 and No. 10 buoys, and the northern tip of Fergusson Wharf, to the east by Bean Rocks Lighthouse and by No. 6 and No. 4 buoys, to the north by latitude 36° 46.7′ S.

Within this area, the following conditions and requirements apply:

- 1. All vessels, excluding those plying registered ferry operations, or those using the high-speed lane at the southern and eastern boundaries of the area, are restricted to a maximum speed of 10 knots.
- 2. The commercial shipping channel is reserved for the use of commercial shipping operations controlled by the Ports of Auckland Limited and by those vessels specifically authorised to use this channel by the Auckland Regional Council's Harbourmaster.

#### Race Track Area

This area is defined as the sea area bounded to the south by latitude 36° 46.7′ S, to the west by the coastline of the North Shore, to the north by the coastline of the Whangaparaoa Peninsula extended to the southern tip of Tiritiri Matangi Island and thence to 36° 36′ S 174° 59′ E, to the east by a line drawn from position 36° 36′ S 174° 59′ E to the Ahaaha Rocks thence to the northern tip of Rakino Island and thence by a line from the northern tip of Rakino Island to Billy Goat Point and along the shoreline of Motutapu and Rangitoto Islands, to join with latitude 36° 46.7′ S.

Within this area, race courses will be established for the Louis Vuitton Cup 2002/2003, the Thirty-first America's Cup Match and the Defender's Internal Racing Campaign from day to day and will be publicly announced.

Inside the race courses the following condition will apply:

Only competing International America's Cup Class yachts, associated tenders, umpires, marshal boats and vessels accredited by the event organisers may navigate within the race course area during the period of racing operations for that day.

Outside the established race courses, normal navigation is permitted although speed restrictions may be imposed in coastal areas.

# **General Conditions and Requirements**

The following applies to all areas specified above.

The Auckland Regional Council may:

- 1. order the suspension or abandonment of racing operations if, in the opinion of the Auckland Regional Council's Harbourmaster, adequate levels of public safety cannot be guaranteed. This power will be exercised in consultation with the New Zealand Police, the event organiser and Ports of Auckland Limited.
- specify and vary conditions and requirements for the day-to-day management and conduct of activities within each area, for the purpose of protecting the safety of the public and the International America's Cup Class yachts and their support craft.

On race days, the co-ordination and management of commercial shipping in Waitemata Harbour will be conducted jointly between the Auckland Regional Council's Harbourmaster and Marine Services Manager, Ports of Auckland Limited.

### **Proposed Hours of Operation**

All areas, except the America's Cup Village area, will generally be active from 0800 to 1800 hours (subject to changes determined on a daily basis). The specific hours of operation will be announced on public broadcasting and marine communication channels.

The America's Cup Village area will be active 24 hours a day for the entire period covered by the proposed declaration.

### **Means of Enforcement**

Compliance with the above conditions and requirements will be enforced by appointed enforcement officers, as defined in section 200B (6) of the Maritime Transport Act 1994.

Under section 200B (5) of the Maritime Transport Act 1994, any person in charge of a ship, craft or seaplane who contravenes this notice commits an infringement offence and is liable to the relevant penalty prescribed in the Maritime Transport (Infringement Fees for Offences Relating to Major Maritime Events) Regulations 1999.

### **Application to Enforcement Officers**

Enforcement officers may, in the course of their duties, be exempt from rules or conditions applying in respect of the areas to which the notice applies but must at all times navigate in accordance with Maritime Rule Part 22: Collision Prevention.

#### **Legal Services Act 2000**

# Amendments to Listing Criteria for Specific Legal Services

The Legal Services Agency is required, under section 71 of the Legal Services Act 2000, to give notice in the *New Zealand Gazette* of new or amended listing criteria for determining when a person may be approved to provide specific legal services.

As a result of the Sentencing Act 2002, the agency is amending the descriptions in its provider manual of criminal provider proceedings categories 3 and 4.

The new descriptions are as follows (new section in italics).

#### **Proceedings Category 3**

Jury trials before any court or before a District Court or High Court judge alone following an application under section 361B of the Crimes Act 1961 (including the preliminary hearing of the offence) where the most serious charge carries a maximum penalty of more that 10 years' imprisonment (other than life imprisonment and other than where the person is convicted and a High Court judge indicates they are considering a sentence of preventive detention. The matter becomes a PC 4 at that stage.)

#### **Proceedings Category 4**

Jury trials in any court (including the preliminary hearing of the offence) where any charge carries a maximum penalty of life imprisonment or where the aided person, if charged, is likely to face a sentence of preventive detention.

These changes are to ensure that proceedings categories 2 and 3 providers can continue to represent legally aided people who are potentially liable (but not likely) to face a sentence of preventive detention.

If the High Court judge indicates they are considering a sentence of preventive detention, the agency will assign a proceedings category 4 co-counsel to the case.

The agency's LSA News publication dated July 2002 contains details of the relevant changes to assignment procedures.

There are no changes to other proceedings categories descriptions.

The new proceedings categories descriptions are effective 1 July 2002.

The agency's provider manual will be amended in due course to reflect these changes.
