“special deposit” means a deposit held other than at call on behalf of the Crown, or any local authority within the meaning of the Local Government Act 1974;

“trust deposit” means a deposit held on trust:

- (i) for persons not of full age or capacity; or
- (ii) for beneficiaries not entitled to payment at call; or
- (iii) otherwise than at call (not being a special deposit).

(2) Expressions defined in the Act have the same meaning in this notice as they do in the Act.

3. Rates of Common Fund interest—(1) The rate of Common Fund interest payable on a deposit (other than an investment deposit repayable at the end of a fixed term) shall be that specified in Schedule 1 for the appropriate type of deposit.

(2) The rate of Common Fund interest payable on an investment deposit repayable at the end of a fixed term shall be that specified in Schedule 2 for the appropriate term and dollar range.

(3) Despite subparagraph (1), the rate of Common Fund interest payable on a deposit made pursuant to an enactment shall be the rate (if any) specified in the enactment.

(4) Despite subparagraph (1), in particular cases or classes of case, Public Trust and the depositor may agree on a rate of interest payable on a special deposit that is different from the rate specified in Schedule 1 and the agreed rate then applies.

4. Revocation of notice and transitional provisions—(1) Subject to subparagraph (2), the Public Trust Common Fund Interest Rates Notice 12 September 2002 is revoked.

- (a) Inside the race courses only competing International America's Cup Class yachts, associated tenders, umpires, marshal boats and vessels accredited by the event organisers may navigate within the race course area during the period of racing operations for that day.
- (b) Outside the established race courses normal navigation is permitted although speed restrictions may be imposed. Changes to speed restrictions will be advised on marine VHF channels.
5. The Auckland Regional Council may:
- (a) Order the suspension or abandonment of racing operations if, in the opinion of the Auckland Regional Council's Harbourmaster, adequate levels of public safety cannot be guaranteed. This power will be exercised in consultation with the New Zealand Police, the Event Organiser and Ports of Auckland Limited.
- (b) Specify and vary conditions and requirements for the day to day management and conduct of activities

within each area, for the purpose of protecting the safety of the public and the International America's Cup Class yachts and their support craft.

On race days the co-ordination and management of commercial shipping in Waitemata Harbour will be conducted jointly between the Auckland Regional Council's Harbourmaster and Marine Services Manager, Ports of Auckland Limited.

Hours of Operation

All areas, except the America's Cup Village area, will generally be active from 0800 to 1800 hours (subject to changes determined on a daily basis). The specific hours of operation will be announced on public broadcasting and marine communication channels.

New Zealand Game Industry Board

Game Industry Board Regulations 1985

Game Industry Board/Deer Industry New Zealand

1. Deer Industry New Zealand.

1.1 With effect from 1 October 2002, Deer Industry New Zealand is the operating name of the Game Industry Board.

2. Board levy.

2.1 Under Regulation 17 (3) of the Game Industry Board Regulations 1985, the Game Industry Board ("the board") fixes the rates of board levy (which levy rates are exclusive of goods and services tax imposed by the Goods and Services Tax Act 1985) as follows:

- (a) On each deer, other than fallow deer, slaughtered in deer slaughtering premises, on the basis of hot clean carcass weight after removal of condemned parts:

18.4 cents per kilogram.
- (b) On each fallow deer slaughtered in deer slaughtering premises, on the basis of hot clean carcass weight after removal of condemned parts:

15.4 cents per kilogram.
- (c) On each killed game deer carcass received at a packing house, zero cents per kilogram cold clean carcass weight after removal of condemned parts.
- (d) On each piece of antler from deer other than fallow deer received at a packing house for processing or packing, on a green weight basis:

384 cents (three hundred and eighty-four cents) per kilogram.

- (e) On each piece of antler from fallow deer received at a packing house for processing or packing, on a green weight basis:

134 cents (one hundred and thirty-four cents) per kilogram.

2.2 No levy is payable when the value of the velvet grade, as defined by the Industry Agreed Grading Guidelines, is less than or equal to \$15.00/kg (G.S.T. exclusive).

2.3 If the Deer Slaughtering Premises ("DSP") or Packing House ("PH") fails to keep accurate records relating to the board levy or to file accurate returns relating to the board levy, then the levy payable will be assessed by the board with reference to such information as the board considers fit.

3. DSPs are not required to collect levies on Tb reactors but will be required to report the number of reactor deer slaughtered to the board in their monthly returns. The levy will be waived for those Tb reactors which are identified with an official reactor tag and where they arrive at the DSP accompanied by an official permit to move.

4. A nil rate of levy applies to any farmed deer or killed game deer carcasses which are wholly condemned for any reason following slaughter or receipt into a PH.

5. No levy is payable in respect of any one farmed deer carcass or piece of antler more than once.

6. These rates of levy come into effect on and from 1 October 2002 and apply until 30 September 2003, or until such time as new levy rates are fixed and come into force.

7. Under Regulation 17A (1), notice is given that the board fixes the rate of additional levy payable in respect of failure to pay, or late payment of, amounts of board levy payable on or after 1 October 2002 at 10 percent of the amount of levy unpaid.

8. The additional levy for failure to pay or late payment may be applied by the board at a rate of 10 percent on the outstanding balance following expiration of the period within which payment is required to be received by the Board, and is payable by the DSP or PH concerned.

9. Of the board levy, a portion will be paid to the Animal Health Board as the deer industry's contribution to the Animal Health Board's activities under the national pest management strategy for bovine tuberculosis. The board levy will be broken down as follows:

9.1 For the Game Industry Board:

- Venison (fallow) 7 cents per kilogram.
- Venison (other) 10 cents per kilogram.
- Velvet (fallow) \$0.50 per kilogram.
- Velvet (other) \$3.00 per kilogram.

9.2 For the Animal Health Board:

- Venison 8.4 cents per kilogram.
- Velvet 84.0 cents per kilogram.
