Provisional Direction: Galvanised Wire From South Africa

Pursuant to section 16 (1) of the Dumping and Countervailing Duties Act 1988 ("the Act"), I hereby give notice that, on the basis of the information made available during the investigation to date, I have reasonable cause to believe, in relation to the importation of the goods specified in the First Schedule to this notice (hereinafter referred to as the subject goods), that:

- (a) the subject goods are being dumped; and
- (b) by reason thereof, material injury to the New Zealand industry has been and is being caused;

and also I am satisfied that action under section 16 of the Act is necessary to prevent material injury being caused during the period of investigation.

Pursuant to section 16 (1) of the Act, I hereby give notice of a provisional direction that payment of the rate of anti-dumping duty set out in the Second Schedule to this notice, in respect of the subject goods, shall be secured in accordance with sections 156 and 157 of the Customs and Excise Act 1996.

Initiation of Dumping Investigation: Glass Wool Insulation From Taiwan

Notice is hereby given that, acting pursuant to section 10 (1) of the Dumping and Countervailing Duties Act 1988 and under delegated authority from the Chief Executive of the Ministry of Economic Development, I have initiated an investigation to determine both the existence and effect of the alleged dumping of the goods described in the Schedule to this notice originating from Taiwan, being satisfied that sufficient evidence has been provided that:

- (a) the goods imported or intended to be imported into New Zealand are being dumped; and
- (b) by reason thereof, material injury is being caused to a New Zealand industry producing like goods,

and also being satisfied that the collective output of those New Zealand producers who have, in writing, expressed support for the application constitutes:

- (a) 25 per cent or more of the total New Zealand production of like goods produced for domestic consumption (assessed during the most recent representative period, being not less than six months); and
- (b) more than 50 per cent of the total production of like goods produced for domestic consumption (as so assessed) by those New Zealand producers who have, in writing, expressed support for or opposition to the application.

Customs (Inward Report) Amendment Rules 2002

Pursuant to sections 288 (1) (a) and (12) of the Customs and Excise Act 1996, the Chief Executive hereby makes the rules prescribing the form for the making of inward reports in respect of aircraft and amends the Customs (Inward Report) Rules 1996.

- 1. Title—(1) These rules are the Customs (Inward Report) Amendment Rules 2002.
- (2) In these rules, the Customs (Inward Report) Rules 1996* are called "the principal rules". (*CR 1A/1996)
- 2. Commencement—These rules come into force on the 28th day after the date of their publication in the New Zealand Gazette.
- **3.** Rule 3 and Schedule Amended—(1) The Schedule to the principal rules is amended by revoking form C1A and substituting form C1A set out in the Schedule of these rules.
- (2) Except to the extent amended by these rules, the principal rules shall remain in force.
- 4. Status of Rules—These rules are Regulations for the purposes of the Regulations (Disallowance) Act 1989.

Pursuant to sections 288 (1) (b) and (12) of the Customs and Excise Act 1996, the Chief Executive hereby makes the rules prescribing the form for the making of outward reports in respect of aircraft and amends the Customs (Outward Report) Rules 1996.

- 1. Title—(1) These rules are the Customs (Outward Report) Amendment Rules (No. 2) 2002.
- (2) In these rules, the Customs (Outward Report) Rules 1996* are called "the principal rules". (*CR 1B/1996)
- 2. Commencement—These rules come into force on the 28th day after the date of their publication in the New Zealand Gazette.
- **3.** Rule 3 and Schedule Amended—(1) The Schedule to the principal rules is amended by revoking form C2A and substituting form C2A set out in the Schedule of these rules.
- (2) Except to the extent amended by these rules, the principal rules shall remain in force.
- 4. Status of Rules—These rules are Regulations for the purposes of the Regulations (Disallowance) Act 1989.
