Statement to the Commerce Commission of the Economic Policy of the Government: Electricity Financial Transmission Rights

The following statement has been transmitted to the Commerce Commission by the Minister of Commerce as a statement of the economic policy of the Government pursuant to section 26 of the Commerce Act 1986.

Government Policy Statement on Electricity Financial Transmission Rights

This Government Policy Statement on Electricity Financial Transmission Rights has been issued following a review of financial transmission rights and the allocation of transmission rentals arising from electricity losses and constraints in the wholesale electricity market.

It supplements the existing Government Policy Statement: Further Development of New Zealand's Electricity Market, issued in February 2002.

Introduction

1. Financial transmission rights (FTRs) should be introduced to assist in the management of locational price risk resulting from transmission losses and constraints and to improve economic signalling (including the signals for new transmission investment). The loss and constraint rentals arising out of the spot market provide the appropriate underpinning for FTRs.

2. The Government's expectations in relation to FTRs are specified below.

Guiding Principles for an FTR Market

- 3. Realistic long term risk management mechanisms must be made available to end users and to competing retailers.
- 4. Economic efficiency is a critical goal that should be pursued in a robust but realistic fashion. The concept of economic efficiency includes the integrity of nodal price signals for price-sensitive generation, consumption and investment decisions.
- 5. FTR design and allocation should give priority to ensuring consumers have access to competitive markets, particularly in regions subject to transmission constraints, but otherwise have due regard to preserving continuity with established price relativities and commercial arrangements.
- 6. Pragmatic solutions must be developed which are implementable and endurable.
- 7. Transpower should not be required to take on commercial risk as a result of FTR arrangements without the agreement of Transpower's board.
- 8. The design of FTR arrangements should mitigate and manage risk to distribution companies.

FTR Policy Framework

- 9. Transpower should continue to receive loss and constraint rentals, and should use the rentals to fund an FTR product.
- 10. A market for short to medium term FTRs should be introduced covering the interconnected grid (with or without spur lines).
- 11. Some or all of Transpower's off-take customers (including distribution companies and direct connect customers) should be offered a long term allocation of FTRs. If a distribution company prefers that its allocation be given to an agent appointed by the distribution company and approved by the FTR group, Transpower should allocate the relevant FTRs to the agent. FTR recipients should be able to refuse an allocation.
- ¹ This focus on off-take customers does not preclude other customers from receiving a similar long term allocation.
- ² Subsequent references in this policy statement to distribution companies should be read as applying also to an agent appointed by a distribution company to manage the distribution company's role under this policy statement
- 12. Recipients of allocated FTRs should be able to put their FTRs into an auction and assign reserve prices in accordance with the process developed by the FTR group under paragraph 19. In this case, they should receive the value assigned to those FTRs by the auction (subject to the price exceeding the reserve). If the value assigned by the auction does not exceed the reserve price, the original recipient should retain the FTR.
- 13. Transpower should pass any excess FTR auction income (auction income not paid to those who put allocated FTRs back into the auction), residual rentals (rentals not utilised in the FTR market) and any income received as payment for an FTR allocation, less appropriate expenses, to its customers.
- 14. A distribution company should pass through rentalrelated or FTR-related cash flows to the distribution company's customers, retailers, and/or end users. The pass through should be transparent, should not discriminate between parties in a like position, and should as far as possible be non-distortionary. It should be consistent with the guiding principles for an FTR market, and in particular have due regard to promoting competition between retailers.
- 15. Distribution companies should be able to recover reasonable costs relating to their role under this policy statement.

Governance

16. Prior to the establishment of the Electricity Governance Board (EGB), the industry should establish an FTR group.

- The FTR group should have an independent chair and should be broadly representative of the wide range of interests affected by FTRs and rental allocations, including consumers (both large and small), distribution companies and Transpower. Neither generators and retailers, nor Transpower and distribution companies should collectively control more than 50% of the voting rights in the FTR group. The FTR group should make decisions by consensus wherever possible, but if necessary, it should make decisions by a two-thirds majority of votes cast. Government officials should attend meetings of the FTR group as observers.
- 17. The FTR group will not have standing with respect to Government policy until its constitution (including membership and voting rights) has been confirmed by the Minister of Energy.
- 18. After receiving advice from Transpower, the FTR group should decide on:
 - (i) design options and issues that must be resolved within the FTR policy framework before the FTR market begins;
 - (ii) a programme and timetable to investigate the options, resolve issues, and make decisions; and
 - (iii) allocation of tasks to achieve the programme.
- 19. Design options should specify (inter alia):
 - (i) the nodes to which FTRs should be allocated;
 - (ii) the methodology for allocating FTRs to distribution companies and Transpower's direct connect off-take customers;
 - (iii) whether particular customers who pay for the sunk costs of specific assets should also be offered an allocation of FTRs relating to that asset;
 - (iv) the price, if any, to be paid for an FTR allocation;
 - (v) the hub or hubs (or a methodology for determining the hub or hubs) from which allocated FTRs will be defined;
 - (vi) a mechanism for approving the appointment of an agent by a distribution company;
 - (vii) model approaches for passing through rental-related and FTR-related cash flows from distribution companies to the distribution companies' customers, retailers, and/or end users;
 - (viii) a process for deciding which FTRs allocated to distribution companies may or should be offered into the FTR auction, and a process for setting reserve prices. These processes should be consistent with the guiding principles for an FTR market, and in particular they should have due regard to promoting competition between retailers, and to ensuring an efficient FTR auction;
 - (ix) the role, if any, of FTRs defined from generation nodes to a hub;
 - (x) a mechanism by which allocations may be adjusted in response to changing circumstances, such as new network investment;
 - (xi) the timing of the initial FTR allocation and auction; and
 - (xii) the way in which FTRs are used to facilitate new transmission investment.
- 20. After receiving advice from Transpower, including on whether an option or options are practicable, the FTR group should decide on an option that best meets the FTR policy framework and the guiding principles for the FTR market.
- 21. Transpower's existing design work on auction rules and contractual arrangements should be used unless the benefits from adopting an amended design outweigh the additional cost of developing that design.

- 22. The decision-making processes of the FTR group should be fully transparent to all interested parties.
- 23. The chairs of the FTR group and Transpower (or their representatives) should report to the Minister of Energy by 28 February 2003 on an agreed programme and timetable for the establishment of the FTR market. They should subsequently report to the Minister monthly on progress in achieving the programme and timetable, and on whether outcomes are consistent with the guiding principles for FTRs and the FTR policy framework.
- 24. The EGB, once established, should take over governance of rules covering FTR matters subject to the guiding principles and the FTR policy framework. If the governance arrangement provides for voting rights to be held by stakeholders, then those voting rights should be held by all interested parties including generators, retailers, distribution companies, Transpower, and large and small consumers. Neither generators and retailers, nor Transpower and distribution companies should collectively control more than 50% of the voting rights under any such governance arrangement.
- 25. In developing governance arrangements, the EGB should have due regard to the desirability of consistency between arrangements, including governance arrangements for FTRs and transmission pricing and investment.
- 26. In the period after the establishment of the FTR market, but before the EGB has taken over governance of FTR rules, bilateral participation contracts (which contain FTR market rules) between Transpower and market participants should provide for the FTR group to approve rule change proposals subject to the guiding principles for the FTR market and the FTR policy framework.
- 27. Transpower should be the arbiter of whether the terms and conditions of contracts, or any proposed rule changes are consistent with the guiding principle relating to Transpower's commercial risk (paragraph 7 above).

The Public Trust Common Fund Interest Rates Notice 30 January 2003

Pursuant to section 50 (1) and (5) of the Public Trust Act 2001 ("the Act"), the following notice is given.

Notice

- **1. Title and commencement**—This notice may be cited as the Public Trust Common Fund Interest Rates Notice 30 January 2003.
- (2) The determinations and revocation notified in this notice take effect from and including 25 January 2003.
- **2. Interpretation**—(1) Unless the context otherwise requires:
 - "agency deposit" means a deposit (not being an investment deposit) held as agent or attorney;
 - "call deposit" means a deposit (not being an agency deposit, an investment deposit, a special deposit or a trust deposit) held in the ordinary course of administration, and determined by Public Trust to be held at call;
 - "deposit" means a sum of money held by Public Trust belonging to any estate, which money for the time being forms part of the Common Fund;
 - "investment deposit" means a deposit held at call or otherwise as an investment under section 51 of the Act;
 - "special deposit" means a deposit held other than at call on behalf of the Crown, or any local authority within the meaning of the Local Government Act 1974;

"trust deposit" means a deposit held on trust:

- (i) for persons not of full age or capacity; or
- (ii) for beneficiaries not entitled to payment at call; or
- (iii) otherwise than at call (not being a special deposit).
- (2) Expressions defined in the Act have the same meaning in this notice as they do in the Act.
- **3. Rates of Common Fund interest**—(1) The rate of Common Fund interest payable on a deposit (other than an investment deposit repayable at the end of a fixed term) shall be that specified in Schedule 1 for the appropriate type of deposit.
- (2) The rate of Common Fund interest payable on an investment deposit repayable at the end of a fixed term shall be that specified in Schedule 2 for the appropriate term and dollar range.
- (3) Despite subparagraph (1), the rate of Common Fund interest payable on a deposit made pursuant to an enactment shall be the rate (if any) specified in the enactment.
- (4) Despite subparagraph (1), in particular cases or classes of case, Public Trust and the depositor may agree on a rate of interest payable on a special deposit that is different from the rate specified in Schedule 1 and the agreed rate then applies.

4. Revocation of notice and transitional provisions-

- (1) The Public Trust Common Fund Interest Rates Notice 28 November 2002 is revoked.
- (2) The rates of interest specified in Schedule 1 to this notice do not apply to any period that ends with 24 January 2003 but otherwise operate as from 25 January 2003.

- 2. Division 12 Pai Gow

Section 3 – Table Layout and Equipment

2.1 Rule 3.2 is amended by inserting after the words "Appendix 1" the phrase ", provided that the designated area for unused tiles, and the dealer's work area, need not be marked on the layout cloth".

Section 6 - Wagers

- 2.2 Rule 6.3 is amended by deleting the words "before the cut of the tiles".
- 2.3 Rule 6.4 is amended by deleting the word "called" and substituting "signalled".
- 2.4 Rule 6.5 is amended by deleting the words "rule 11.1 (b)" and substituting "rule 11.1 (a)".
- 2.5 Rule 6.9 is amended by deleting the words "called 'No more bets'" and substituting "signalled 'No more bets' and placed the shaken dice cup on the layout,".

Section 9 – Shuffle and Cut of the Tiles

- 2.6 Section 9 of this division is amended by deleting rule 9.3A and substituting the following:
 - "9.3A An approved cut shall be selected:
 - (a) where there is a player/banker, by the player/banker if he/she elects to; or
 - (b) by the game supervisor; or
 - (c) through a random selection method as set out in approved procedures.

The tiles shall be set up by the dealer."

- 2.7 Rule 9.4 is amended by deleting the word "call" and substituting "signal".
- 2.8 Section 9 of this division is amended by deleting rule 9.8 and substituting the following:
 - "9.8 The dealer shall then place the dice cup in a central position on the table and remove the cover, ensuring that all players have an uninterrupted view of the tiles when they are uncovered. All 3 dice must come to rest with 1 surface flat to the base of the dice cup, otherwise the dice cup shall be shaken again."

Section 10 – Delivery and Setting of the Tiles

- 2.9 Rule 10.1 is amended by deleting the following phrases: "announce 'first tiles to box.....', identifying the appropriate box by number, and then" and ", whether or not anyone is seated at the box or there is any wager on the box".
- 2.10 Section 10 of this division is amended by deleting rule 10.2 and substituting the following:
 - "10.2 Where there is no bet on a box, the 4 tiles will be delivered in relation to this empty box."
- 2.11 Section 10 of this division is amended by inserting after rule 10.2 the following:
 - "10.2A Where groups of 4 tiles are to be delivered to adjacent empty boxes, they may be placed collectively in relation to those boxes."
- 2.12 Rule 10.3 is amended by deleting the words "designated area for tiles" in subparagraph (a) and substituting "designated area for unused tiles".
- 2.13 Rule 10.11 is amended by deleting the word "declare" and substituting "determine".
- 2.14 Rule 10.13 is amended by deleting the second sentence and substituting "The dealer shall collect the player's wager, and then pick up the tiles and place them in the dealer's work area as shown in Appendix 1 without exposing them."

Section 11 - Variations of Play; Settlement of Wagers


- 2.15 Section 11 of this division is amended by deleting rules 11.1, 11.2 and 11.3 and substituting the following:
 - "11.1 When the house is the sole banker:
 - (a) the chung shall be placed on box number 1 and the house tiles shall be the group of 4 tiles delivered to that box. No wagers shall be accepted on box number 1;
 - (b) the house tiles shall be positioned directly in front of the float tray in the dealer's work area as shown in Appendix 1;
 - (c) the dealer shall set the house tiles after all of the players' hands have been set;
 - (d) the dealer shall expose the house tiles and compare the hand with each of the players' hands in turn to determine whether the hand wins, loses or draws in accordance with rule 6.1;
 - (e) all losing wagers shall be picked up and placed in the losing wager area and the corresponding tiles placed in the dealer's work area as shown in Appendix 1. After all comparisons have been made, and before the winning wagers are paid, the losing wagers shall be placed in the float tray;
 - (f) if a hand constitutes a push, the tiles shall be removed and placed in the dealer's work area and the wager shall remain; and

- (g) after all of the hands at the table have been exposed, the dealer shall pay, in accordance with rule 6.11, all winning wagers, picking up the tiles when payment is made and placing them in the dealer's work area.
- 11.2 When a player/banker is banking and the house is not participating in the bank:
 - (a) the chung shall be placed on the player/banker's box and the player/banker's tiles shall be the group of 4 tiles delivered to that box;
 - (b) after all of the other players have made their wagers, the player/banker shall place, in the player/banker's box, chips of a value equal to or greater than the total of the other players' wagers. If the player/banker fails to cover the total of the other players' declared wagers, the game shall be conducted in accordance with either rule 11.1 or rule 11.3;
 - (c) the dealer shall take the player/banker's wager and place it in the banker wager area;
 - (d) the player/banker's hand shall be set, after all of the other hands have been set;
 - (e) after the player/banker's hand has been set, the dealer shall move it to the front of the float tray and then expose the hand;
 - (f) the dealer shall then, in turn, expose and match each of the other players' hands with the player/banker's hand:
 - (g) all losing wagers shall be picked up immediately and placed in the losing wager area, and the corresponding tiles placed in the dealer's work area;
 - (h) if a hand constitutes a push, the tiles shall be removed and placed in the dealer's work area and the wager shall remain;
 - (i) after all of the hands at the table have been exposed, the dealer shall pay, in accordance with rule 6.11, all winning wagers with chips from the losing wager area, counter-clockwise from the player/banker's box, picking up the tiles when payment is made and placing them in the dealer's work area. The sum remaining in the losing wager area shall be handed to the player/banker, less commission, in accordance with rule 6.14; and
 - (j) if there are insufficient funds in the losing wager area to pay winning wagers, the shortfall shall be taken from the player/banker's wager.
- 11.3 When the player/banker and the house are co-bankers:
 - (a) the chung shall be placed on the co-banker's box and the banker's tiles shall be the group of 4 tiles delivered to that box;
 - (b) after all of the other players have made their wagers, the co-banker shall place, in the co-banker's box, chips of a value equal to or greater than 50% of the total of the other players' wagers;
 - (c) the dealer shall take the co-banker's wager, together with chips of an equivalent value from the float tray, and place them in the banker wager area;
 - (d) the co-banker's tiles shall then be moved to a position directly in front of the float tray;
 - (e) the dealer shall set the banker's hand in accordance with the house way after all of the other hands have been set, and may permit the co-banker to expose 2 of the 4 tiles in the hand before the hand is set;
 - (f) the dealer shall then, in turn, expose and match each of the other players' hands with the co-banker's hand;
 - (g) all losing wagers shall be picked up immediately and placed in the losing wager area, and the corresponding tiles placed in the dealer's work area;
 - (h) if a hand constitutes a push the tiles shall be removed and placed in the dealer's work area and the wager shall remain;
 - (i) after all of the hands at the table have been exposed, the dealer shall pay, in accordance with rule 6.11, all winning wagers with chips from the losing wager area, starting counter-clockwise from the co-banker's box, picking up the tiles when payment is made and placing them in the dealer's work area;
 - (j) the total remaining in the losing wager area after settlement of the other players' wagers shall be divided equally between the co-bankers;
 - (k) the house's share of that sum, and the house's original wager, shall be returned to the float tray. The co-banker's original wager shall be handed to him/her. The sum remaining in the losing wager area shall be handed to the co-banker, less commission, in accordance with rule 6.14; and
 - (l) if there are insufficient funds in the losing wager area to pay winning wagers, the shortfall shall be taken from the co-banking wager. Any sum left after the settlement of all winning and losing wagers by the other players shall be divided in 2, and the house's portion placed in the float tray and the co-banker's portion handed back to him/her".
