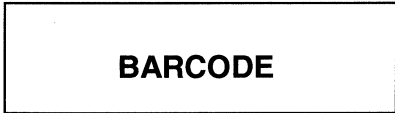

The Public Trust Common Fund Interest Rates Notice 20 March 2003

Pursuant to sections 50 (1) and 50 (5) of the Public Trust Act 2001 ("the Act"), the following notice is given.

Notice

1. Title and commencement—(1) This notice may be cited as the Public Trust Common Fund Interest Rates Notice 20 March 2003.

(2) The determinations and revocation notified in this notice take effect from and including 15 March 2003.

2. Interpretation—(1) Unless the context otherwise requires:

"agency deposit" means a deposit (not being an investment deposit) held as agent or attorney;

"call deposit" means a deposit (not being an agency deposit, an investment deposit, a special deposit or a trust deposit) held in the ordinary course of administration, and determined by Public Trust to be held at call;

"deposit" means a sum of money held by Public Trust belonging to any estate, which money for the time being forms part of the Common Fund;

"investment deposit" means a deposit held at call or otherwise as an investment under section 51 of the Act;

"special deposit" means a deposit held other than at call on behalf of the Crown, or any local authority within the meaning of the Local Government Act 1974;

"trust deposit" means a deposit held on trust:

(i) for persons not of full age or capacity; or

(ii) for beneficiaries not entitled to payment at call; or

(iii) otherwise than at call (not being a special deposit).

(2) Expressions defined in the Act have the same meaning in this notice as they do in the Act.

3. Rates of Common Fund interest—(1) The rate of Common Fund interest payable on a deposit (other than an investment deposit repayable at the end of a fixed term) shall be that specified in Schedule 1 for the appropriate type of deposit.

(2) The rate of Common Fund interest payable on an investment deposit repayable at the end of a fixed term shall be that specified in Schedule 2 for the appropriate term and dollar range.

(3) Despite subparagraph (1), the rate of Common Fund interest payable on a deposit made pursuant to an enactment shall be the rate (if any) specified in the enactment.

(4) Despite subparagraph (1), in particular cases or classes of case, Public Trust and the depositor may agree on a rate of interest payable on a special deposit that is different from the rate specified in Schedule 1 and the agreed rate then applies.

4. Revocation of notice and transitional provisions—

(1) The Public Trust Common Fund Interest Rates Notice 27 February 2003 is revoked.

(2) The rates of interest specified in Schedule 1 to this notice do not apply to any period that ends with 14 March 2003 but otherwise operate as from 15 March 2003.

Notice of Amendment to Ministerial Scheme Under Section 8A of the Foundation for Research, Science, and Technology Act 1990—the Grants for Private Sector Research and Development Scheme

Direction to: The Foundation for Research, Science and Technology (“the foundation”).

Under section 8A of the Foundation for Research, Science, and Technology Act 1990, I direct the foundation to allocate funds in accordance with the Grants for Private Sector Research and Development Scheme (“the scheme”) specified in this notice.

This notice replaces the one published in the *New Zealand Gazette*, 6 July 2000, No. 75, page 1813, which established the scheme.

Grants for Private Sector Research and Development

Nature of the Scheme

The scheme is intended to increase the level of private sector investment in research and development¹ in New Zealand.

The intended outcome of the scheme is a greater level of investment by firms² in research and development, technological learning, knowledge application and the development of technology-based human capital.

The scheme will target all technologically aware³ firms with an emphasis on small and medium sized firms⁴.

It will focus on projects that have the potential to stretch a firm’s technological capabilities beyond existing levels and improve their ability to apply technological innovation for business growth.

These funds can be allocated to a firm (or a group of firms) to undertake a research and development project.

Scheme Objective

Projects that meet the scheme’s objective are eligible to receive funds from the foundation.

The scheme’s objective is to increase the level of new private sector research and development investment.

In making funding decisions, the foundation will fund those projects that, in its view, best meet the following criteria:

- Have a clear link to a business strategy focused on developing markets, processes or services with reasonable commercial potential;
- are likely to start sooner and complete earlier with the scheme’s support;
- have the potential to create an enduring wealth creating capability; and
- have the potential to create an enduring increase in technological capability in the firm.

The foundation will have full discretion to manage the allocation of funds for the scheme in a way that achieves the outcome and objective of the scheme.

The Mechanism

The foundation will use the scheme to fund up to 33.3% of the costs that a firm will incur in undertaking research and development for a project that meets the scheme's objective. The maximum amount the scheme will contribute to one project is \$100,000.00 (G.S.T. inclusive).

Those costs can include the cost to the firm of contracting research and development capability.

Funding to be Allocated

Funds available for the scheme will be published each year in the Estimates of Appropriations.

The foundation will have the discretion to allocate up to 10% of funding for this scheme:

- to the Techlink Scheme, the Technology for Industry Fellowship Scheme or the Technology for Business Growth Scheme; or
- between the Techlink Scheme, the Technology for Industry Fellowship Scheme or the Technology for Business Growth Scheme.

This will occur if all schemes involved in the allocation are appropriated within the same non-departmental output class under the Public Finance Act 1989.

The Minister of Research, Science and Technology's written approval is required before the foundation can transfer more than 10% of the scheme to any other scheme issued by the Minister of Research, Science and Technology under section 8A of the Foundation for Research, Science, and Technology Act 1990.

Period of Operation

The scheme will commence operation on 1 April 2003 and is estimated to continue for a period of five years.

Monitoring Agency

Monitoring of the scheme, including implementation of this notice by the Foundation for Research, Science and Technology and the extent to which the scheme achieves its stated objective, will be carried out by the Ministry of Research, Science and Technology.
