Notice of Public Ruling

1. This is a notice of a public ruling made under section 91D of the Tax Administration Act 1994.
2. Public ruling No. 03/04 entitled "Payments made by parents or guardians of students to state schools – G.S.T. treatment" was issued on 20 June 2003. Heavy Motor Vehicle Regulations 1974 Traffic Regulations 1976

Exemption From Specified Requirements of the Heavy Motor Vehicle Regulations 1974 and the Traffic Regulations 1976

Pursuant to Regulation 16A (2) of the Heavy Motor Vehicle Regulations 1974, pursuant to Regulation 90 (1) of the Traffic Regulations 1976, and pursuant to the powers delegated to me by the Director of Land Transport Safety, I, Laszlo Andras Hidvegi, Senior Engineer Safer Vehicles Policy, hereby exempt the vehicles specified in Schedule 1 of this notice from the requirements in Schedule 2, subject to the conditions in Schedule 3, until the time specified in Schedule 5.

For the purpose of this exemption, the term "agricultural trailer" is defined in Schedule 4.

This notice replaces the exemption for the towing connection of agricultural vehicles and the brakes of agricultural trailers published in the *New Zealand Gazette*, 12 December 2002, page 4496.

Schedule 1

All light tractors that are being used to tow heavy trailers, all heavy tractors and all heavy agricultural trailers.

Schedule 2

Regulation 16A (1)(c) of the Heavy Motor Vehicle Regulations 1974, requiring vehicles to comply with the New Zealand Standard 5446: 1987 Code of Practice for Heavy Motor Vehicle Towing Connections: Drawbar Trailers.

The requirement in Regulation 83 (b) of the Traffic Regulations 1976, according to which a trailer must be fitted with a brake that operates immediately to stop the trailer if it becomes disconnected from the towing vehicle.

Schedule 3

1. A towing connection must be suitable for its purpose, must be in safe condition and in good working order.
2. A coupling must be fitted with a locking device, and it must be possible to verify by visual inspection that the coupling is locked in its fully engaged position.
3. The towing connection, other than a three-point agricultural linkage, fitted to a tractor to tow a trailer, must have the following, clearly displayed in kilograms, on or adjacent to the coupling, by the time specified in point 6:
 - (a) the maximum mass of a trailer that can be towed by the tractor by means of this towing connection; and
 - (b) the permitted maximum vertical load for the coupling.
4. The towing connection, other than a two-point or three-point agricultural linkage, fitted to a heavy agricultural trailer for the purpose of towing it, must have the following, clearly displayed in kilograms, on or adjacent to the coupling, by the time specified in point 6:
 - (a) the maximum mass of the trailer, including the mass of any vehicles that can be towed by the trailer; and
 - (b) the maximum vertical load at the coupling when the trailer is fully laden.

5. The data in 3 (a), 3 (b), 4 (a) and 4 (b) must be rounded to the nearest 100kg and must be established by the vehicle manufacturer, the manufacturer of the towing connection, a specialist certifier approved by the Director of Land Transport Safety or a chartered mechanical engineer.
6. The data in 3 (a), 3 (b), 4 (a) and 4 (b) must be displayed after 1 July 2004.
7. A heavy agricultural trailer and a vehicle towing it or a heavy tractor towing a trailer, which are connected by a coupling other than a two-point or three-point agricultural linkage, must have a safety chain to ensure that the trailer and the towing vehicle remain connected if the coupling fails.
8. The safety chain must be permanently attached to the trailer and non-permanently connected to the towing vehicle.
9. The safety chain must not be attached to the trailer by welding of the chain itself.
10. The safety chain must have a breaking strength of at least twice the maximum mass of the trailer.
11. The safety chain must have markings stamped on to it by the manufacturer, from which the breaking strength of the chain can be established and verified either directly or indirectly.
12. The attachment point of the safety chain on the trailer must have a strength that is at least equivalent to the breaking strength of the safety chain.
13. The safety chain must be connected to a connection point on the towing vehicle that has a strength of at least twice the maximum mass of a trailer that can be towed by the tractor by means of the towing connection other than the three-point linkage.
14. The attachment point and the connection point for a safety chain, where practicable, must be fitted to a component that is not readily removable from the towing or towed vehicle.
15. The length and attachment of the safety chain must:
 - (a) allow full articulation between the tractor and the trailer; and
 - (b) prevent the connection from contacting the ground if a coupling failure occurs on level surface.

Schedule 4

For the purpose of this exemption, an agricultural trailer is a trailer that is designed exclusively for agricultural purposes.

Schedule 5

This exemption will lapse on the day when Land Transport Rule: Heavy Vehicles [Rule 31002] comes into force.

 - one person appointed, in writing, by the Gore District Council; and

 - two persons appointed, in writing, by the chief executives of Rayonier Asia Pacific, Ernslaw One Limited, Craigpine Timber Limited, Southwood Export Limited and Blakely Pacific Limited, after such consultation as the chief executives consider appropriate; and
 - one person appointed, in writing, by the Department of Conservation under the signature of its director-general; and
 - one person appointed by the New Zealand Fire Service under the signature of its chief executive.

(3) In the event that any appointment to be made under 4 (2) (d) is not carried out within three months of the date by which the appointment should be made, then the National Rural Fire Officer may appoint to the committee some fit person who shall represent the interests of the organisations described in 4 (2) (d).

New Zealand Qualifications Authority

Education Act 1989

Criteria for the Exemption of Courses of Less Than Three Months Delivered to Foreign Students and Associated Withdrawal and Refund Criteria

Pursuant to section 232 (1) of the Education Act 1989, the New Zealand Qualifications Authority is required to quality assure all courses delivered to foreign students, unless the course is less than three months’ duration and is an exempt course, as provided for in section 232 (2).

Further, pursuant to section 236 (1) (d) (iv) of the Act, the New Zealand Qualifications Authority requires private training establishments which enrol foreign students in

courses of less than three months to make provision for early withdrawals and refunds.

Following consultation, the New Zealand Qualifications Authority Board has made the following decisions on the exemption criteria and the policy for early withdrawals and refunds.

These policies have been published on the New Zealand Qualifications Authority web site.

Exemption criteria for the exemption of courses less than three months

A course may be exempt from the provisions of section 232 (1) of the Education Act 1989, if the course is recreational in nature.

A course is deemed to be recreational in nature if its intent meets one of the following definitions:

Hobby:

An activity undertaken regularly for pleasure. The participant is in pursuit of a field of interest rather than an educational outcome.

Leisure activity:

An action taken in pursuit of a recreational outcome. The participant aims to gain skills in the field of a leisure activity. The participant would not expect to achieve an educational outcome in relation to further or higher study, or entry into employment.

Experiential:

Involving or based on experience or observation. The participant would be seeking through experience or observation to gain skills associated with a field of personal interest and would not expect to gain an educational outcome associated with further study or entry into employment.

Withdrawals and refunds for courses of less than three months delivered to foreign students

Section 236 (1) (d) (iv) of the Education Act 1989 states that the establishment allows, or will allow, every foreign student enrolled in a course of study or training that is of less than three months' duration to withdraw from it within a period (being less than seven days) specified by the authority, and refunds, or will refund, to any student who so

withdraws a minimum amount or proportion, specified by the authority, of any payments made by the student to the establishment in respect of that course.

The New Zealand Qualifications Authority Board has approved the following in relation to this requirement:

Where a foreign student enrolled at a private training establishment in a course of study or training, that is less than three months' duration, withdraws from such a course, the following minimum refund entitlement will apply:

- (a) For courses of up to and including four weeks and six days:
 - (i) where a foreign student withdraws within the first two days of the course for which attendance of students at the private training establishment is required, the private training establishment may retain up to 50% of the full amount of any payments made by the student to the private training establishment in respect of the course; and must refund the balance to the student; unless
 - (ii) two days constitutes the full amount of tuition paid for by the student, in which case the provider may retain 100% of the payment made in respect of the course.
- (b) For courses of five weeks or more but less than three months:
 - (i) where a foreign student withdraws within the first five days of the course for which attendance of students at the private training establishment is required, the private training establishment may retain up to 25% of the full amount of any payments made by the student to the private training establishment in respect of the course; and must refund the balance to the student.

These policies were approved by the New Zealand Qualifications Authority Board and were effective as from 1 July 2003.

Consolidated Notes to the Financial Statements for the Year Ended 31 March 2003

1. Statement of Accounting Policies

Reporting Entity

The financial statements presented here are for the reporting entity The Community Trust of Wellington and its wholly owned company, Wellington Community Trust Charities Limited. The Community Trust of Wellington is an incorporated charitable trust under the Charitable Trusts Act 1957.

Reporting Basis

The trustees have chosen to prepare general purpose financial reports which comply with generally accepted accounting practice.

Measurement Base

The measurement base adopted is historical cost with the exception of certain items for which specified accounting policies are identified.

Investment Income (Net)

Investment income (net) includes gross investment income less management fees payable to the fund managers.

Basis of Consolidation

The consolidated financial statements have been prepared using the purchase method of consolidation and include the financial statements of the parent and subsidiary company.

All significant inter-entity profits and transactions have been eliminated in preparing the consolidated financial statements.

Accounts Receivable

Accounts receivable are stated at expected realisable value.

Donations

Donations made from current year's income are recorded in the statement of financial performance when paid. Donations from prior years' income are recorded in the statement of movements in trust funds when paid.

Fixed Assets

Fixed assets are stated at cost less accumulated depreciation.

Depreciation

Depreciation is charged at the maximum rates allowable by the Inland Revenue Department. The tax rates are as follows:

Goods and Services Tax

The Community Trust of Wellington financial statements are prepared on a G.S.T. inclusive basis.

Shares and Investments

Shares and other investments are stated at the market value. Changes in the market value of investments are taken to the statement of financial performance.

Financial Instruments

All financial instruments held by the trust are recorded in the statement of financial position. The financial instruments comprise equity securities, discounted securities, secured investments, borrowings, deposits and cash. Concentrations of credit risk arise as a result of holding equity securities as investments. These are subject to the normal market risk associated with investments of this nature. There are no significant differences between the fair value and book value of financial instruments.

Where possible, financial assets and liabilities are supported by collateral or other security. These arrangements are described in the individual policy statements associated with each item.

Changes in Accounting Policies

There have been no changes in accounting policies. All policies have been applied on bases consistent with those used in previous years.

2. Nature of Business

The Community Trust of Wellington was incorporated as a charitable trust in accordance with the provisions of the Trustee Banks Restructuring Act 1988 and now superseded by the Community Trust Act 1999. The purpose of the community trust is to provide charitable, cultural, philanthropic and recreational benefits to the community, principally in the trust region.

The nature of business of the wholly owned company, Wellington Community Trust Charities Limited, is restricted by its constitution to providing charitable benefits to the community, principally in the region of The Community Trust of Wellington.

The Community Trust of Wellington and its subsidiary company operate under the trading name of "The Community Trust of Wellington".

5. Taxation

The Community Trust of Wellington is not exempt from income tax as a charitable trust. No taxation liability arises for the year ended 31 March 2003.

For taxation purposes, Wellington Community Trust Charities Limited is deemed to be a charitable organisation and on this basis the income is not subject to taxation. The company's charitable status was confirmed on 27 August 1997 by the Inland Revenue Department.
