##### New Zealand Emergency (Prescribed Food) Food Standard 2003

Pursuant to sections 11D and 11M of the Food Act 1981, notice is given that the New Zealand Emergency (Prescribed Food) Food Standard 2003 was issued by the Director-General of Agriculture and Forestry on 24 September 2003.

In respect of those persons who received notice of this emergency food standard, pursuant to section 11M (3) (e) of the Food Act 1981, the standard came into force upon service of the notification.

In all other cases, this emergency food standard will come into force upon notification in the *New Zealand Gazette*.

The New Zealand Emergency (Prescribed Food) Food Standard 2003 amends the New Zealand (Prescribed Foods) Food Standards 2002 by adding tahini or crushed sesame seeds or any food containing these products (including sesame seed paste, sesame paste, sesame seed butter, hamas tahini, tahina, tahine, halva dessert mix, hummus halawa, halva, helva and babaganoush).

The presence of pathogenic bacteria is the condition to be monitored.

Compliance with the New Zealand Emergency (Prescribed Food) Food Standard 2003 is mandatory.

It will remain in force for a maximum period of six months or, if a permanent amendment to the New Zealand (Prescribed Foods) Food Standards 2002 is required, until that permanent amendment to the standards is introduced (whichever is earlier).

- Te Kura Toitu o Te Whaiti-nui-a-Toi will endeavour to develop, maintain and uphold cultural integrity with te mauri o Toi as a guiding philosophy (ie Hikina te mauri o Toi, kia toitu te whenua, te reo, te wairua, te Iwi).
- Te Kura Toitu o Te Whaiti-nui-a-Toi will reflect a holistic learning environment (i.e. physically, mentally, socially, spiritually, culturally) where emphasis will be placed on encouraging students to actively participate in all fields of traditional and modern sciences and technology with all curriculum areas.
- Te Kura Toitu o Te Whaiti-nui-a-Toi will ensure that it involves and interacts with the whanau, hapu and Iwi of our tamariki for support and strive to ensure that we produce young and future leaders.
- Te Kura Toitu o Te Whaiti-nui-a-Toi will be part of the Tuhoe Education Authority's strategic and educational plan that arises from the Mission Statement:

*Whangaia ki te korero, kia pehapeha te korokoro, tera i te kereru i runga i te miro.*

- Students will be encouraged and motivated to participate fully to the best of their abilities in the learning programmes of Te Kura Toitu o Te Whaiti-nui-a-Toi.
- To ensure the success of Te Kura Toitu o Te Whaiti-nui-a-Toi, it will need the passion and commitment of the Board of Trustees, Tumuaki, staff and whanau to its vision, aims, purposes and objectives.

(2) Expressions defined in the Act have the same meaning in this notice as they do in the Act.

**3. Rates of Common Fund interest**—(1) The rate of Common Fund interest payable on a deposit (other than an investment deposit repayable at the end of a fixed term) shall be that specified in Schedule 1 for the appropriate type of deposit.

(2) The rate of Common Fund interest payable on an investment deposit repayable at the end of a fixed term shall be that specified in Schedule 2 for the appropriate term and dollar range.

(3) Despite subparagraph (1), the rate of Common Fund interest payable on a deposit made pursuant to an enactment shall be the rate (if any) specified in the enactment.

## General Section

### Deer Industry New Zealand

#### Game Industry Board Regulations 1985

##### Game Industry Board Operating as Deer Industry New Zealand

###### 1. Deer Industry New Zealand.

1.1 Deer Industry New Zealand is the operating name of the Game Industry Board ("the board").

###### 2. Board levy.

2.1 Under Regulation 17 (3) of the Game Industry Board Regulations 1985, the board fixes the rates of board levy (which levy rates are exclusive of goods and services tax imposed by the Goods and Services Tax Act 1985) as follows:

- (a) On each deer, other than fallow deer, slaughtered in deer slaughtering premises, on the basis of hot clean carcass weight after removal of condemned parts:
 

14.2 cents (fourteen point two cents) per kilogram.
- (b) On each fallow deer slaughtered in deer slaughtering premises, on the basis of hot clean carcass weight after removal of condemned parts:
 

9.2 cents (nine point two cents) per kilogram.
- (c) On each killed game deer carcass received at a packing house, zero cents per kilogram cold clean carcass weight after removal of condemned parts.
- (d) On each piece of antler from deer other than fallow deer received at a packing house for processing or packing, on a green weight basis:
 

372 cents (three hundred and seventy-two cents) per kilogram.
- (e) On each piece of antler from fallow deer received at a packing house for processing or packing, on a green weight basis:
 

72 cents (seventy-two cents) per kilogram.

2.2 For the purpose of paragraphs 2.1 (a) and 2.1 (b) above, hot clean carcass weight is defined in the DeerQA Venison Processors Industry Agreed Standards (dated 21 July

2003) at Standard IAS-3: Venison Standard Carcass. This document is available on request from Deer Industry New Zealand by telephoning (04) 382 8626 or from P.O. Box 10-702, Wellington.

2.3 No levy is payable when the value of the velvet grade, as defined by the Industry Agreed Grading Guidelines, is less than or equal to \$15.00/kg (G.S.T. exclusive).

2.4 If the Deer Slaughtering Premises ("DSP") or Packing House ("PH") (formerly Game Packing House) fails to keep accurate records relating to the board levy or to file accurate returns relating to the board levy, then the levy payable will be assessed by the board with reference to such information as the board considers fit.

3. DSPs are not required to collect levies on Tb reactors but will be required to report the number of reactor deer slaughtered to the board in their monthly returns. The levy will be waived for those Tb reactors which are identified with an official reactor tag and where they arrive at the DSP accompanied by an official permit to move.

4. A nil rate of levy applies to any farmed deer or killed game deer carcasses which are wholly condemned for any reason following slaughter or receipt into a PH.

5. No levy is payable in respect of any one farmed deer carcass or piece of antler more than once.

6. These rates of levy come into effect on and from 1 October 2003 and apply until 30 September 2004, or until such time as new levy rates are fixed and come into force.

7. Under Regulation 17A (1), notice is given that the board fixes the rate of additional levy payable in respect of failure to pay, or late payment of, amounts of board levy payable on or after 1 October 2003 at 10 percent of the amount of levy unpaid.

8. The additional levy for failure to pay or late payment may be applied by the board at a rate of 10 percent on the outstanding balance following expiration of the period within which payment is required to be received by the board, and is payable by the DSP or PH concerned.

9. Of the board levy, a portion will be paid to the Animal Health Board as the deer industry's contribution to the Animal Health Board's activities under the national pest management strategy for bovine tuberculosis. The board levy will be broken down as follows:

## 9.1 For Deer Industry New Zealand:

- Venison (fallow) 7 cents per kilogram.
- Venison (other) 12 cents per kilogram.
- Velvet (fallow) \$0.50 per kilogram.
- Velvet (other) \$3.50 per kilogram.

## 9.2 For the Animal Health Board:

- Venison 2.2 cents per kilogram.
- Velvet 22 cents per kilogram.
