 - (b) if the holder works in an operation where explosives are used, the unit standards set out in Group 14 of the Appendix.
- (3) The holder must satisfy the secretary that he or she has had at least 1 year's experience actively engaged in the winning of coal and support of the face openings, if the holder is the holder of a mine manager's certificate under the Mining Act 1971 or an A-Grade tunnel manager's certificate under the Quarries and Tunnels Act 1982.
- (4) In cases where paragraph (3) does not apply, the holder must satisfy the secretary that he or she has had at least 5 years' experience in the underground workings of a coal mine or of a metalliferous mine or in tunnel construction, including:
 - (a) 2 years' experience actively engaged in the winning of coal and support of the face openings; and
 - (b) 1 year's experience in some or all of the shift work referred to in paragraph (7).
- (5) The holder must hold a first-aid certificate that:
 - (a) shows that he or she is qualified to give first-aid to persons requiring it; and
 - (b) has been obtained by the applicant within the 5 years immediately preceding the date of application for the certificate of competence as a coal mine underviewer.
- (6) The holder must hold a current certificate of competence as a gas tester issued under the Regulations.
- (7) The shift work to which paragraph (4) (b) applies is:
 - (a) preparing for and installing either mechanical or hydraulic transport of coal;
 - (b) building permanent or temporary stoppings;
 - (c) ventilation and erection of brattice;
 - (d) erection of either steel or timber sets; and
 - (e) erection of other types of roof supports.

Certificate of Competence as a Gas Tester

- (1) The holder of a certificate of competence as a gas tester must have passed the unit standards set out in Group 13 of the Appendix.
- (2) The holder of a certificate of competence as a gas tester must satisfy the secretary that:
 - (a) he or she is the holder of a current first aid certificate; and
 - (b) he or she has had at least 3 months' experience in testing for gas.

Certificate of Competence as a Mine Surveyor

- (1) The holder of a certificate of competence as a mine surveyor must have been trained to the satisfaction of the secretary as a mine surveyor by:
 - (a) a person who is a registered surveyor under the Surveyors Act 1966; or
 - (b) by a person who has a certificate of competency as a mine surveyor.
- (2) Periodic reports on training to which paragraph (1) applies must have been supplied to the secretary.
- (3) The holder of a certificate of competence as a mine surveyor must have had at least 3 years' practical experience in surveying including:

- (a) 6 months' experience in opencast and topographical surveying; and
- (b) 6 months' experience in engineering surveying; and
- (c) 6 months' experience underground in the surveying of mines; and
- (d) 3 months' experience in boundary definition work comprising field and office work.

Certificate of Competence as a Winding Engine Driver

- (1) The holder a certificate of competence as a winding engine driver must have passed the unit standards set out in Group 12 of the Appendix.
- (2) The applicant for a certificate of competence as a winding engine driver must demonstrate to the satisfaction of the secretary that:
 - (a) he or she has the ability to operate a winder and respond to standard industry signals: and
 - (b) he or she has knowledge of, and the appropriate skill to respond to, emergency procedures.

Recognition of Overseas Certificates or Work Experience

- (1) The secretary may grant any of the certificates of competence listed in Regulation 16 of the Regulations, other than a certificate of competence as a gas tester or a certificate of competence as a winding engine driver, without assessment to any person, if the secretary is satisfied that:
 - (a) the applicant is to reside in New Zealand, either permanently or temporarily; and
 - (b) the applicant is the holder of:
 - (i) a certificate of a corresponding class granted outside New Zealand, if the standard of training and assessment required for the grant of the overseas certificate is equivalent to that required for the grant of a certificate under Regulations made under the Health and Safety in Employment Act 1992; or
 - (ii) credentials that clearly demonstrate his or her mining experience outside New Zealand and his or her ability to carry out the duties of the position to which the certificate pertains; and
 - (c) the applicant has provided a letter from their present employer, or immediate previous employer if not currently employed, that they are of good character and repute; and
 - (d) the applicant is able to speak, write and understand the English language to a standard sufficient for the purpose of carrying out the duties to which the certificate of competence relates.

The Authorised Futures Dealers Notice (No. 6) 2003

- 1. Title, commencement and expiry—(1) This notice is the Authorised Futures Dealers Notice (No. 6) 2003.
- (2) This notice comes into force on the day after the date of its publication in the *New Zealand Gazette*.
- (3) This notice expires on the close of 31 October 2008.
- **2. Interpretation**—(1) In this notice, unless the context otherwise requires:
 - "Act" means the Securities Markets Act 1988.

"CFA" means Cantor Fitzgerald (Australia) Pty Limited.

- "foreign exchange futures contract" includes an exchange rate swap contract, forward exchange rate contract, exchange rate index contract, and any option on any of the foregoing.
- "interest rate futures contract" includes an interest rate swap agreement, forward interest rate contract, and any option on any of the foregoing.
- "matched principal basis" means a transaction whereby CFA simultaneously enters into two identical futures contracts with different parties, acting on opposite sides of the futures contracts, thereby facilitating the transaction between the two counterparties.
- (2) Any term or expression that is defined in the Act and used, but not defined, in this notice has the same meaning as in the Act.
- **3. Authorisation**—CFA is authorised to carry on the business of dealing in foreign exchange futures contracts and interest rate futures contracts.
- **4. Application**—This authorisation applies only to dealing in foreign exchange futures contracts and interest rate futures contracts that consist of advising or assisting a party or potential party to a foreign exchange futures contract or interest rate futures contract in connection with the acquisition or disposition of such contract, including by entering into foreign exchange futures contracts or interest rate futures contracts on a matched principal basis, in the course of CFA carrying on the business of operating an electronic marketplace for foreign exchange futures contracts and interest rate futures contracts.
- **5.** Conditions—(1) The authorisation is subject to the condition that CFA does not provide advice or assistance in connection with the acquisition or disposition of any futures contract except a foreign exchange futures contract or an interest rate futures contract to be entered into between two parties, each of which is either:
 - (a) a registered bank within the meaning of section 2 (1) of the Reserve Bank of New Zealand Act 1989 or a bank licensed or authorised by the central

- banking authority of a jurisdiction other than New Zealand to carry on the business of banking in that jurisdiction; or
- (b) a party who CFA is satisfied on reasonable grounds is:
 - (i) a person who owns tangible assets of a market value of more than \$10 million (or its equivalent in any currency); or
 - (ii) a trustee or a funds manager, acting in that capacity, which has under that person's control, as trustee or funds manager, assets with an aggregate market value of more than \$50 million (or its equivalent in any currency); or
 - (iii) a person who is authorised by the Securities Commission under section 38 of the Securities Markets Act 1988 to deal in futures contracts; or
 - (iv) a person authorised in another jurisdiction by the competent authority of that jurisdiction to deal in futures contracts; or
 - (v) Her Majesty the Queen in right of New Zealand, a Crown entity named in the Fourth Schedule to the Public Finance Act 1989, or a State enterprise named in the First or Second Schedule to the State Owned Enterprises Act 1989 (each as amended from time to time); or
 - (vi) a person which is a statutory corporation; or
 - (vii) a person who is a related body corporate of a person described in subparagraphs (i) to (vi) above.
- (2) The authorisation is subject to the further condition that CFA, before advising or assisting in connection with the acquisition or disposition of any foreign exchange futures contract or interest rate futures contract, is satisfied on reasonable grounds that each party is contracting:
 - (a) as principal on its own account; or
 - (b) on behalf of a related body corporate; or
 - (c) as trustee of a trust or manager of a managed fund.
- (3) The authorisation is subject to the further condition that the terms of every futures contract in respect of which the authorisation applies must:
 - (a) create obligations that cannot be transferred or terminated by either party to the futures contract without the consent of the other party; and
 - (b) require that any transfer of obligations under the futures contract can be made only to a person who meets the criteria described in clause 5 (1) (a) or (b).
- (4) The authorisation is subject to the further condition that CFA does not hold client money or client property in connection with dealing in futures contracts.
