Disciplinary Tribunal of the Institute of Chartered Accountants of New Zealand—Notice of Decision of the Disciplinary Tribunal (Member Guilty of Misconduct in a Professional Capacity, Conduct Unbecoming an Accountant, Negligence or Incompetence and Breaching the Code of Ethics of the Institute of Chartered Accountants of New Zealand)

At a hearing of the Disciplinary Tribunal of the Institute of Chartered Accountants of New Zealand held on the 19th day of May 2004, which the member elected not to attend and was not represented by counsel, the tribunal recorded that **Grant Perry McGowan**, of Christchurch, pleaded guilty to the following charges and admitted the following particulars:

“Charges

THAT in terms of the Institute of Chartered Accountants of New Zealand Act 1996 and the Rules made thereunder, and in particular Rule 21.30, the member is guilty of:

- misconduct in a professional capacity;
- conduct unbecoming an accountant;
- negligence or incompetence in a professional capacity of such a degree or so frequent that it brings the profession into disrepute;
- breaching the code of ethics of the institute.

Particulars

IN THAT

In his role as a chartered accountant in public practice and in relation to complaints made against him, he:

- (a) made investments on behalf of a client in entities in which he had a material financial interest without offering the client the opportunity to take independent advice and/or without appropriate authorisation;
- (b) made inappropriate and/or imprudent investments on behalf of the client;
- (c) failed to keep proper records in relation to monies invested on behalf of the client and/or monies invested;
- (d) borrowed approximately \$85,000.00 from the client's trust to repay monies owed in circumstances where he did not have the appropriate authority to do so;
- (e) made investments on behalf of a client in entities in which he had a material financial interest without

offering the client the opportunity to take independent advice and/or without appropriate authorisation;

- (f) made inappropriate and/or imprudent investments on behalf of the client;
- (g) failed to keep proper records in relation to monies invested on behalf of the client and/or monies invested;
- (h) failed within a reasonable and proper time to repay monies to the client's estate, despite repeated requests to do so by the executor to the estate;
- (i) failed to properly account for residual monies and/or interest owed to the client's estate;
- (j) failed to fully repay residual monies and/or interest owed to the client's estate;
- (k) in circumstances where he had been ordered to appear before the professional conduct committee for a final determination and in circumstances where he suffered an injury prior to that meeting, he failed within a reasonable or proper time to give any explanation or excuse for his non-attendance and/or failed to notify the professional conduct committee until approximately 1½ hours before the professional conduct committee meeting on the 12th day of January 2004.”

The tribunal found the member guilty as charged and the particulars proven.

Orders of the Tribunal

- (a) Pursuant to Rule 21.31 (a) of the Rules of the Institute of Chartered Accountants of New Zealand, the disciplinary tribunal ordered that the name of **Grant Perry McGowan** be removed from the institute's Register.
- (b) Pursuant to Rule 21.31 (d) of the Rules of the Institute of Chartered Accountants of New Zealand, the disciplinary tribunal ordered that the certificate of public practice held by **Grant Perry McGowan** be cancelled.
- (c) Pursuant to Rule 21.33 of the Rules of the Institute of Chartered Accountants of New Zealand, the disciplinary tribunal ordered that **Grant Perry McGowan** pay to the institute the sum of \$41,738.00 (inclusive of G.S.T.) in respect of the costs and expenses of the hearing before the disciplinary tribunal and the investigation by the professional conduct committee.
- (d) Pursuant to Rule 21.52 (b) of the Rules of the Institute of Chartered Accountants of New Zealand, the

disciplinary tribunal ordered that the publication of the names of the complainants, the solicitors and the names of the companies involved, other than the name of the member's practice and the member's practice trust company, be prohibited.

In accordance with Rule 21.35 of the Rules of the Institute of Chartered Accountants of New Zealand, the disciplinary tribunal directed that the decision be published in the *Chartered Accountants Journal of New Zealand*, the *New Zealand Gazette* and the *Christchurch Press* with mention of the member's name and locality.

In reaching its decision, the tribunal considered that it had three principle matters it had to consider in connection with the charges.

- (1) The charges to which **Grant Perry McGowan** has pleaded guilty include misconduct in a professional capacity, conduct unbecoming an accountant, negligence or incompetence and significant breaches of the code of ethics;
- (2) **Grant Perry McGowan** failed to respond to the professional conduct committee on numerous occasions which seriously impedes the institute's conduct processes; and
- (3) there was a prior charge against **Grant Perry McGowan**, a consent order of a severe reprimand and the payment of costs of \$3,500.00 for a complaint of a significantly similar nature.

The tribunal agreed with the prosecution that the charges to which the member had pleaded guilty were serious, that the member was guilty of totally unprofessional conduct and that his actions related to vulnerable clients.

He had put clients' money in high risk investments and in investments in which he himself had a financial interest.

There had been a pattern of offending and **Grant Perry McGowan** had treated the professional conduct committee with disdain.

Right of Appeal

Pursuant to Rule 21.41 of the Rules of the Institute of Chartered Accountants of New Zealand which were in force at the time of the original notice of complaint, the member may, not later than 14 days after the notification of this tribunal to the member of the exercise of its powers, appeal in writing to the appeals council of the institute against the decision.

No decision other than the direction as to publicity shall take effect while the member remains entitled to appeal or while any such appeal by the member awaits determination by the appeals council.

“trust deposit” means a deposit (not being an agency deposit, an investment deposit, a protection deposit or a special deposit) held on trust:

- (i) for persons not of full age or capacity; or
- (ii) for beneficiaries not entitled to payment at call; or
- (iii) otherwise than at call.

(2) Expressions defined in the Act have the same meaning in this notice as they do in the Act.

3. Rates of Common Fund interest—(1) The rate of Common Fund interest on deposits (other than investment deposits repayable at the end of a fixed term or protection deposits) shall be that specified in Schedule 1 for the appropriate type of deposits.

(2) The rate of Common Fund interest on each protection deposit associated with a particular private training establishment shall be that specified in Schedule 2 for the appropriate dollar range of the total of those deposits.

(3) The rate of Common Fund interest payable on investment deposits repayable at the end of a fixed term shall be that specified in Schedule 3 for the appropriate interest payment frequency, term and dollar range.

(4) Despite subparagraph (1), the rate of Common Fund interest payable on deposits made pursuant to an enactment shall be the rate (if any) specified in the enactment.

Commerce Commission

Commerce Act 1986

Gas Control Inquiry

The Commerce Act 1986 envisages the possibility that control may be introduced over goods and services as part of the statutory framework to promote competition in markets within New Zealand. The relevant provisions are found in Part IV of the Act.

By letter dated 30 April 2003, the Minister of Energy (“Minister”) requested the Commerce Commission (“Commission”) to undertake a Gas Control Inquiry (“the inquiry”) into whether or not control should be introduced in relation to the goods and services supplied by persons in markets directly related to either a natural gas transmission system or a natural gas distribution system or both (gas services).

The Minister’s request specified that the Commission must deliver its findings by **1 November 2004**.

The Commission is carrying out a two-stage process.

The first stage, which has already been completed, involved interested parties giving their views on the Commission’s proposed framework.

The second stage will involve interested parties giving their views on the application of that framework.

As part of the first stage of the inquiry process, the Commission released a draft framework paper on **16 July 2003** and invited interested parties and industry participants to make written submissions on the draft framework paper by **15 August 2003**.

Following the submission period, the Commission held a conference on the draft framework paper between **1 September 2003** and **4 September 2003**.

The second stage of the process involves the Commission releasing a draft report setting out the findings of the inquiry.

The Commission released the draft report on **21 May 2004**.

There will be a submission period and conference on the draft report following this release. The Commission invites interested parties to give their views on the draft report.

The Commission in an earlier notice (*New Zealand Gazette*, 24 July 2003, page 2218) indicated that the due date for written submissions would be **30 April 2004** with the conference planned for the week commencing **31 May 2004**.

The Commission now extends the due date for written submissions to **2 July 2004** by 12.00 midday with the conference now being held between **22 July 2004** and **23 July 2004** and **26 July 2004** and **28 July 2004**.

Notice of Making of Electricity Governance Amendment Rules (No. 3) 2004

1. Pursuant to section 172I of the Electricity Act 1992, I notify the amendment of the Electricity Governance Rules 2003 ("the rules") under section 172H of the Electricity Act 1992.

- (g) amending rule 3.12 of section II of part G;
- (h) amending rule 3.14 of section II of part G;
- (i) amending rule 3.15 of section II of part G;
- (j) amending rule 3.17.1 of section II of part G;
- (k) amending rule 3.18 of section II of part G;
- (l) amending rule 3.19 of section II of part G;
- (m) amending rule 4.4 of section III of part G;
- (n) renumbering existing rules 4.4.5 to 4.4.10 of section III of part G as 4.4.6 to 4.4.11 of section III of part G;
- (o) amending rule 4.11 of section III of part G;
- (p) amending rule 8.2.1 of section III of part G;
- (q) amending rule 3.2.1 of section V of part G;
- (r) deleting rule 3.2.2 of section V of part G;
- (s) renumbering existing rules 3.2.3 to 3.2.5 of section V of part G as 3.2.2 to 3.2.4 of section V of part G;
- (t) amending rule 3.3 of section V of part G;
- (u) amending rule 1.3.4 of schedule G6 of part G;
- (v) inserting a new Form 2 in schedule G1 of part G;
- (w) renumbering existing Forms 2 to 6 as Forms 3 to 7; and
- (x) updating all relevant cross references appropriately.

4. These rules come into force on 1 July 2004.

Energy Efficiency and Conservation Act 2000

Proposal to Make Regulations for Mandatory Energy Performance Standards

Pursuant to section 36 of the Energy Efficiency and Conservation Act 2000, the Minister of Energy gives the following notice.

The Minister of Energy proposes to recommend to Cabinet that Schedule 1 of the Energy Efficiency (Energy Using Products) Regulations 2002 be amended to introduce mandatory energy performance standards (MEPS) for a range of energy-using products, and to increase the stringency of MEPS for a number of other energy-using products.

A period of public consultation on the proposed Regulations is also notified and details are given below.

The proposed amendments are as follows:

- To introduce minimum energy performance standards for commercial refrigeration equipment as defined in AS1731:2003, for introduction on 1 October 2004.

- To introduce minimum energy performance standards for distribution transformers as defined in AS 2374 (oil filled) and AS 2375 (dry type), for introduction on 1 October 2004.
- To introduce minimum energy performance standards for single phase air conditioners as defined in AS/NZS 3823:2003, for introduction on 1 October 2004.
- To increase the stringency of minimum energy performance standards for single phase and three phase air conditioners as defined in AS/NZS 3823:2003 by October 2007.
- To increase the stringency of minimum energy performance standards for household refrigerators and freezers as defined in AS/NZS 4474.2-2001 on 1 January 2005.

The proposed Regulations will establish, or increase the stringency of, the minimum energy performance standards of these products to ensure alignment of standards with Australia, in accordance with the Trans-Tasman Mutual Recognition Arrangement, and to ensure the cost effective improvement of energy efficiency performance of these product classes.
