#### Limits and Exclusions on Class 4 Venue Costs Notice 2 September 2004

Pursuant to section 116 of the Gambling Act 2003, I, Catherine Jane Reid, Manager, Gaming Operational Policy, Department of Internal Affairs, acting under authority delegated to me by the Secretary for Internal Affairs, give notice that the following limits and exclusions on the costs that may be incurred by a corporate society that conducts class 4 gambling have been set.

1. This notice applies only to costs associated with class 4 venues in respect of which a venue agreement is required under the Gambling Act 2003.
2. A corporate society, when incurring costs associated with class 4 venues, must not incur costs of:
  - (a) more than \$0.60 per gaming machine per hour of gaming machine operation in Hourly Operating Costs (Limit A);
  - (b) more than \$75.00 per gaming machine per week for Weekly Operating Costs (Limit B);
  - (c) more than \$800.00 per venue per week for Venue Operating Costs (Limit C); and
  - (d) more than 16% of the turnover from all class 4 gambling conducted by that corporate society in any 12-month period, less prizes paid in that period (Limit D).
3. A corporate society, when incurring costs associated with a class 4 venue, must not:
  - (a) incur costs that are not Hourly Operating Costs, Weekly Operating Costs or Venue Operating Costs;
  - (b) incur costs that are Hourly Operating Costs, Weekly Operating Costs or Venue Operating Costs for services performed at class 4 venues in the operation of class 4 gambling except for those made within the limits set out in (2) (a), (2) (b), (2) (c) and (2) (d);
  - (c) reimburse costs of a venue operator that the venue operator is not liable for under the venue agreement or that are not actually incurred by the venue operator; or
  - (d) incur the same cost simultaneously in more than one of the categories specified in (2) (a)-(c).
4. For the purposes of this notice:
 

“Hourly Operating Costs” are:

  - (i) labour costs for the performance of tasks required for the hourly operation of machines;
  - (ii) electricity costs of operating gaming machines; and
  - (iii) fees, for managing the provision of the services specified in (4) (i) and (4) (ii), not exceeding 25% of the sum of (4) (i) and (4) (ii).

“Weekly Operating Costs” are:

  - (iv) labour costs for the performance of tasks required for the weekly management of machines;

- (v) rent or lease payments for hosting gaming machines;
- (vi) insurance costs;
- (vii) interest costs; and
- (viii) fees, for managing the provision of the services specified in (4) (iv)-(vii), not exceeding 25% of the sum of (4) (iv), (4) (v), (4) (vi) and (4) (vii).

“Venue Operating Costs” are:

- (ix) labour costs for the performance of tasks required for the weekly provision of a venue;
- (x) security costs;
- (xi) developments and/or enhancements and/or maintenance of the venue; and
- (xii) fees, for managing the provision of the services specified in (4) (ix)-(xi), not exceeding 25% of the sum of (4) (ix), (4) (x) and (4) (xi).

5. The limits and exclusions in this notice take effect on 1 December 2004 except those in (2) (d), which take effect from 1 December 2005 onwards.

#### The Public Trust Common Fund Interest Rates Notice 2 September 2004

The following notice is given pursuant to section 50 of the Public Trust Act 2001 ("the Act").

##### Notice

**1. Title and commencement**—(1) This notice may be cited as the Public Trust Common Fund Interest Rates Notice 2 September 2004.

(2) The determinations and revocation notified in this notice take effect from and including 26 August 2004.

**2. Interpretation**—(1) Unless the context otherwise requires:

"agency deposit" means a deposit (not being an investment deposit) held as agent or attorney;

"call deposit" means a deposit (not being an agency deposit, an investment deposit, a protection deposit, a special deposit or a trust deposit) held in the ordinary course of administration, and determined by Public Trust to be held at call;

"deposit" means a sum of money held by Public Trust belonging to any estate, which money for the time being forms part of the Common Fund;

"investment deposit" means a deposit held at call or otherwise as an investment under section 51 of the Act;

"protection deposit" means a deposit, held at call, of tuition, boarding, accommodation or other fees by or on behalf of a student enrolled at a private training establishment within the meaning of Part 18 of the Education Act 1989;

"special deposit" means a deposit held other than at call on behalf of the Crown, or any local authority within the meaning of the Local Government Act 1974;

"trust deposit" means a deposit (not being an agency deposit, an investment deposit, a protection deposit or a special deposit) held on trust:

- (i) for persons not of full age or capacity; or
- (ii) for beneficiaries not entitled to payment at call; or
- (iii) otherwise than at call.

(2) Expressions defined in the Act have the same meaning in this notice as they do in the Act.

**3. Rates of Common Fund interest**—(1) The rate of Common Fund interest on deposits (other than investment deposits repayable at the end of fixed term or protection deposits) shall be that specified in Schedule 1 for the appropriate type of deposits.

(2) The rate of Common Fund interest on each protection deposit associated with a particular private training establishment shall be that specified in Schedule 2 for the appropriate dollar range of the total of those deposits.

(3) The rate of Common Fund interest payable on investment deposits repayable at the end of a fixed term shall be that specified in Schedule 3 for the appropriate interest payment frequency, term and dollar range.

(4) Despite subparagraph (1), the rate of Common Fund interest payable on deposits made pursuant to an enactment shall be the rate (if any) specified in the enactment.

(5) Despite subparagraphs (1), (2) and (3), in particular cases or classes of case, Public Trust and the depositor may agree on a rate of interest payable on investment deposits, protection deposits or special deposits that is different from

the rate specified in Schedules 1, 2 or 3 and the agreed rate then applies.

**4. Revocation of notice and transitional provisions**—(1) The Public Trust Common Fund Interest Rates Notice 26 August 2004 is revoked.

(2) The rates of interest specified in Schedules 1 and 2 to this notice do not apply to any period that ends with 25 August 2004 but otherwise operate as from 26 August 2004.

(3) The rates of interest specified in Schedule 3 to this notice:

- (i) do not apply to investment deposits repayable at the end of a fixed term that commenced prior to 26 August 2004; but
- (ii) do apply to investment deposits repayable at the end of a fixed term that commenced on or after 26 August 2004.

### Foundation for Research, Science, and Technology Act 1990

#### Notice of Changes to Ministerial Scheme Under Section 8A of the Foundation for Research, Science, and Technology Act 1990—the TechLink Scheme

*Direction to:* The Foundation for Research, Science and Technology (“the foundation”).

Under section 8A of the Foundation for Research, Science, and Technology Act 1990, I direct the foundation to allocate funds in accordance with the TechLink Scheme (“the scheme”) specified in this notice.

This notice revokes and replaces the notice published in the *New Zealand Gazette*, 6 July 2000, page 1814, which established the TechLink programme within the Technology New Zealand Scheme.

#### Nature of the Scheme

The scheme is intended to create awareness of, and facilitate access to, technology and technological capabilities that are new to firms<sup>1</sup>.

The intended outcome of the scheme is an increased awareness and understanding of the value that technological innovation can deliver to their businesses.

The scheme should target all firms, with an emphasis on small and medium sized firms<sup>2</sup>.

#### Objectives of the Scheme

The objectives of the scheme are to:

- increase the awareness of, understanding of, and access to new technology and technological capabilities critical to successful firms now and in the future;
- provide firms with access to and information about public and private suppliers of technology, and

technology services, within New Zealand and overseas; and

- reduce transaction cost barriers associated with providing:
  - technology appraisal services to small and medium sized firms; and
  - access to new technology and to sources of guidance and assistance to firms commencing technology based projects.

#### Mechanisms of Support for the Scheme

The foundation will allocate funds to support projects that meet the scheme’s objectives. These funds can be allocated to a firm (or a group of firms). The foundation may require a firm(s) to fund up to 50% of the project costs. The project should be aimed at increasing awareness and understanding, by firms, of the value that technological innovation can deliver to that firm or other firms.

The scheme will target support to those projects that, in the foundation’s view, best meet the following criterion:

- Have the potential to create awareness of, and facilitate access to, technology or technological capabilities that are new to the firm(s).

The foundation will have full discretion to manage the allocation of funds for the scheme in a way that achieves the outcome and objectives of the scheme. The type of projects that could be supported may include, but are not limited to, the following examples:

- Publication, promotion and pro-active delivery of technology success stories and case studies on a national and a regional basis; or
- delivery of technology information and advisory services (including planning) to firms commencing technology-based projects; or
- facilitating networks of firms based around technology or with the potential to do so; or
- assist collectives<sup>3</sup> entities in identifying and evaluating through technical means, the commercial opportunities provided by the entities’ access or rights to:
  - land or related assets that cannot be used as collateral for bank loans;
  - special land feature or qualities of the land or related assets; and
  - indigenous resources, including native flora and fauna, traditional knowledge and customary rights;
 and to use scientific evidence to assist the entity in determining which commercial opportunity to pursue; and
- encourage collectives into high-tech, high value-added processing, through fostering their research, science and technology capability and capacity to absorb and make use of advanced knowledge.

#### Funding to be Allocated

Funds available for the scheme will be published each year in the estimates of appropriations.

The foundation will have the discretion to allocate up to 10% of funding for this scheme:

- to the Technology for Business Growth scheme or the Technology for Industry Fellowship Scheme; or
- between the Technology for Business Growth Scheme and the Technology for Industry Fellowship Scheme

if all schemes involved in the allocation are appropriated within the same non departmental output class under the Public Finance Act 1989.

The Minister of Research, Science and Technology’s written approval is required before the foundation can allocate 10% or more than 10% of the scheme to any other scheme issued by the Minister of Research, Science and Technology under



section 8A of the Foundation for Research, Science, and Technology Act 1990.

#### Period of Operation

The scheme will commence operation on 1 August 2004 and is estimated to continue for a period of five years from 1 August 2004.

#### Monitoring Agency

Monitoring of the scheme, including implementation of this notice by the Foundation for Research, Science and Technology and the extent to which the scheme achieves its stated objectives, will be carried out by the Ministry of Research, Science and Technology.

### Notice of Introduction of a Ministerial Scheme Under Section 8A of the Foundation for Research, Science, and Technology Act 1990—the International Investment Opportunities Fund

*Direction to:* The Foundation for Research, Science and Technology (“the foundation”).

Under section 8A of the Foundation for Research, Science, and Technology Act 1990, I direct the foundation to allocate funds in accordance with the International Investment Opportunities Fund (“the scheme”) specified in this notice.

#### Nature of the Scheme

The intended outcome of this scheme is to increase the ability of New Zealand researchers to participate in research collaborations that attract international co-funding, to recruit highly experienced researchers from overseas and to support participation in international research programmes with a high relevance to New Zealand’s economic, social and/or environmental development.

The scheme will be used to secure benefits for New Zealand in terms of research funding, access to equipment or technologies not available in New Zealand and ensuring advanced skills are matched to areas of strong growth.

The foundation will work with the Health Research Council of New Zealand (HRC) and the Ministry of Research, Science and Technology to develop and implement priorities, and work with the HRC to invest the fund each year. The scheme will give priority to opportunities involving bilateral partners identified in the Government’s Research, Science & Technology International Linkages Strategy.

#### Scheme Objectives

Projects that meet the scheme’s objectives are eligible to receive funds from the foundation.

The scheme’s objectives are:

- **Objective One:** To provide funding to enable New Zealand researchers to respond to out-of cycle

opportunities to gain access to international research programmes and associated funding streams;

- **Objective Two:** To establish joint funding pools with other countries to facilitate research programmes of joint interest; and
- **Objective Three:** To assist world-leading researchers, working in key areas of strategic interest to New Zealand, to relocate to New Zealand and establish a research team.

In making funding decisions, the foundation will fund those programmes that, in its view, best meet the following criteria:

- Scientific and technological quality; and
- potential benefit to New Zealand; including the ability to utilise overseas expertise and advances in science and technology, and the contribution to New Zealand’s research, science and technology goals.

#### Operating Principles

In running the fund, the foundation will:

- seek commitment from the research institutions submitting proposals to provide infrastructural support and organisational co-funding for successful projects;
- seek to leverage New Zealand funding to ensure the best outcomes for New Zealand research and researchers;
- seek to ensure benefit to New Zealand is captured for the wealth and wellbeing of New Zealanders; and
- ensure the process is flexible and responsive to opportunity.

#### The Mechanism

The scheme has three separate but interlinked objectives—

Objective One of the scheme is intended to provide a mechanism for New Zealand researchers to gain entry into overseas research programmes and funds that, due to timing, would not otherwise occur as part of the standard investment cycle. The funds under this objective should be invested contestably and sufficiently frequently to meet out-of cycle opportunities.

Funds will be provided by the international investment opportunities fund to meet the following needs:

- Providing seeding or bridging funding to underwrite the New Zealand share of the costs of a joint research proposal with international partners, until these can be accommodated within normal funding cycles.

Under Objective Two, funds will be provided for New Zealand research purchase agencies to establish a diversity of joint funding pools with overseas funders, including:

- developing research opportunities for New Zealand in strategic partnership with overseas funding agencies; and
- investing in targeted research capacity development initiatives in partnership with overseas funding agencies.

Objective Two will be administered on a contestable basis and aim to encourage a range of partnerships.

Under Objective Three, funds may be provided to assist world-leading researchers, working in areas of strategic interest to New Zealand, to relocate to New Zealand. Costs covered by this objective may include:

- relocation costs;
- research funding until a researcher can be accommodated within normal funding cycles; and
- salary costs.

Objective Three requires co-funding and support from a host institution.

### Allocation of Funding

Funds available to the scheme will be published each year in the estimates of appropriations.

### Period of Operation

The scheme commenced operation on 1 September 2004. Its continuation and mode of operation will be reviewed after two years.

### Monitoring Agency

Monitoring and review of the scheme, including of the implementation of this Ministerial notice by the foundation and the extent to which the scheme achieves its stated objectives, will be carried out by the Ministry of Research, Science and Technology.

The expanded scheme will support firms by one or more of the following objectives:

- Creating new research, science and technological capabilities within New Zealand firms.
- Building research and development (R&D) absorptive capacity within New Zealand firms.
- Fostering connections between New Zealand firms and existing research providers<sup>2</sup> (both public and private).
- Improving researchers’ understanding of the business environment within which R&D is undertaken (and vice versa).
- Developing individuals’ skills and knowledge of commercially focused R&D environments.
- Increase the chances of business success through the appropriate use of expert assistance.

### Mechanisms of Support

The foundation will use the scheme to allocate funds to:

- provide salary support for the secondment of individuals between a firm and a research provider to undertake a commercially-focused science or technology project, management of an R&D project, or commercialisation of an R&D project<sup>3</sup>;

- provide support for the placement of individuals within firms or research providers to cover senior undergraduates, postgraduates, recent graduates, recent immigrants and experts to undertake a commercially-focused science or technology project, management of an R&D project, or commercialisation of an R&D project; or
- provide a stipend for an individual to undertake a commercially-focused science or technology project, or an R&D commercialisation project; while undertaking a postgraduate tertiary qualification.

The foundation may require a firm(s) to fund up to 50% of the project costs. More projects may meet the scheme’s objectives than there are funds available. The foundation will fund those projects that, in its view, best meet the following criteria:

- They are supported by a firm(s) and, where necessary, are supported by an appropriate research provider; and
- the fellows will be of at least undergraduate level working towards a tertiary qualification, or be qualified in the fields of science, engineering, technology, R&D project management or R&D commercialisation, relevant to the project.

The foundation will have full discretion to manage the allocation of funds for the scheme in a way that achieves the outcome and objective of the scheme.

### Funding to be Allocated

Funds available for the scheme will be published each year in the estimations of appropriations.

The foundation will have the discretion to allocate up to 10% of funding for this scheme to the TechLink Scheme, the Technology for Business Growth Scheme or the Grants for Private Sector Research and Development Scheme, provided all schemes involved in the allocation are appropriated within the same non departmental output class under the Public Finance Act 1989.

The Minister of Research, Science and Technology’s written approval is required before the foundation can allocate 10% or more of the scheme to any other scheme issued by the Minister of Research, Science and Technology under section 8A of the Foundation for Research, Science, and Technology Act 1990.

### Period of Operation

The expanded scheme will commence on 1 July 2004 and it is anticipated to continue for a period of five years.

### Monitoring Agency

The Ministry of Research, Science and Technology will monitor the scheme, including implementation of this Ministerial notice by the Foundation for Research, Science and Technology, and the extent to which the scheme achieves its stated objectives.

<sup>3</sup>R&D project management and R&D commercialisation projects are to target R&D gaps, and may include experimental, and production development and intellectual property management. This extended scope does not extend to the management of non-technical projects, market assessments and developing market strategies etc.
