### Dumping and Countervailing Duties Act 1988

#### Final Determination of Dumping Investigation: Oral Liquid Paracetamol From the Republic of Ireland

Pursuant to section 13 of the Dumping and Countervailing Duties Act 1988 ("the Act"), I hereby give notice that I have made a final determination that, in relation to the importation or intended importation of the goods specified in the Schedule to this notice (the "subject goods"):

- (a) the subject goods are being dumped; and
- (b) by reason thereof, material injury to the New Zealand industry is threatened.

#### Schedule

##### Goods Subject to Determination

##### Country of Origin

The Republic of Ireland (Ireland).

##### Description of Goods

*Oral liquid paracetamol in various strengths and pack sizes, excluding: elixirs and paracetamol in other forms.*

The goods are currently classified under Tariff Item 3003.90.09 and Statistical Key 10K and 3004.90.19 and Statistical Key 19G.
