### Restricted Activities Under the Health Practitioners Competence Assurance Act 2003

On 27 June 2005, the Health Practitioners Competence Assurance (Restricted Activities) Order 2005 was made by the Governor-General, pursuant to section 9 of the Health Practitioners Competence Assurance Act 2003 ("the HPCAA").

Formal notification of that Order in Council appears at page 2396 of this *New Zealand Gazette*.

#### What are restricted activities? What does this mean for you?

Section 9 of the HPCAA allows for specified activities to be restricted to registered health practitioners, in order to protect members of the public from the risk of serious or permanent harm.

From 1 August 2005, it will be illegal for anyone other than a health practitioner registered under the HPCAA to perform any of the activities listed below. It is an exception to this if the activity is performed in an emergency situation.

Any breaches will be investigated by the Ministry of Health and may be prosecuted. Anyone found guilty on summary conviction faces a fine of up to \$30,000.

#### What restrictions are being put in place?

The restricted activities that are to be declared under the HPCAA are:

- (a) Surgical or operative procedures below the gingival margin or the surface of the skin, mucous membranes or teeth.
- (b) Clinical procedures involved in the insertion and maintenance of fixed and removable orthodontic or oral and maxillofacial prosthetic appliances.
- (c) Prescribing of enteral or parenteral nutrition where the feed is administered through a tube into the gut or central venous catheter.
- (d) Prescribing of an ophthalmic appliance, optical appliance or ophthalmic medical device intended for remedial or cosmetic purposes or for the correction of a defect of sight.
- (e) Performing a psychosocial intervention with an expectation of treating a serious mental illness without the approval of a registered health practitioner.
- (f) Applying high velocity, low amplitude manipulative techniques to cervical spinal joints.

This will be supplemented shortly by explanatory material that assists to clarify the intended scope and intention of these restrictions.

A key consideration is that the restrictions are not intended to restrict the activities of practitioners of established professions not regulated under the HPCAA, from carrying out activities that they are currently legitimately doing without risk of harm to the public.

### Social Security Act 1964

#### Home Help Amendment 2005

Pursuant to section 124 (1) (d) of the Social Security Act 1964, the Minister for Social Development and Employment establishes and approves the following amendment to the Home Help Programme (as established and approved on 6 May 2004).

#### A m e n d m e n t

**1. Title**—(1) This amendment is the Home Help Amendment 2005.

(2) In this amendment, the Home Help Programme is called “the programme”.

**2. Commencement**—(1) This amendment, except for clause 4, comes into effect on 1 July 2005.

(2) Clause 4 comes into effect on 1 April 2007.

**3. Schedule amended**—The Schedule of the programme is amended by revoking clause 1, and substituting the following clauses:

“1 The hourly rate that may be paid for a home helper is—

- (a) \$10; plus
- (b) an additional 6% of the rate in paragraph (a) for holiday pay.

“1A If the minimum wage rate for an adult worker paid by the hour prescribed by Order in Council under the Minimum Wage Act 1983 increases from the rate in force on 1 April 2005, the rate in paragraph (a) of clause 1 must be considered to be increased by the same proportion as that minimum wage rate has increased, with effect on,—

- (a) except as provided in paragraph (b), the 1 April following the date on which the minimum wage rate increase comes into force; or
- (b) if the minimum wage rate increase comes into force on 1 April in a year, that 1 April.”

**4. Schedule amended**—Clause 1 of the Schedule of the programme (as substituted by clause 3) is amended by omitting from paragraph (b) the expression “6%”, and substituting the expression “8%”.

#### **Explanatory Note**

*This note is not part of the amendment, but is intended to indicate its general effect.*

*This amendment to the Home Help Programme:*

- changes, on and from 1 July 2005, the hourly rate that may be paid to a home helper from a maximum of \$10.14 including holiday pay to a uniform rate of \$10.00 plus an additional 6% for holiday pay;
- provides for the \$10.00 rate to be indexed, on 1 April each year, to increases in the minimum wage rate payable to an adult worker paid by the hour from that applying on 1 April 2005; and
- increases, on 1 April 2007, the additional 6% for holiday pay to an additional 8%.

Omit from the paragraph immediately following the heading “**Grants of Living Alone Payments**” the words “section 18A of the Social Welfare (Transitional Provisions) Act 1990” and substitute the words “section 13 of the New Zealand Superannuation and Retirement Income Act 2001 or section 74U of the War Pensions Act 1954”.

##### **Clause 1**

Omit from the definition of **living alone payment** the words “section 18A of the Social Welfare (Transitional Provisions) Act 1990” and substitute the words “section 13 of the New Zealand Superannuation and Retirement Income Act 2001 or section 74U of the War Pensions Act 1954”.

##### **Clause 2**

Omit paragraph (a).

##### **Clause 3**

Omit the words “is contributing directly or indirectly to the cost” and substitute the words “is regularly contributing in a substantial way to the total cost”.

##### **New clause 3A**

Insert, after clause 3:

“3A An applicant should not be considered to be sharing household expenses with his or her spouse or partner by reason only that they share a joint bank account.”

Omit the example immediately before clause 4.

##### **Explanatory Note**

*This note is not part of the amendment, but is intended to indicate its general effect.*

*This amendment to the Ministerial Direction – Living Alone Payments, which comes into effect on 1 July 2005:*

- updates references to the statutory provisions relating to living alone payments;
- omits the provision requiring an applicant to have a right to exclusive occupation of the residence occupied;
- changes clause 3 of the direction so that regular contributions in a substantial way to the total cost of the applicant’s household expenses are considered to be the sharing of household expenses, instead of direct or indirect contributions to the cost;
- clarifies that the sharing of a joint bank account between the applicant and his or her spouse or partner is not by itself considered to be the sharing of household expenses;

### Programme

**1. Title**—This programme is the Exempt Persons Personal Allowance Programme.

**2. Commencement**—This programme comes into effect on 1 July 2005.

**3. Purpose**—The purpose of this programme is to provide a personal allowance to exempt persons in long-term residential care who would otherwise be required to contribute the whole of their benefits to the cost of contracted care services provided to them.

**4. Interpretation**—(1) In this programme, unless the context otherwise requires:

**Act** means the Social Security Act 1964

**allowance** means an exempt person’s personal allowance (being the special assistance under this programme)

**expiry date** means the earlier of the dates set out in clause 8.

(2) Terms otherwise defined in section 3 (1) and in Part 4 of the Act have the same meanings.

(3) References in this programme to sections 139, 142, and 155, Part 4, and Schedule 27 of the Act are to those provisions as inserted or substituted on 1 July 2005 by sections 5 and 6 of the Social Security (Long-term Residential Care) Amendment Act 2004.

**5. Application of the Social Security Act**—(1) Sections 12, 62, 74, 74A, 77 (1), 80A, 80BD (1) and 86J of the Act apply to this programme and any exempt person as if the assistance under this programme were a benefit under the Act.

(2) Nothing in subclause (1) affects or limits the application of any other provision of the Act.

**6. Exempt person’s personal allowance**—(1) An exempt person in receipt of any benefit is entitled to receive an exempt person’s personal allowance under this programme.

(2) The amount of an allowance is the same amount as Regulations made under section 155 of the Act prescribe as the amount of a personal allowance for the purposes of Part 3 of Schedule 27 of the Act (not exceeding the amount of the benefits received by the exempt person).

**7. Period for which allowance payable**—(1) An allowance commences on the date on or after 1 July 2005 on which the exempt person becomes liable, under section 139 and section 142 of the Act, to make payment of any benefit received by the person towards the cost of contracted care services provided to the person.

(2) An allowance ends on the earliest of the following dates:

- (a) The date on which the exempt person ceases to be entitled to any benefit;
- (b) the date on which the person ceases to be an exempt person or dies; or
- (c) the expiry date.

**8. Expiry**—This programme expires on 30 June 2006, or any earlier date on which it is revoked.

### Explanatory Note

*This note is not part of the programme, but is intended to indicate its general effect.*

*This programme, which comes into effect on 1 July 2005, provides an exempt person in long-term residential care, who would otherwise be required to contribute the whole of the person’s benefits to the costs of the care, with a personal allowance of the same amount as other residents assessed as requiring care are allowed to retain from their benefits, but not exceeding the amount of the benefits the person receives.*

### Programme

**1. Title**—This programme is the Employment Transition Programme.

**2. Commencement**—This programme comes into effect on 1 July 2005.

**3. Purpose**—The purpose of this programme is to support people with disabilities who were formerly in receipt of an invalid's benefit to remain in employment following the completion of an employment trial.

**4. Interpretation**—(1) In this programme, unless the context otherwise requires:

**Act** means the Social Security Act 1964

**applicant** means a person who applies for assistance or a person on whose behalf an application for assistance is made

**assistance** means employment transition assistance, being the special assistance under this programme

**earner levy** means the levy payable under subsections (1) and (2) of section 219 of the Injury Prevention, Rehabilitation, and Compensation Act 2001

**expiry date** means the date referred to in clause 10

**employment trial** means the undertaking, by an invalid's beneficiary granted that benefit on the ground of permanent and severe restriction of capacity for work, of a period of open employment agreed with the chief executive under section 44A (2) of the Act to establish whether he or she could sustain that employment

**net specified income**, in relation to a person, means:

- (a) the amount of the person's income (within the meaning of section 3 (1) of the Act) after the deduction of income tax and the earner levy; and
- (b) includes the amount (after abatement on account of income) of any of the following benefits payable to the person and the person's spouse or partner:
  - (i) an unemployment benefit or a sickness benefit, a widow's benefit, a domestic purposes benefit, an invalid's benefit, an independent youth benefit, or an emergency benefit; or
  - (ii) New Zealand superannuation or a veteran's pension.

(2) Terms otherwise defined in the Act have the same meanings in this programme.

**5. Application of Social Security Act**—(1) Sections 12, 62, 66, 74, 74A, 76, 77, 80 (1), 80A, 80BD, 81, 82 (1) and (4), 84, 84A and 86J of the Act apply to this programme and to any applicant as if the special assistance under it were a benefit.

(2) Nothing in subclause (1) limits or affects the application of any other provision of the Act.

**6. Employment transition assistance**—(1) This clause applies to an applicant who:

- (a) as a result of undertaking an employment trial, had his or her invalid's benefit cancelled on the grounds that he or she was capable of regularly working 15 or more hours a week in open employment; and
- (b) applies for assistance under this programme more than 28 days before the expiry date, and:
  - (i) within 28 days after the cancellation of the benefit, if the benefit was cancelled on or after 1 July 2005; or
  - (ii) within 60 days of 1 July 2005, in any other case.

(2) The chief executive may grant an applicant to whom this clause applies employment transition assistance if satisfied that:

- (a) the applicant is regularly working 15 or more hours a week in open employment (whether or not

the employment is the same employment as the applicant undertook during the employment trial); and

- (b) the applicant's income would not be sufficient to disentitle the applicant from receiving an invalid's benefit under the Act; and
- (c) the applicant's net specified income is less than the average amount of the applicant's net specified income over the period of the employment trial; and
- (d) without the assistance, the applicant would not be able to sustain the employment referred to in paragraph (a).

(3) This clause is subject to clause 8 (4).

**7. Rate of assistance**—(1) The amount of assistance payable in respect of any week is:

a – b but not more than c

(2) No assistance is payable in respect of any week in which b is greater than a.

(3) In this clause:

**a** is the average amount of the applicant's net specified income over the period of the employment trial;

**b** is the amount of the applicant's net specified income in respect of the week concerned; and

**c** is the amount of an invalid's benefit that would be payable to the applicant and the applicant's spouse or partner if the applicant were granted that benefit.

**8. Period of grant of assistance**—(1) Assistance granted under clause 6 (2) commences on the later of the following dates:

- (a) The date of application for the assistance; or
- (b) 1 July 2005.

(2) Assistance granted under that clause ceases if:

- (a) for 8 consecutive weeks, the applicant's income is equal to or more than the amount that would disentitle the applicant from receiving an invalid's benefit under the Act; or
- (b) the applicant has received no income from employment for 4 consecutive weeks; or
- (c) the applicant is again granted an invalid's benefit.

(3) If it has not ceased earlier, assistance ceases with the close of the expiry date.

(4) Where assistance has ceased under subclause (2), an applicant is not entitled to receive any further assistance under this programme unless the applicant is again granted an invalid's benefit and completes a further employment trial.

**9. Reviews of assistance**—Without limiting section 81 of the Act, the chief executive must review an applicant's eligibility for assistance:

- (a) 6 months after the assistance commences; and
- (b) at 6 monthly intervals thereafter.

**10. Expiry**—This programme expires on 31 July 2007.

#### *Explanatory Note*

*This note is not part of the programme, but is intended to indicate its general effect.*

*This programme, which comes into effect on 1 July 2005, provides financial support to support people with disabilities who were formerly in receipt of an invalid's benefit to remain in employment following the completion of an employment trial.*

- In any one or more monthly instalments of the levy, by setting a new rate for that activity or by adjusting an existing levy rate under Regulation 10; or
- in the end-of-year reconciliation under Regulations 11 to 13.

The Commission has decided to recover the costs in relation to the Whirinaki contract by setting a new annual levy rate for supply security operations under Regulation 10.

Under Regulation 10, an annual levy rate is adjusted by redoing the calculation in Regulation 7 using the amended figures for the whole or any part of the financial year.

Regulation 7 specifies how the Commission must calculate the annual levy rates.

## **Securities Commission**

### **Securities Markets Act 1988**

#### **The Authorised Futures Dealers Notice (No. 2) 2005**

Pursuant to section 38 of the Securities Markets Act 1988, the Securities Commission gives the following notice.

#### **Notice**

**1. Title, commencement and expiry**—(1) This notice is the Authorised Futures Dealers Notice (No. 2) 2005.

(2) This notice comes into force on the day after the date of its publication in the *New Zealand Gazette*.

(3) This notice expires on the close of 30 June 2010.

**2. Interpretation**—(1) In this notice, unless the context otherwise requires:

“Act” means the Securities Markets Act 1988.

“OAM” means Overlay Asset Management.

(2) Any term or expression that is defined in the Act and used, but not defined, in this notice has the same meaning as in the Act.

**3. Authorisation**—(1) OAM is authorised to carry on the business of dealing in futures contracts generally.

(2) The authorisation is subject to the conditions that:

(a) OAM does not carry on the business of dealing in futures contracts except as part of the business of

OAM as a funds manager and provider of currency overlay management services; and

- (b) OAM deals only on behalf of its wholesale clients, being clients that are:
- (i) a person who owns tangible assets with a market value of more than \$10 million; or
  - (ii) a trustee of a trust or a funds manager, acting in that capacity, who has under that person's control, as trustee or funds manager, assets with an aggregate market value of more than \$50 million; or
  - (iii) a person who is authorised to carry on the business of dealing in futures contracts under the Act; or
  - (iv) a person authorised in another jurisdiction by the competent authority of that jurisdiction to deal in futures contracts; or
  - (v) Her Majesty the Queen in right of New Zealand, a Crown entity named in the Crown Entities Act 2004, or a State enterprise named in the First or Second Schedule to the State-Owned Enterprises Act 1986 (each as amended from time to time); or
  - (vi) a person who is a statutory corporation; or

(vii) a person who is a related body corporate of any of the persons mentioned in subparagraphs (i) to (vi) above; and

- (c) Before acquiring or disposing of any futures contract in respect of which the authorisation applies, OAM is satisfied on reasonable grounds that the wholesale client is contracting:
  - (i) as principal on its own account; or
  - (ii) on behalf of a related body corporate; or
  - (iii) as trustee of a trust or manager of a managed fund; and
- (d) OAM notifies the Commission of any material matter concerning OAM's authorisation as a futures dealer, including any regulatory action taken concerning OAM, whether in New Zealand or overseas; and
- (e) OAM provides the Commission with a copy of OAM's annual financial statements, including a certified correct full English translation of these accounts, no later than three months after the end of each financial year for OAM.

## General Section

### Varroa Agency Incorporated

#### Biosecurity Act 1993

#### Notice of Controlled Area and Movement Controls in Respect of Varroa Mite\*

**1. Commencement**—This notice takes effect on and from 1 July 2005.

**2. Controlled Area declaration**—Pursuant to section 131 (2) of the Biosecurity Act 1993, the Varroa Agency Incorporated hereby declares all parts of New Zealand that fall within the island known as the South Island and includes Stewart Island, to be an area that is controlled for the purpose of limiting the spread of varroa mite (*Varroa destructor*, formerly known as *Varroa jacobsoni*), being an unwanted organism under the Biosecurity Act 1993. This area is henceforth referred to as the “Controlled Area”.

**3. Notice of movement controls**—Pursuant to section 131 (3) of the Biosecurity Act 1993, the Varroa Agency Incorporated hereby gives notice that:

The movement into the Controlled Area from any other part of New Zealand that is not part of the Controlled Area, of the things listed in Schedule 1 is prohibited, except with the permission of an inspector or authorised person appointed under the Biosecurity Act 1993.

#### Schedule 1 – Things subject to movement controls

- Honey bees (meaning *Apis mellifera*), alive or dead, at any stage of development, including live beehives, nucleus colonies, frames of bee brood, queen bees and escorts, package bees and bulk bees.
- Used beehives (meaning anything that is being or has been used for the keeping of honey bees), including any part of any beehive.

- Unused beehives containing wax foundation or plastic frames covered with beeswax.
- Unprocessed beeswax, propolis and pollen, and any honey that is not packaged for retail sale.
- Used beekeeping equipment.
- Anything upon which, or within which, the varroa mite, dead or alive, is present.
- Vehicles, which are used for the purpose of visiting apiary sites and transporting any thing listed from (a) to (e) in this Schedule (beekeeping vehicles).
- Unprocessed logs (logs that have been felled with no further processing).
- Bulk wine grapes.
- Buildings (complete structures such as a house but not including portacombs).

*Please Note:* That it is an offence to move any of the things listed in Schedule 1 into the South Island without the permission of an inspector or authorised person. Every person who does so, commits an offence. In the case of an individual, a person may be sentenced to imprisonment for a term not exceeding five years, ordered to pay a fine not exceeding \$100,000.00, or both; in the case of a corporation, the penalty is a fine not exceeding \$200,000.00.
