Notice of Initiation: Review of Anti-dumping Duty Applying to Imports of Plasterboard from the **Kingdom of Thailand**

Pursuant to section 14 (8) of the Dumping and Countervailing Duties Act 1988, and acting under delegated authority from the Chief Executive of the Ministry of Economic Development, I have initiated a review of the imposition of anti-dumping duty in respect of the goods described in the Schedule to this notice ("the goods").

This initiation follows the receipt of an application made by the New Zealand industry providing positive evidence justifying the need for a review.

Anti-dumping duty was imposed on the goods following two separate determinations made on 27 September 2000 and 19 November 2000.

The current rate of duty on the goods results from a reassessment of the duty on 4 December 2002, and published in the New Zealand Gazette, 12 December 2002, No. 178, page 4481.
