3. Nomination of Tangata Tiaki/Kaitiaki—Ihaia Briggs and Tim Manawatu were nominated as Tangata Tiaki/Kaitiaki by Te Rūnanga o Koukourarata. Their appointments were originally confirmed by the Associate Minister of Fisheries by way of the Fisheries (South Island Customary Fishing) Notice (No. 28) 2001 (No. F181)*. Te Rūnanga

o Koukourarata, being the tangata whenua who holds manawhenua manamoana over the area/rohe moana (as represented by Te Rūnanga o Ngāi Tahu), has nominated Ihaia Briggs and Tim Manawatu as Tangata Tiaki/Kaitiaki for the area/rohe moana for a further five-year period each.
