### Notice of Decision of the Disciplinary Tribunal of the Institute of Chartered Accountants of New Zealand (Member Guilty of Misconduct in a Professional Capacity and Breaching the Rules and/or Code of Ethics of the Institute)

At a hearing of the Disciplinary Tribunal of the Institute of Chartered Accountants of New Zealand held in public on the 3rd and 4th days of July 2006, at which the member was in attendance and represented by counsel, **Leon Paul Hendren**, of Christchurch, pleaded guilty to the following charges (1) and (4) and admitted the following particulars 1.1 (a), (b), (c), (d), 1.2 (a), (b), (c), (d) and 2.1, and the tribunal found particular 2.2 proven. Charges (2), (3) and (5) were withdrawn by the prosecution.

#### Charges

THAT in terms of the Institute of Chartered Accountants of New Zealand Act 1996 and the Rules made thereunder, and in particular Rule 21.30, **Leon Paul Hendren** is guilty of:

- (1) misconduct in a professional capacity; and/or
- (2) (withdrawn);
- (3) (withdrawn);
- (4) breaching the Rules and/or Code of Ethics of the institute; and/or
- (5) (withdrawn).

#### Particulars

IN THAT in relation to being a member of the Institute of Chartered Accountants of New Zealand and in relation to a complaint, the member:

- 1.1 was professionally associated with an invitation to invest money to the public and/or prospective investors when he knew, or after reasonable enquiry ought to have known, that the invitation did not give a full and fair statement in relation to:
  - (a) the nature of the rights that were to be purchased by Partnership A from Company B; and/or
  - (b) the right to claim depreciation in accordance with the Income Tax Act 1994; and/or
  - (c) the true value of the rights that were being transferred and/or the purchase price to be paid by Partnership A; and/or
  - (d) the estimated future results for Partnership A for the years ended 31 March 1998 to 31 March 2007.
 (Code of Ethics 1995 – FP 1; and/or FP 2; and/or FP 5; and/or FP 7; and/or EP 8.4; and/or EP 22; and/or EP 29; and/or EP 31.)
- 1.2 made representations or caused representations to be made to one or more prospective investors in Partnership A which failed to present the information fully and/or honestly and/or professionally so that such

representations would be understood in the proper context in relation to:

- (a) the nature of the rights that were to be purchased by Partnership A from Company B; and/or
- (b) the right to claim depreciation in accordance with the Income Tax Act 1994; and/or
- (c) the true value of the rights that were being transferred and/or the purchase price to be paid by Partnership A; and/or
- (d) the estimated future results for Partnership A for the years ended 31 March 1998 to 31 March 2007.

(Code of Ethics 1995 – FP 1; and/or FP 2; and/or FP 5; and/or FP 7; and/or EP 22; and/or EP 29; and/or EP 31.)

AND the member:

2.1 failed to disclose to the prospective investors that he would directly or indirectly receive a financial benefit from the said scheme or arrangement; and/or

(Code of Ethics 1995 – FP 1; and/or FP 5.)

2.2 made conflicting statements to the professional conduct committee and the Inland Revenue Department as to the basis for determining the purchase price and/or valuation of the rights to be transferred.

(Code of Ethics 1995 – FP 1; and/or FP 5; and/or EP 29.)

### Reasons

The member has admitted all the particulars 1.1 (a), (b), (c), (d), 1.2 (a), (b), (c), (d) and 2.1 with the exception of particular 2.2 and pleaded guilty to charges (1) and (4) with charges (2), (3) and (5) being withdrawn by the prosecution.

In relation to particular 2.2, although he submitted that the conflicts could be reconciled, the tribunal found this particular proved but not of great significance.

The tribunal acknowledges the environment in which the member operated with an entrepreneurial firm, a charismatic boss and a natural desire to please his employer and a reliance on the ACTONZ precedence.

The tribunal also acknowledges that other parties were also participants but are not before the tribunal but it is no defence to ethical breaches that his employer was not bound by such a code.

The Code of Ethics requires among other things fundamental principles of integrity, objectivity, independence and freedom of conflicts of interest.

The tribunal asked if he had a genuine belief as to the business opportunity, the validity of the critical IP and the tax treatment to follow.

Despite the submissions on his behalf, the tribunal doubted that he did, but for a professional that belief must be reasonable as well as genuine.

IP was acquired for nothing and resold for \$7.5 million, a sum not supported by realistic or soundly researched projections.

But most telling, the member did not disclose his economic interest as a vendor of the \$7.5 million.

### Orders of the Tribunal

- (a) Pursuant to Rule 21.31 (a) of the Rules of the Institute of Chartered Accountants of New Zealand, the disciplinary tribunal ordered that the name of **Leon Paul Hendren** be removed from the Institute's Register of Members.
- (b) Pursuant to Rule 21.33 of the Rules of the Institute of Chartered Accountants of New Zealand, the disciplinary tribunal ordered that **Leon Paul Hendren** pay to the institute the sum of \$17,196.85 (inclusive of GST) in respect of the costs and expenses of the hearing before the disciplinary tribunal and the investigation by the professional conduct committee.
- (c) Pursuant to Rule 21.52 (b) of the Rules of the Institute of Chartered Accountants of New Zealand, the disciplinary tribunal ordered that the briefs of evidence and the financial details of the complainants be suppressed.

In accordance with Rule 21.35 of the Rules of the Institute of Chartered Accountants of New Zealand, the disciplinary tribunal directed that the decision of the tribunal be published in the *Chartered Accountants Journal*, the *New Zealand Gazette* and the *Christchurch Press* with mention of the member's name and locality.

### Right of Appeal

Pursuant to Rule 21.41 of the Rules of the Institute of Chartered Accountants of New Zealand which were in force at the time of the original notice of complaint, the member may, not later than 14 days after the notification of this tribunal to the member of the exercise of its powers, appeal in writing to the appeals council of the institute against the decision.

#### Notice

**1. Title and commencement**—(1) This notice may be cited as the Fisheries (Declaration of Koukourārata Mātaitai Reserve Bylaws) Notice 2006.

(2) This notice shall come into effect 28 days after the date of its notification in the *New Zealand Gazette*.

**2. Interpretation**—In this notice:

- The term “cockle” means the mollusc *Austrovenus stutchburyi* (formerly *Chione stutchburyi*).
- Terms have, unless the context otherwise requires, the same meaning as defined in the Fisheries (South Island Customary Fishing) Regulations 1999.

**3. Approval of bylaws for the Koukourārata Mātaitai Reserve**—The Minister of Fisheries hereby approves the following bylaws for the Koukourārata Mātaitai Reserve:

- Except as provided in subclause (b) below, the taking or possession of cockles from within the Koukourārata Mātaitai Reserve is prohibited.
- On any Saturday or Sunday during the month of September, a person may take or possess cockles from within the Koukourārata Mātaitai Reserve provided that:
  - prior to the taking or possession, the person has obtained and completed a cockle catch reporting

form available from the Te Rūnanga o Koukourārata office;

- (ii) no person shall in any one day take or possess more than 12 cockles from the Koukourārata Mātaitai Reserve; and
- (iii) no person shall take cockles by any method other than hand-gathering from the Koukourārata Mātaitai Reserve.

**4. Fishing subject to these bylaws**—Under Regulations 25 (3) of the Fisheries (South Island Customary Fishing) Regulations 1999, all fishing within the Koukourārata Mātaitai Reserve is subject to these bylaws.

**5. Breach of bylaws is an offence**—Under Regulation 43 of the Fisheries (South Island Customary Fishing) Regulations 1999, a person commits an offence against those Regulations if the person breaches any of these bylaws.

**6. Revocation**—The Fisheries (Declaration of Koukourārata Mātaitai Reserve Bylaws) Notice 2001 (No. F201) published in the *New Zealand Gazette*, 27 September 2001, No. 132, page 3382, is hereby revoked.

### Foundation for Research, Science, and Technology Act 1990

#### Notice of Changes to Ministerial Scheme Under Section 8A of the Foundation for Research, Science, and Technology Act 1990—the New Economy Research Fund Scheme

*Direction to:* The Foundation for Research, Science and Technology (“the foundation”).

Under section 8A of the Foundation for Research, Science, and Technology Act 1990, the foundation is directed to allocate funds in accordance with the New Economy Research Fund Scheme (“the scheme”) specified in this notice.

This direction revokes and replaces the direction, establishing the scheme, issued to the Foundation for Research, Science and Technology by the Minister of Research, Science and Technology, on the 1st day of November 1999, and published in *New Zealand Gazette*, 18 November 1999, No. 173, page 4102.

Allocation of funds under the scheme must be consistent with the direction issued to the foundation under section 103 of the Crown Entities Act 2004, which came into effect on the 8th day of May 2006, and published in *New Zealand Gazette*, 18 May 2006, No. 47, page 1183, as that direction may be amended from time to time.

#### The New Economy Research Fund Scheme

##### *The Nature of the Scheme*

The New Economy Research Fund will facilitate research through supporting researcher-led innovation aimed at developing capability and knowledge in new areas or applications where industries are emerging or yet to emerge, in order to underpin new high-technology business opportunities.

The focus of the research should be on targeted basic research and human capital that will underpin new enterprises and new sectors.

The scheme is not restricted to any type of research provider.

Research providers must be able to demonstrate the capability to carry out the proposed research themselves.

#### *The Objectives of the Scheme*

The primary objective of the scheme is to underpin new or emerging knowledge-based enterprises in New Zealand through:

- supporting investigator-initiated basic research that has the potential to create the advanced technological platforms that will underpin new and emerging industries;
- building a critical mass of research capability and new knowledge in emerging science and technology areas;
- developing advanced human capital and skills that draw from rapidly advancing international science and technology; and
- developing new areas of knowledge to a point where they may be further developed, sustained and/or exploited through other public or private investments.

#### *Principles for Determining Research Support*

The scheme will support research proposals that:

- meet international standards of excellence;
- seek to build new areas of knowledge and research groupings in areas extending beyond existing industry boundaries;
- build human capital in advanced science and technology that may underpin the emergence of new industries;
- are initiated as a basic research concept or idea, and develop towards a research-led commercial opportunity; and
- involve research based in New Zealand, but which may include appropriate international collaboration to maximise the benefit to New Zealand.

It is recognised and accepted that the research supported by the scheme may generate uncertain or unpredictable results.

#### **Funding Estimate**

The amount of funds available for the scheme is estimated at \$61.586 million. Actual funding will be published in the annual *Estimates of Appropriation*.

#### **Timing Estimate**

It is estimated that the scheme will operate for a minimum of five years from the date of this notice.

#### **Monitoring**

The foundation’s management of the scheme will be monitored by the Ministry of Research, Science and Technology.

Pursuant to section 11 (1) of the Health Practitioners Competence Assurance Act 2003 ("the Act"), the board specifies two scopes of practice as follows:

- A. MEDICAL LABORATORY SCIENTIST
- B. MEDICAL LABORATORY TECHNICIAN



**Qualifications Prescribed for Registration in a Scope of Practice****A. MEDICAL LABORATORY SCIENTIST**

Pursuant to section 12 of the Act, the qualifications required for registration as a medical laboratory scientist shall be one of the following:

1. A degree in medical laboratory science from a New Zealand university accredited by the board.
2. A post-graduate qualification, approved by the board in each case, combined with relevant and specialised medical laboratory experience that, in the opinion of the board, is sufficient for registration as a medical laboratory scientist.
3. Certification in medical laboratory science by an authority outside New Zealand approved by the board, combined with relevant and specialised medical laboratory experience that, in the opinion of the board, is sufficient for registration as a medical laboratory scientist.
4. A course of training, examinations and post-qualification medical laboratory experience that, in the opinion of the board, is substantially equivalent to the course of training for the New Zealand BMLSC degree.

**B. MEDICAL LABORATORY TECHNICIAN**

Pursuant to section 12 of the Act, the qualifications required for registration as a medical laboratory technician shall be one of the following:

1. Qualified Medical Laboratory Technician (QMLT) certificate or Qualified Technical Assistant (QTA) certificate or Qualified Phlebotomy Technician (QPT) certificate issued by the New Zealand Institute of Medical Laboratory Science.
2. A bachelors degree in a field of science awarded by a New Zealand university, approved in each case by the board, combined with a minimum of 12 months' relevant full-time (or equivalent) medical laboratory experience that, in the opinion of the board, is sufficient for registration as a medical laboratory technician.
3. A National Diploma in Science, Level Six, or equivalent qualification, with a minimum of 12 months' relevant full-time (or equivalent) medical laboratory experience that, in the opinion of the board, is sufficient for registration as a medical laboratory technician.
4. A course of training and an examination or examinations combined with relevant medical laboratory experience that, in the opinion of the board, is sufficient for registration as a medical laboratory technician.
