- (e) “area/rohe moana” means an area described by a line beginning on the coastline three kilometres north-east of the mouth of the Pahaoa River (41°23.1'S 175°45.2'E), then due south to a point

on the South Island fisheries waters boundary (42°18.9'S 175°45.2'E), then generally north-west following the South Island fisheries waters boundary to a point (41°39.0'S 174°58.0'E), then generally north to a point on the coastline at Windy Point (41°24.0'S 174°59.2'E), then generally east along the coastline to the point of commencement. The geographical co-ordinates named are in terms of the WGS84 datum;

- (f) "South Island fisheries waters" has the same meaning as defined in the Fisheries (South Island Customary Fishing) Regulations 1999.

3. Nomination of Kaitiaki—Ngāti Hinewaka me ona Kārangaranga has nominated Gray Carter, Tom Hemi, June Robinson, Paul Southey, Whakatere Terrence Te Maari, Whare Gray Te Maari, Haami Te Whaiti and Ross Ward as the Kaitiaki for managing customary food-gathering within the area/rohe moana.

4. Appointment of Kaitiaki—On 14 September 2006, the Associate Minister of Fisheries (acting pursuant to a delegated authority) confirmed, under Regulation 9 (1) of the Fisheries (Kaimoana Customary Fishing) Regulations

1998, the appointment of Gray Carter, Tom Hemi, June Robinson, Paul Southey, Whakatere Terrence Te Maari, Whare Gray Te Maari, Haami Te Whaiti and Ross Ward as the Kaitiaki for managing customary food-gathering within the area/rohe moana.

1. Title and commencement—(1) This notice may be cited as the Public Trust Common Fund Interest Rates Notice 5 October 2006.

(2) The determinations and revocation notified in this notice take effect from and including 28 September 2006.

2. Interpretation—(1) Unless the context otherwise requires:

“agency deposit” means a deposit (not being an investment deposit) held as agent or attorney;

“call deposit” means a deposit (not being an agency deposit, an investment deposit, a protection deposit, a special deposit or a trust deposit) held in the ordinary course of administration, and determined by Public Trust to be held at call;

“deposit” means a sum of money held by Public Trust belonging to any estate, which money for the time being forms part of the Common Fund;

“investment deposit” means a deposit held at call or otherwise as an investment under section 51 of the Act;

“protection deposit” means a deposit, held at call, of tuition, boarding, accommodation or other fees by or on behalf of a student enrolled at a private training establishment within the meaning of Part 18 of the Education Act 1989;

“special deposit” means a deposit held other than at call on behalf of the Crown, or any local authority within the meaning of the Local Government Act 1974;

“trust deposit” means a deposit (not being an agency deposit, an investment deposit, a protection deposit or a special deposit) held on trust:

- (i) for persons not of full age or capacity; or
- (ii) for beneficiaries not entitled to payment at call; or
- (iii) otherwise than at call.

(2) Expressions defined in the Act have the same meaning in this notice as they do in the Act.

3. Rates of Common Fund interest—(1) The rate of Common Fund interest on deposits (other than investment deposits repayable at the end of fixed term or protection deposits) shall be that specified in Schedule 1 for the appropriate type of deposits.

(2) The rate of Common Fund interest on each protection deposit associated with a particular private training establishment shall be that specified in Schedule 2 for the appropriate dollar range of the total of those deposits.

(3) The rate of Common Fund interest payable on investment deposits repayable at the end of a fixed term shall be that specified in Schedule 3 for the appropriate interest payment frequency, term and dollar range.

(4) Despite subparagraph (1), the rate of Common Fund interest payable on deposits made pursuant to an enactment shall be the rate (if any) specified in the enactment.

(5) Despite subparagraphs (1), (2) and (3), in particular cases or classes of case, Public Trust and the depositor may agree on a rate of interest payable on investment deposits, protection deposits or special deposits that is different from the rate specified in Schedules 1, 2, or 3 and the agreed rate then applies.

4. Revocation of notice and transitional provisions—

(1) The Public Trust Common Fund Interest Rates Notice 10 August 2006 is revoked.

(2) The rates of interest specified in Schedules 1 and 2 to this notice do not apply to any period that ends with 27 September 2006 but otherwise operate as from 28 September 2006.

Electricity Act 1992

Notice of Making of Electricity Governance Amendment Rules (No. 40) 2006 and Notice of Reasons for Decision

1. Pursuant to section 172I of the Electricity Act 1992 ("Act"), I notify the amendment of the Electricity Governance Rules 2003 ("Rules") under section 172H of the Act.

2. The empowering provision for the Electricity Governance Regulations, in relation to which the amendment to the Rules is made, is section 172D (1) (3) of the Act.

3. The existing procurement plan in Schedule C5 of Part C of the Rules will be replaced in its entirety with a new Schedule C5. The key changes from the existing Schedule C5 are:

- (a) an increase in the system operator's standard charge-out rates for administrative costs relating to procurement (clause 45);
- (b) new clauses to be included in any new long-term contract for over-frequency reserve, voltage support or black start (clauses 75 to 77):
 - (i) the system operator can cancel a contract by giving the service provider one month's notice if, in the system operator's reasonable opinion, the number or duration of maintenance outages of equipment used to provide or monitor the ancillary service is such that it substantially detrimentally affects the service provider's ability to provide or monitor the ancillary service; and
 - (ii) a formula for annual adjustment of the availability or event fees is to be agreed between the system operator and the ancillary services agent;
- (c) an updated commentary by the system operator on the competitive cost pressures and degree of market innovation involved in ancillary service procurement for the plan year (clauses 81 to 83);
- (d) clarification of the response rate required of generating units to provide frequency keeping ancillary service (clause 90);
- (e) amendment of existing provisions to cancel an existing offer or submit a new or revised offer later than two hours prior to the beginning of a trading period:
 - (i) by extending the existing provision to situations where the system operator has issued a formal notice (clause 113);
 - (ii) by requiring a service provider to report all cancellations or submissions that have been made later than two hours prior to the beginning of the trading period, to the system operator in writing with an explanation for each (clause 114);
 - (iii) by requiring a service provider to prepare a written monthly report of all such cancellation and submissions by the 20th of the month following the month being reported (clause 114); and
 - (iv) by requiring the system operator to include details of any late cancellation reported to it

in the system operator's report to the Board (clause 84);

- (f) new clauses that allow the term of an ancillary service procurement contract for frequency keeping or instantaneous reserve to be shorter or longer than the term of the procurement plan (clauses 115, 140);
 - (g) amendment of existing clauses to increase the specificity of fast instantaneous reserve (FIR) and the calculation of instantaneous reserve delivered in an under-frequency event by interruptible load, including an allowance for "load pickup" (clauses 125 to 128);
 - (h) a new clause requiring data on the response of instantaneous reserve to be measured, recorded, and provided by generating units for thermal generating stations and hydro stations that provide a combination of tail water depressed and partly loaded spinning reserve, and by station for other hydro generating stations (clause 130);
 - (i) new clauses which explain the system operator will continue to procure over-frequency reserve and black start under existing long-term contracts during the term of this procurement plan unless they are terminated (clauses 157, 198); and
 - (j) amendment of an existing requirement for a black start service provider to progressively energise the grid from network busbars, to a requirement that it provides generation output that supports the initial charging of transmission circuits and assets, and the progressive energising of the grid at network busbars (clauses 188.3, 188.4).
4. Pursuant to section 172Z (4) of the Act, the reasons for my decision to amend the Rules are that:
- (a) the new Schedule C5 improves the processes by which ancillary services requirements are specified, assessed and procured, while maintaining an appropriate balance between flexibility and certainty;
 - (b) the new Schedule C5 improves the transparency and clarity of the procurement plan; and
 - (c) the new procurement plan complies with the requirement in the Rules to review the procurement plan annually.

5. These rules come into force on **1 December 2006**.

STANDARD 3.3.1

FOOD SAFETY PROGRAMS FOR FOOD SERVICE TO VULNERABLE PERSONS

(Australia only)

Purpose and commentary

This Standard requires food businesses that process food for service to vulnerable persons to implement a documented and audited food safety program.

Food businesses that process or serve potentially hazardous food for hospital patients, aged care recipients, children in child care centres and vulnerable people receiving other services will generally fall within the requirements of this Standard, provided the food is intended for six or more vulnerable persons. This Standard also applies to delivered meals organisations that process potentially hazardous meals intended for six or more vulnerable persons.

Table of Provisions

- 3 Food safety programs

Clauses

1 Application

(1) This Standard applies to food businesses that engage in one of the activities listed and described in the Table to this subclause.

Table to subclause 1(1)

Activity 1	Process or serve potentially hazardous food within a facility listed and defined in the Schedule to six or more vulnerable persons at any given time
Activity 2	The principal activity is processing food into ready to eat food for service in a facility listed and defined in the Schedule and the processed food – <ul style="list-style-type: none"> (a) is for service to six or more vulnerable persons at any given time; and (b) includes ready to eat potentially hazardous food.
Activity 3	The principal activity is processing food into ready to eat food for delivery by a delivered meal organisation and the processed food – <ul style="list-style-type: none"> (a) is for service to six or more vulnerable persons at any given time; and (b) includes ready to eat potentially hazardous food.

Editorial note:

'Process' in relation to food is defined in Standard 3.2.2 as an activity conducted to prepare food for sale including chopping, cooking, drying, fermenting, heating, pasteurising, thawing and washing, or a combination of these activities.

A number of the definitions of the facilities listed in the Schedule are adapted from the National Health Data Dictionary, version 12. This Dictionary contains core definitions endorsed by the Australian Health Ministers Advisory Council as the authoritative source of national standard definitions for use in clinical care delivery.

- (2) This Standard also applies to delivered meals organisations that –
- (a) are food businesses; and
 - (b) process food for service to six or more vulnerable persons at any given time, and the food served is ready to eat food which includes ready to eat potentially hazardous food.

Editorial note:

'Potentially hazardous food' is defined in Standard 3.2.2 as food that has to be kept at certain temperatures to minimise the growth of any pathogenic micro-organisms that may be present in the food or to prevent the formation of toxins in the food.

- (3) This Standard does not apply to –
- (a) food businesses that only serve milk or soy milk as, or in, a beverage; or
 - (b) delivered meals organisations that only deliver food.
- (4) Subclause 1(2) of Standard 1.1.1 does not apply to this Standard.

- (2) In this Standard –

milk includes flavoured and modified milk.

ready to eat in relation to food means food that is ready for consumption, but includes food that may be re-heated, portioned or garnished or food that undergoes similar finishing prior to service.

vulnerable person means a person who is in care in a facility listed in the Schedule or a client of a delivered meals organisation.

3 Food safety programs

- (1) A food business to which this Standard applies must comply with Standard 3.2.1.
- (2) Clause 6 of Standard 3.2.1 applies to a food business to which this Standard applies.

STANDARD 4.2.4

PRIMARY PRODUCTION AND PROCESSING STANDARD FOR DAIRY PRODUCTS

(Australia only)

Purpose and commentary

This Standard sets out a number of food safety requirements, including the implementation of documented food safety programs for dairy primary production, collection, transportation and processing. However, this Standard does not apply to retail sale activities. Chapter 3 of this Code covers retail sale activities.

- (1) Unless the contrary intention appears, the definitions in Chapters 2 and 3 of this Code apply to this Standard.
- (2) In this Standard –

Authority means the State, Territory or Commonwealth government agency or agencies having the legal authority to implement and enforce this Standard.

control measure means a measure that prevents, eliminates or reduces to an acceptable level, a food safety hazard.

dairy primary production means the production of milk or colostrum for further processing for human consumption and includes the keeping, grazing, feeding and milking of animals and the storage of milk on the premises at which the animals were milked.

dairy primary production business means a business, enterprise or activity that involves dairy primary production.

dairy processing includes the manufacture of dairy products.

dairy processing business means a business, enterprise or activity that involves dairy processing.

dairy products include –

- (a) milk; and
- (b) colostrum; and
- (c) liquid milk products; and
- (d) cream and thickened cream; and
- (e) butter, butter concentrate, buttermilk, concentrated buttermilk, dairy blend, ghee, and anhydrous milk fat (butter oil);
- (f) casein, caseinate, and cheese; and
- (g) whey, whey cream and concentrated whey cream; and
- (h) cultured milk and yoghurt; and
- (i) ice-cream and ice-cream mix; and
- (j) buttermilk powder, lactose powder, milk sugar, powdered milk, skim milk powder, whey powder, milk protein powder and other milk concentrates.

dairy transport business means a business, enterprise or activity involving the collection and transport of milk from the dairy primary production business to the processing business or the transport of bulk milk or dairy products between dairy processors.

inputs includes any feed, water and chemicals, including agricultural and veterinary chemicals, used in connection with the primary production of milk or colostrum.

2 Application

- (1) Subclause 1(2) of Standard 1.1.1 does not apply to this Standard.
- (2) This Standard does not apply in New Zealand.
- (3) This Standard does not apply to retail sale activities.

Division 2 – Dairy primary production requirements**3 Controlling food safety hazards**

A dairy primary production business must control its potential food safety hazards by implementing a documented food safety program.

4 Specific requirements

- (1) For clause 3, the control measures must manage the hazards arising from –
 - (a) inputs; and
 - (b) the design, construction, maintenance and operation of premises and equipment; and
 - (c) milking animals; and
 - (d) persons involved in milking; and
 - (e) milking practices.

- (2) For clause 3, the control measures must also –
- (a) include support programs that ensure that premises and equipment are clean and sanitary and that pests are controlled; and
 - (b) ensure that milk is cooled and stored at a temperature that prevents or reduces the growth of microbiological hazards in the milk; and
 - (c) ensure that milk for human consumption is only sourced from healthy animals.

5 Tracing

As part of the documented food safety program in clause 3, a dairy primary production business must have a system that enables the tracing of –

- (a) inputs; and
- (b) animals to be milked; and
- (c) the milk produced.

6 Skills and knowledge

A dairy primary production business must ensure that persons undertaking primary production activities have skills and knowledge of food safety and hygiene matters commensurate with their work activities.

Division 3 – Dairy collection and transportation

7 Controlling food safety hazards

A dairy transport business must control its potential food safety hazards by implementing a documented food safety program.

8 Specific requirements

For clause 7, the control measures must manage hazards arising from –

- (a) transport vehicles, equipment and containers used in the collection and transport of the milk or dairy product; and
- (b) persons engaged in the dairy transport business;

and must include a support program that ensures that the food contact surfaces of transport vehicles, and equipment and containers used in collecting and transporting of the dairy products are clean and sanitary.

9 Product tracing

As part of the documented food safety program in clause 7, a dairy transport business must have a system to identify the immediate supplier and immediate recipient of the dairy product.

10 Time and temperature controls

A dairy transport business must transport dairy products using time and temperature controls that prevent or reduce the growth of microbiological hazards in the product.

11 Skills and knowledge

A dairy transport business must ensure that persons undertaking milk or dairy product collection and transport activities have skills and knowledge of food safety and hygiene matters commensurate with their work activities.

Division 4 – Dairy processing

12 Application

To avoid doubt, Standards 3.2.2 and 3.2.3 apply to the processing of dairy products.

13 Controlling food safety hazards

A dairy processing business must control its potential food safety hazards by implementing a documented food safety program.

14 Product tracing

As part of the documented food safety program in clause 13, a dairy processing business must have a system to identify the immediate supplier of dairy products and ingredients and the immediate recipient of the dairy products.

15 Processing of milk and dairy products

- (1) Milk must be pasteurised by –
- (a) heating to a temperature of no less than 72°C and retaining at such temperature for no less than 15 seconds; or
 - (b) heating, using any other time and temperature combination of equivalent or greater lethal effect on any pathogenic micro-organisms in the milk; or
 - (c) using any other process that provides an equivalent or greater lethal effect on any pathogenic micro-organisms;
- unless an applicable law of a State or Territory otherwise expressly provides.

Editorial note:

For paragraph 15(1)(c), any other process used would need to be validated by the business and verified by the Authority. The provision concerning an applicable law of a State or Territory is a temporary one and will be reviewed by FSANZ under another proposal.

(2) Milk processed under paragraph 15(1)(a) must be cooled immediately in a way that ensures that the growth of microbiological hazards in the milk is prevented or reduced.

- (3) Dairy products, other than cheese and cheese products, must be processed using –
- (a) a heat treatment that uses a combination of time and temperature of equal or greater lethal effect on any pathogenic micro-organisms in the milk product achieved by paragraphs 15(1)(a) or 15(1)(b); or
 - (b) using any other process that provides an equivalent or greater lethal effect on any pathogenic micro-organisms.

Editorial note:

For paragraph 14(3)(b), any other process used would need to be validated by the business and verified by the Authority.

(4) Dairy products processed under paragraph 15(3)(a) must be cooled immediately in a way that ensures that the growth of microbiological hazards in the product is prevented or reduced.

(5) To avoid doubt, subclause 15(3) does not apply to the processing of dairy products that have been made using milk already processed in accordance with subclause 15(1).

Editorial note:

Dairy products may have a greater fat and/or solids content compared to milk and therefore require a greater time and temperature treatment to achieve an equivalent level of bacterial reduction. Information on equivalent heat treatments to pasteurisation for these products is provided in the 'Interpretive Guide' to this Standard.

16 Processing of dairy products to make cheese and cheese products

Milk or dairy products used to make cheese or cheese products must be processed –

- (a) in accordance with subclause 15(1); or
- (b) by being held at a temperature of no less than 62°C for a period of no less than 15 seconds, and the cheese or cheese product stored at a temperature of no less than 2°C for a period of 90 days from the date of processing; or
- (c) such that –
 - (i) the curd is heated to a temperature of no less than 48°C; and
 - (ii) the cheese or cheese product has a moisture content of less than 36%, after being stored at a temperature of no less than 10°C for a period of no less than 6 months from the date of processing; or
- (d) in accordance with clause 1 of Standard 4.2.4A.

Editorial note:

For dairy product distribution, refer to the requirements in Standards 3.2.2 and 3.2.3 on storage and transportation.
