#### Electricity Regulations (Prohibited Electrical Appliance – Multi Reverse Plug Adapter) Notice 2007

Pursuant to Regulation 102 of the Electricity Regulations 1997 ("the Regulations"), I, Sanjai Deepak Raj, Group Manager, Energy Safety Service, give the following notice.

**1. Title and commencement**—(1) This notice is the Electricity Regulations (Prohibited Electrical Appliance – Multi Reverse Plug Adapter) Notice 2007.

(2) This prohibition is to take effect on and from the date following the date of publication of this notice in the *New Zealand Gazette*.

**2. Prohibited equipment**—The manufacture, importation, sale, installation and use of the electrical appliance, being a "Multi Reverse Plug Adapter" as prescribed in this notice, is prohibited.

#### 3. Description—

- (a) The outlet device to which this notice applies is a product known as "Travel adaptor" and/or "Multi Reverse Plug Adapter" available from "The Warehouse" prior to 15 March 2007, although it may have been available elsewhere.
- (b) The packaging wording is "Multi Reverse Plug Adapter". The appliance is known to exist in overall grey and white colour. The product may exist with other colours and packaging.
- (c) The product has a three insulated pin plug portion with the following wording moulded into the plastic; "MAX.220V~MAX.10A MAX.2000W".
- (d) The product has a socket outlet portion, able to accept plugs from multiple countries, and has the following wording printed on the white plastic front face; "POWER ON SAFETY SHUTTER".
- (e) An orange light will illuminate on the front face if plugged into an energised socket outlet.

**4. Details of hazard**—The outlet device constitutes, or may constitute an electrical hazard, in that:

- (a) The user may receive an electric shock when an earth pin of a plug is inserted into the live active receptacle of the adapter.
- (b) The adaptor has an insufficient voltage rating for use in New Zealand and may present a hazard during normal use.

**5. Reasons for prohibition**—The outlet device described in this notice is a non-compliant electrical appliance under Regulation 76A of the Regulations in that:

- It is so constructed that:
  - (1)(b) It has inadequate protection against direct contact or indirect contact; and
  - (2)(c) It is not safe under both normal and abnormal conditions of use.

(2) The classes of authorised user listed in subclause (1) of this clause may use national student numbers only for one or more of the following purposes:

- Monitoring and ensuring student enrolment and attendance.
- Ensuring education providers and students receive appropriate resourcing.
- Statistical purposes.
- Research purposes.
- Ensuring that students' educational records are accurately maintained.

**4.** Use of national student numbers by schools—(1) Education providers that are registered schools as defined in section 2 of the Education Act 1989 are authorised to use national student numbers only for the following purposes:

- Ensuring that students' educational records are accurately maintained by:
  - administering the National Certificate of Educational Achievement.
  - participating in the pilot project for the e-asTTle assessment tool where the school has been selected for the pilot project.

#### **Fisheries Act 1996**

### Fisheries (Standards and Specifications) Notice 2007 (No. F400)

Pursuant to section 296P of the Fisheries Act 1996, I make the following notice.

Notice

**1. Title and commencement**—(1) This notice may be cited as the Fisheries (Standards and Specifications) Notice 2007.

(2) This notice shall come into effect on 1 April 2007.

**2.** Interpretation—In this notice, terms and expressions defined in the Fisheries Act 1996 have the same meanings as in that Act.

**3.** Nature of standards and specifications—(1) I have amended the previous standards and specifications issued under section 2960 of the Fisheries Act 1996.

(2) The standards and specifications relate to the performance or exercise of specified functions, duties and powers by an Approved Service Delivery Organisation (ASDO). A general indication of the nature of these standards and specifications is listed in clauses 4 and 5 below.

(3) The amendment to the standards and specifications will allow the ASDO to register a fishing vessel for a period not exceeding five years and issue the appropriate certificate of registration in the approved form under section 103(3) of the Fisheries Act 1996.

**4. Business standards and specifications**—These standards and specifications relate to the general operation and management of an ASDO in exercising any specified function, duty, or power including standards and specifications relating to:

- (a) ASDO operation.
- (b) performance record keeping and reporting to the Ministry of Fisheries.
- (c) relationship between the Minister of Fisheries and the ASDO, including dispute resolution.
- (d) development and use of approved forms.
- (e) information management and system requirements.
- (f) the technical operating standards for exchange of electronic data and information from an ASDO (including data exchange dictionaries).
- (g) supply of information to the Ministry of Fisheries to assist with requests made under the Official Information Act 1982.

**5.** Service standards and specifications—These standards and specifications relate to the operation and management of specific registry services by an ASDO including standards and specifications relating to:

- (a) revoking and amending approvals for licences, approvals, authorities, permissions or decisions or a registration where false or misleading information has been supplied.
- (b) monitoring and recording fishers' compliance with various reporting and record-keeping requirements.
- (c) client registration.
- (d) monitoring foreign ownership and quota aggregation provisions.
- (e) maintaining and operating registers relating to quota, annual catch entitlements (ACE), registered fishing vessels, fishing permits and the transitional register of quota and forward trades.
- (f) recording decisions regarding quota allocation on the quota and annual catch entitlement registers.
- (g) processing transfers of quota and ACE and calculating and comparing ACE with reported catch.
- (h) processing applications for caveats and mortgages.
- (i) recording decisions made by the Ministry of Fisheries on applications for fishing permits on the permit register.
- (j) registering fishing vessels except for the granting of consent to register foreign owned or operated fishing vessels or fish carriers.

- (k) processing and licensing licensed fish receiver applications.
- (1) receiving and processing of monthly harvesting returns, licensed fish receiver (LFR) returns, annual inventory returns from an LFR and annual audit reports from an LFR.

- "special deposit" means a deposit held other than at call on behalf of the Crown, or any local authority within the meaning of the Local Government Act 1974;
- "trust deposit" means a deposit (not being an agency deposit, an investment deposit, a protection deposit or a special deposit) held on trust:
  - (i) for persons not of full age or capacity; or
  - (ii) for beneficiaries not entitled to payment at call; or
- (iii) otherwise than at call.

(2) Expressions defined in the Act have the same meaning in this notice as they do in the Act.

**3. Rates of Common Fund interest**—(1) The rate of Common Fund interest on deposits (other than investment deposits repayable at the end of fixed term or protection deposits) shall be that specified in Schedule 1 for the appropriate type of deposits.

(2) The rate of Common Fund interest on each protection deposit associated with a particular private training establishment shall be that specified in Schedule 2 for the appropriate dollar range of the total of those deposits.

(3) The rate of Common Fund interest payable on investment deposits repayable at the end of a fixed term shall be that specified in Schedule 3 for the appropriate interest payment frequency, term and dollar range.

(4) Despite subparagraph (1), the rate of Common Fund interest payable on deposits made pursuant to an enactment shall be the rate (if any) specified in the enactment.

(5) Despite subparagraphs (1), (2) and (3), in particular cases or classes of case, Public Trust and the depositor may agree on a rate of interest payable on investment deposits, protection deposits or special deposits that is different from the rate specified in Schedules 1, 2, or 3 and the agreed rate then applies.

**4.** Revocation of notice and transitional provisions— (1) The Public Trust Common Fund Interest Rates Notice 22 March 2007 is revoked.

(2) The rates of interest specified in Schedules 1 and 2 to this notice do not apply to any period that ends with 21 March 2007 but otherwise operate as from 22 March 2007.

(3) The rates of interest specified in Schedule 3 to this notice:

- (i) do not apply to investment deposits repayable at the end of a fixed term that commenced prior to 22 March 2007; but
- (ii) do apply to investment deposits repayable at the end of a fixed term that commenced on or after 22 March 2007.

# **Requirements and Exemptions for Profiles** (Investment Plans) for 2008–2010 for Tertiary Education Organisations

Pursuant to sections 159x and 159y of the Education Act 1989, the Tertiary Education Commission (TEC) gives the following notice.

### Notice

**1.** This notice may be cited as the Requirements and Exemptions for Profiles (Investment Plans) for 2008–2010 for Tertiary Education Organisations Notice 2007.

2. This notice applies from the date of its publication.

### Introduction

**3.** From 2008, in the interests of streamlining the funding process and reducing compliance costs for tertiary education organisations, charters and profiles will be merged into one document called an Investment Plan ("Plan").

**4.** To access funding from the TEC for 2008 and onwards, all organisations, other than those exempted by this notice, are required to have an approved Plan in place by 31 December 2007 that covers the three-year period from 2008 to 2010.

**5.** Plans will be summary-level documents, subject to ongoing dialogue and annual review. The scale of the Plans will vary, depending on the size and complexity of the organisation.

**6.** The TEC retains the right to revisit and vary any funding decision it makes, or funding condition it develops, pursuant to any relevant and applicable funding determination under section 159ZA of the Act.

# **Content Requirements for Plans**

7. Investment Plans submitted to the TEC will be the output of dialogue between each organisation and the TEC. The Plan will present a summary of the organisation's planning context, its three-year outlook and planned provision. The Plan will also set out the key performance indicators to be used for monitoring progress and achievement.

**8.** The Plan must include the following information (comprising four parts):

(i) *Plan Context* (this section establishes the framework for the rest of the Plan)

Outline of the particular factors the organisation has considered and intends to respond to in its Plan, including:

- Government priorities in the Tertiary Education Strategy 2007–12 (the TES/STEP – incorporating Statement of Tertiary Education Priorities 2008–10\*) including the distinctive contribution expected of the type of organisation;
- Needs and priorities of stakeholders (including students);
- Areas for organisational capability development (including those for the delivery of quality education and research).

The organisation's role within the tertiary education system (its special character) including:

- Brief statements on the organisation's core purpose and local, regional, industry or national fit, including any shifts required to achieve these.
- (ii) Three-year Outlook

Planned activity for the three-year period to address the factors identified in the *Plan Context* including:

- Outcomes the organisation intends to achieve;
- Initiatives, including capability development, that will be undertaken to achieve those outcomes;

and any other key changes in core activities.

## (iii) Summary of Activity

Information on delivery over the three-year period of the Plan including:

- Student Achievement Component (SAC) or Industry Training Fund student numbers by National Qualification Award Level (1–10);
- Total TEC funding sought (including SAC by funding category\*\*, and TEO Component as appropriate for each type of organisation);
- Planned student numbers in more detail if requested by the TEC.
- (iv) Key Performance Indicators

Measures to be used in evaluating performance against the Plan, including:

• Outcome commitments for the key performance indicators\* in relation to STEP priorities, and the key shifts expected of each type of organisation in the TES/STEP;



# Other organisational outcome commitments for initiatives and changes in the *Three-year Outlook*.

# **Decision-Making Criteria**

**9.** In reaching a decision about what to approve within the Investment Plan, including what to fund and the period of funding, the TEC will consider the following in relation to each tertiary organisation\*\*\*:

- The organisation's planned alignment with the TES/STEP, including the distinctive contribution and key shifts expected of that type of organisation, and its contribution to the tertiary network of provision;
- Evidence of effective identification of stakeholder needs and priorities;
- The organisation's governance and management arrangements, and financial viability;
- Evidence of the organisation's capability in forecasting, planning and implementation;
- Past performance against organisational commitments (including quality and capability improvement commitments);
- Evidence of critical reflection on current performance;
- The allocation of Student Achievement Component, TEO Component and other Government funding available to the organisation;
- Whether the activities outlined in the Plan are appropriate and achievable;
- Whether any conditions or limits on funding are required, having regard to any relevant and applicable funding determinations issued by the Minister under section 159ZA of the Education Act.

## Exemptions

**10.** The following organisations are exempted from the requirement to prepare and submit a Plan in 2007 for funding in 2008:

- Organisations that the TEC is contracting only pilot initiatives and who otherwise receive no other funding from the TEC;
- Employers only receiving workplace literacy funding from the TEC;
- Government training establishments;
- Schools seeking or receiving tertiary funding;
- Rural Education Activities Programme providers (REAPs);
- Community education providers;
- Private training establishments (PTEs) that currently receive, or intend to apply for, less than \$2,000,000.00 in TEC funding.

## **Timeline and Process**

**11.** The TEC Investment Guidance to assist organisations in developing their Plans includes the process and Plan submission date. The Investment Guidance will be available on the TEC's website at www.tec.govt.nz in mid-April 2007.
