At a hearing of the disciplinary tribunal of the Institute of Chartered Accountants of New Zealand held in public on 29 March 2007, at which the member was in attendance and represented by counsel, **Michael Timothy Tolich**, a chartered accountant of Manukau City, admitted the following particulars (a), (b), (c) and (d) and pleaded guilty to the following charges (2) and (3) and was found guilty of the following charge (1).

Charges

THAT in terms of the Institute of Chartered Accountants of New Zealand Act 1996 and the Rules made thereunder, and in particular Rule 21.30, the member is guilty of:

- (1) misconduct in a professional capacity; and/or
- (2) conduct unbecoming an accountant; and/or
- (3) breaching the institute's Code of Ethics 1995.

Particulars

IN THAT:

Being a chartered accountant and in relation to a complaint, the member:

- (a) pleaded guilty in the Auckland District Court to nine counts of forgery and six counts of using a document with intent to defraud in relation to invoices and/or cheques and/or withdrawal slips amounting to a sum of \$190,000.00; and/or
- (b) breached EP13 and/or EP22 and/or EP29 of the Code of Ethics 1995, in that whilst performing his role as the chief financial officer of the A Trust, he forged nine invoices with a total value of \$115,000.00, then used the invoices to requisition nine cheques; and/or
- (c) breached EP13 and/or EP22 of the Code of Ethics 1995, in that whilst performing his role as the chief financial officer of the A Trust and trustee of the B Trust, he used three A Trust cheques and two B Trust cheques for kickback payments totalling \$65,000.00, to a party or parties associated with the C Trust in return for approval of grant applications made by A Trust and B Trust; and/or
- (d) breached EP13 and/or EP22 of the Code of Ethics 1995, in that whilst performing his role as trustee of the B Trust, he withdrew \$10,000.00 in cash from the B Trust and used this cash for a kickback payment to a party associated with the D Trust in return for approval of a grant application made by B Trust.

Reasons

Michael Timothy Tolich's actions have been immoral and illegal and he has admitted fraudulent acts. The tribunal noted that he did not have any personal reward and the difficult environment in which he was operating. The tribunal also noted that he was discharged without conviction and his illness. But these acts lie at the heart of the integrity of chartered accountants and the public's expectations of them involving as they do the management of other people's money. The tribunal found the member guilty of misconduct in a professional capacity; his actions are unacceptable for a member of the institute and reflect badly on the institute and its members.

Orders of the Tribunal

- (a) Pursuant to Rule 21.31(a) of the Rules of the Institute of Chartered Accountants of New Zealand, the disciplinary tribunal ordered that the name of **Michael Timothy Tolich** be removed from the institute's Register of Members.

Radiocommunications Regulations 2001

Radiocommunications (Radio Standards) Notice 2007

Pursuant to Regulation 32(1)(a), (b), (c), (d) and (j) of the Radiocommunications Regulations 2001, the Chief Executive, Ministry of Economic Development, hereby gives the following notice.

Notice

1. Title, commencement and purpose

(a) This notice is the Radiocommunications (Radio Standards) Notice 2007.

(b) This notice comes into force on 19 April 2007.

(c) This notice prescribes:

- (i) classes of radio transmitting products, being interfering equipment as defined in section 2(1) of the Radiocommunications Act 1989.
- (ii) the standards applicable to particular classes of products.
- (iii) the level of conformity applicable to a class of product.
- (iv) products that are exempt from the need to be the subject of a declaration of conformity.

2. Interpretation

(a) For the purposes of Table 1 of this notice:

“**ACMA Radiocommunications Standard**” means a standard made by the Australian Communications and Media Authority under subsection 162(1) of the Australian Radiocommunications Act 1992.

“**ARIB**” means a standard published by the Association of Radio Industries and Businesses in Japan.

“**AS/NZS**” means a joint Australian/New Zealand standard under the terms of the Active Co-operation Agreement between Standards Australia International Limited and Standards New Zealand.

“**CFR**” means the Code of Federal Regulations of the United States of America.

“**EN**” means a standard published by the European Committee for Electrotechnical Standardisation, commonly known as CENELEC.

“**ETS**” and “**ETS EN**” means a standard published by the European Telecommunications Standards Institute, commonly known as ETSI.

“**RFS**” means a standard or specification published by the Chief Executive of the Ministry of Economic Development.

(b) Other words and expressions contained in this notice that are defined in the Act, Regulations and notices made under the Regulations, have the meanings so defined.

3. Scope

- (a) Except for a radio transmitter operating in conformity with a spectrum licence granted under section 48(1) of the Act, every product that is a radio transmitter is subject to the provisions of this notice and may only be used pursuant to and in conformity with:
- (i) a general user radio licence granted by the chief executive under the Regulations.
 - (ii) a general user spectrum licence granted by the chief executive under section 55A of the Act.
 - (iii) a radio licence granted by the chief executive under the Regulations.
 - (iv) an exemption from the requirement for a radio licence granted by the chief executive under the Regulations.
- (b) The frequency, frequencies and power of a radio transmitter product to which subsection (a) applies must be in conformity with a licence, or exemption from the requirement for a licence, irrespective of any frequency, or frequencies, or transmitter power otherwise specified in an applicable standard prescribed in Table 1.
- (c) If a product fits any of the following descriptions, the product is exempt from the requirement to be the subject of a declaration of conformity and to be labelled. The products are:
- (i) short range device (SRD) radio transmitters installed in vehicles at the time of manufacture.
 - (ii) military radio transmitters of the New Zealand Defence Force.
 - (iii) military radio transmitters of the defence force of another country operating in co-operation with the New Zealand Defence Force.

4. Applicable standards

- (a) For the purposes of Regulation 32(1)(a), (b), (c) and (d), the applicable standards and levels of conformity apply to specified classes of product as provided in the tables to this notice.
- (b) Unless expressly stated to the contrary in this notice:
- (i) an amendment or modification to an applicable standard is effective from the date specified by the authority issuing the amendment or modification.
 - (ii) a product that is first supplied one year or more after the effective date of an amendment or modification to an applicable standard, must conform to that amended or modified applicable standard.
- (c) If an applicable standard is an ACMA Radiocommunications Standard, assessment of conformity of a product to that standard, including the electromagnetic radiation (EMR) performance of the product, must be in accordance with the requirements of:
- (i) relevant notices issued by the Australian Communications and Media Authority under section 182 of the Australian Radiocommunications Act 1992; and
 - (ii) applicable standards made by the Australian Communications and Media Authority under subsection 162(1) of the Australian Radiocommunications Act 1992.

5. Conformity requirements

- (a) If a product is in a class to which Table 1 of this notice applies, the product must conform to the requirements of an applicable standard specified in Table 1.
- (b) If a product is not in a class to which a standard prescribed in Table 1 of this notice applies, the product must, as a minimum, comply with the requirements of Table 2 of this Schedule.
- (c) Any product must, as a minimum, comply with the requirements of Table 2 of this Schedule.
- (d) The supplier of a product to which subsection (a) applies must comply with the level of conformity requirements applying to that product as prescribed in the Radiocommunications (Compliance) Notice 2004, published in a Supplement to the *New Zealand Gazette*, 12 December 2003, No. 170, page 4714, or a notice in replacement thereof.

6. Revocation

The Radiocommunications (Radio Standards) Notice 2005 No. 2, made pursuant to Regulation 32 of the Radiocommunications Regulations 2001 and published in the *New Zealand Gazette*, 13 October 2005, No. 175, page 4397, is hereby revoked on 19 April 2007.

7. Transitional provision

Notwithstanding the revocation of the notice set out in clause 6, every product that is compliant with the requirements of that notice on the commencement date of this notice is deemed to be compliant with the requirements of this notice.

(2) Expressions defined in the Act have the same meaning in this notice as they do in the Act.

3. Rates of Common Fund interest—(1) The rate of Common Fund interest on deposits (other than investment deposits repayable at the end of fixed term or protection deposits) shall be that specified in Schedule 1 for the appropriate type of deposits.

(2) The rate of Common Fund interest on each protection deposit associated with a particular private training establishment shall be that specified in Schedule 2 for the appropriate dollar range of the total of those deposits.

- (c) addition of specific provisions in that new appendix for the treatment of existing assets which are non-compliant;
- (d) addition of new definitions of the terms, "back up protection system", "circuit breaker failure protection system" and "main protection system" in Part A of the Rules (as used in the amendments); and
- (e) a minor typographical change to the defined term, "circuit breaker", to remove the hyphen between the words "circuit" and "breaker" wherever it is used in the Rules.

4. Pursuant to section 172Z(4) of the Act, the reasons for my decision to amend the Rules are to:

- (a) clarify the existing obligations in Technical Code A of Schedule C3 of Part C relating to duplicate protection; and
- (b) extend the existing duplicate protection obligations to future grid interface voltages above 220 kV a.c.

5. These rules come into force on 31 May 2007.
