establishment within the meaning of Part 18 of the Education Act 1989;

“special deposit” means a deposit held other than at call on behalf of the Crown, or any local authority within the meaning of the Local Government Act 1974;

“trust deposit” means a deposit (not being an agency deposit, an investment deposit, a protection deposit or a special deposit) held on trust:

- (i) for persons not of full age or capacity; or
- (ii) for beneficiaries not entitled to payment at call; or
- (iii) otherwise than at call.

(2) Expressions defined in the Act have the same meaning in this notice as they do in the Act.

**3. Rates of Common Fund interest—**(1) The rate of Common Fund interest on deposits (other than investment deposits repayable at the end of fixed term or protection deposits) shall be that specified in Schedule 1 for the appropriate type of deposits.

(2) The rate of Common Fund interest on each protection deposit associated with a particular private training establishment shall be that specified in Schedule 2 for the appropriate dollar range of the total of those deposits.

(3) The rate of Common Fund interest payable on investment deposits repayable at the end of a fixed term shall be that specified in Schedule 3 for the appropriate interest payment frequency, term and dollar range.

(4) Despite subparagraph (1), the rate of Common Fund interest payable on deposits made pursuant to an enactment shall be the rate (if any) specified in the enactment.

(5) Despite subparagraphs (1), (2) and (3), in particular cases or classes of case, Public Trust and the depositor may agree on a rate of interest payable on investment deposits, protection deposits or special deposits that is different from the rate specified in Schedules 1, 2, or 3 and the agreed rate then applies.

**4. Revocation of notice and transitional provisions—**

(1) The Public Trust Common Fund Interest Rates Notice 26 April 2007 is revoked.

(2) The rates of interest specified in Schedules 1 and 2 to this notice do not apply to any period that ends with 25 April 2007 but otherwise operate as from 26 April 2007.

More widespread use of this information will facilitate better management of commercial positions for generators and retailers, and enable better analysis of wholesale prices.
5. These rules come into force on 1 June 2007.

#### Proposal for Minimum Energy Performance Standards for Set Top Boxes and External Power Supplies

Pursuant to section 36 of the Energy Efficiency and Conservation Act 2000, the Minister of Energy gives the following notice:

The Minister of Energy proposes to implement minimum energy performance standards (MEPS), effective from 1 April 2008, for the following products:

1. Set top boxes or digital television decoders.
2. External power supplies rated up to and including 250W/250VA.

The proposal is part of the equipment energy efficiency (E3) trans-Tasman work programme for 2005/07.

The work programme is a key part of implementing the National Energy Efficiency and Conservation Strategy in New Zealand.

For set top boxes, the cost benefit analysis addressing this proposal is now available for public comment on

[www.eeca.govt.nz](http://www.eeca.govt.nz)

As well as providing analysis of the costs and benefits of the proposal for both New Zealand and Australia, the report details the energy performance levels for set top boxes.

The test methods are covered in the standard AS/NZS 62087.

For external power supplies, the consultation regulatory impact statement (RIS) addressing the proposal is now available for public comment on

The RIS provides analysis of the costs and benefits of the proposal for both New Zealand and Australia.

A standard, AS/NZS 4665, has been published for test methods and energy performance of external power supplies.

If the proposals proceed, they will result in an amendment to the Energy Efficiency (Energy Using Products) Regulations 2002 ("the Regulations").

The proposal for set top boxes is to call up AS/NZS 62087.2, as an amendment to Schedule 1 of the Regulations, effective from 1 April 2008.

The proposal for external power supplies is to call up AS/NZS 4665, as an amendment to Schedule 1 of the Regulations, effective from 1 April 2008.

  - (iv) a person authorised in another jurisdiction by the competent authority of that jurisdiction to deal in futures contracts; or
  - (v) Her Majesty the Queen in right of New Zealand, a Crown entity named in the Crown Entities Act 2004, or a State enterprise named in the First or Second Schedule to the State-Owned Enterprises Act 1986 (each as amended from time to time); or
  - (vi) a person who is a statutory corporation or a registered bank; or
  - (vii) a person whose principal business is the investment of money or who, in the course of and for the purposes of their business, habitually invests money; or
  - (viii) a person who is a related body corporate of any of the persons mentioned in subparagraphs (i) to (vii) above; and
- (d) before dealing in any futures contract in respect of which the authorisation applies, Trafalgar Copley is satisfied on reasonable grounds that the wholesale client is contracting:
  - (i) as principal on its own account; or
  - (ii) on behalf of a related body corporate; or
  - (iii) as trustee of a trust or manager of a managed fund; and
- (e) Trafalgar Copley notifies the Commission of any material matter concerning Trafalgar Copley’s authorisation as a futures dealer, including any regulatory action taken concerning Trafalgar Copley, whether in New Zealand or overseas; and
- (f) Trafalgar Copley provides the Commission with a copy of Trafalgar Copley’s audited financial statements no later than three months after the end of each financial year for Trafalgar Copley.
