for 24 nautical miles to a point (37°10.3'S; 176°19.7'E), then south-easterly to a point (37°25.3'S; 176°40.7'E) then generally south-westerly for 24 nautical miles to the point of commencement. The geographical coordinates named are in terms of the WGS84 datum.

**3.
