    - (i) in the case of copies of financial statements or group financial statements for that period that are required to be delivered for registration under section 19 of the Act, the exemption is granted before those documents are required to be delivered for registration under that section; or
    - (ii) in any other case, the exemption is granted before the financial statements or group financial statements for that period are required to be completed; and
  - (b) subsequent accounting periods.
- **5. Interpretation**—In this notice, unless the context otherwise requires:

**Act** means the Financial Reporting Act 1993.

**exempt overseas company** means Coinstar Money Transfer Limited.

- **6. Exemptions for directors of exempt overseas companies**—(1) Every director of the exempt overseas company is exempted from the following provisions in respect of the exempt overseas company:
  - (a) Sections 10(1) and 11 of the Act to the extent that these sections require group financial statements to be prepared in accordance with New Zealand generally accepted accounting practice;
  - (b) section 13 of the Act to the extent that it requires group financial statements prepared in relation to the exempt overseas company to comply with section 14 of the Act; and
  - (c) section 19(3) of the Act to the extent that it requires copies of group financial statements of the exempt overseas company, together with a copy of the auditor's report on those statements, to be delivered to the Registrar for registration.

#### Statement of Reasons

This notice, which comes into force on its notification in the *New Zealand Gazette* and expires on 30 July 2012, exempts the directors of Coinstar Money Transfer Limited, a company that was incorporated in the United Kingdom, from various provisions of the Financial Reporting Act 1993 ("the Act").

The effect of the exemptions is to exempt Coinstar Money Transfer Limited from the requirements under the Act to prepare and deliver for registration group financial statements.

The basis for the exemption is that the company is exempt from the requirement to prepare group financial statements in its home jurisdiction because it is a subsidiary of a parent company which is required to prepare audited consolidated financial statements in the United Kingdom.

The principal differences in financial statements that will be provided by Coinstar Money Transfer Limited relying on the exemptions are:

- The directors of Coinstar Money Transfer Limited will prepare and register financial statements for the New Zealand business and stand-alone parent company financial statements; and
- the directors will not file group financial statements.

The Registrar considers that it is appropriate to grant the exemptions because:

- the Registrar has had regard to the financial reporting and audit requirements that must be complied with by Coinstar Money Transfer Limited in its home jurisdiction, under which it is not required to prepare group financial statements; and
- Coinstar Money Transfer Limited will still be required to file stand alone parent company financial statements and financial statements for the group's New Zealand business prepared in accordance with New Zealand generally accepted accounting practice as if the members of the group were companies formed and registered in New Zealand; and
- the Registrar is satisfied that the above financial statements provide sufficient information to avoid any detriment to members of the public who have dealings with Coinstar Money Transfer Limited; and
- the exemptions address the particular difficulties experienced by Coinstar Money Transfer Limited in complying with the Act. The exemptions are not existence.

### **Resource Management Act 1991**

### National Policy Statement on Electricity Transmission

ANAND SATYANAND, Governor-General ORDER IN COUNCIL

At Wellington this 10th day of March 2008

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL PRESIDED IN COUNCIL

Pursuant to section 52(2) of the Resource Management Act 1991, His Excellency the Governor-General, acting on the advice and with the consent of the Executive Council and on the recommendation of the Minister for the Environment (having satisfied the requirements of that Act), approves the following national policy statement.

#### PREAMBLE

This national policy statement sets out the objective and policies to enable the management of the effects of the electricity transmission network under the Resource Management Act 1991.

In accordance with section 55(2A)(a) of the Act, and within four years of approval of this national policy statement, local authorities are to notify and process under the First LexisNexis

Schedule to the Act a plan change or review to give effect as appropriate to the provisions of this national policy statement.

The efficient transmission of electricity on the national grid plays a vital role in the well-being of New Zealand, its people and the environment. Electricity transmission has special characteristics that create challenges for its management under the Act. These include:

- Transporting electricity efficiently over long distances requires support structures (towers or poles), conductors, wires and cables, and sub-stations and switching stations.
- These facilities can create environmental effects of a local, regional and national scale. Some of these effects can be significant.
- The transmission network is an extensive and linear system which makes it important that there are consistent policy and regulatory approaches by local authorities.
- Technical, operational and security requirements associated with the transmission network can limit the extent to which it is feasible to avoid or mitigate all adverse environmental effects.
- The operation, maintenance and future development of the transmission network can be significantly constrained by the adverse environmental impact of third party activities and development.
- The adverse environmental effects of the transmission network are often local while the benefits may be in a different locality and/or extend beyond the local to the regional and national making it important that those exercising powers and functions under the Act balance local, regional and national environmental effects (positive and negative).
- Ongoing investment in the transmission network and significant upgrades are expected to be required to meet the demand for electricity and to meet the Government's objective for a renewable energy future, therefore strategic planning to provide for transmission infrastructure is required.

The national policy statement is to be applied by decision-makers under the Act. The objective and policies are intended to guide decision-makers in drafting plan rules, in making decisions on the notification of the resource consents and in the determination of resource consent applications, and in considering notices of requirement for designations for transmission activities.

However, the national policy statement is not meant to be a substitute for, or prevail over, the Act's statutory purpose or the statutory tests already in existence. Further, the national policy statement is subject to Part 2 of the Act.

For decision-makers under the Act, the national policy statement is intended to be a relevant consideration to be weighed along with other considerations in achieving the sustainable management purpose of the Act.

This preamble may assist the interpretation of the national policy statement, where this is needed to resolve uncertainty.

### 1. TITLE

This national policy statement is the National Policy Statement on Electricity Transmission 2008.

### 2. COMMENCEMENT

This national policy statement comes into force on the 28th day after the date on which it is notified in the *New Zealand Gazette*.

#### 3. INTERPRETATION

In this national policy statement, unless the context otherwise requires:

**Act** means the Resource Management Act 1991.

**decision-makers** means all persons exercising functions and powers under the Act.

electricity transmission network, electricity transmission and transmission activities / assets / infrastructure / resources / system all mean part of the national grid of transmission lines and cables (aerial, underground and undersea, including the high-voltage direct current link), stations and sub-stations and other works used to connect grid injection points and grid exit points to convey electricity throughout the North and South Islands of New Zealand.

**national environmental standard** means a standard prescribed by regulations made under the Act.

**national grid** means the assets used or owned by Transpower NZ Limited.

sensitive activities includes schools, residential buildings and hospitals.

#### 4. MATTER OF NATIONAL SIGNIFICANCE

The matter of national significance to which this national policy statement applies is the need to operate, maintain, develop and upgrade the electricity transmission network.

#### 5. OBJECTIVE

To recognise the national significance of the electricity transmission network by facilitating the operation, maintenance and upgrade of the existing transmission network and the establishment of new transmission resources to meet the needs of present and future generations, while:

- managing the adverse environmental effects of the network; and
- managing the adverse effects of other activities on the network.

# 6. RECOGNITION OF THE NATIONAL BENEFITS OF TRANSMISSION

#### **POLICY 1**

In achieving the purpose of the Act, decision-makers must recognise and provide for the national, regional and local benefits of sustainable, secure and efficient electricity transmission. The benefits relevant to any particular project or development of the electricity transmission network may include:

- (i) maintained or improved security of supply of electricity; or
- (ii) efficient transfer of energy through a reduction of transmission losses; or
- (iii) the facilitation of the use and development of new electricity generation, including renewable generation which assists in the management of the effects of climate change; or
- (iv) enhanced supply of electricity through the removal of points of congestion.

The above list of benefits is not intended to be exhaustive and a particular policy, plan, project or development may have or recognise other benefits.

# 7. MANAGING THE ENVIRONMENTAL EFFECTS OF TRANSMISSION

### **POLICY 2**

In achieving the purpose of the Act, decision-makers must recognise and provide for the effective operation, maintenance, upgrading and development of the electricity transmission network.

#### **POLICY 3**

When considering measures to avoid, remedy or mitigate adverse environmental effects of transmission activities, decision-makers must consider the constraints imposed on LexisNexis

achieving those measures by the technical and operational requirements of the network.

#### POLICY 4

When considering the environmental effects of new transmission infrastructure or major upgrades of existing transmission infrastructure, decision-makers must have regard to the extent to which any adverse effects have been avoided, remedied or mitigated by the route, site and method selection.

#### POLICY 5

When considering the environmental effects of transmission activities associated with transmission assets, decision-makers must enable the reasonable operational, maintenance and minor upgrade requirements of established electricity transmission assets.

#### POLICY 6

Substantial upgrades of transmission infrastructure should be used as an opportunity to reduce existing adverse effects of transmission including such effects on sensitive activities where appropriate.

#### **POLICY 7**

Planning and development of the transmission system should minimise adverse effects on urban amenity and avoid adverse effects on town centres and areas of high recreational value or amenity and existing sensitive activities.

#### POLICY 8

In rural environments, planning and development of the transmission system should seek to avoid adverse effects on outstanding natural landscapes, areas of high natural character and areas of high recreation value and amenity and existing sensitive activities.

#### POLICY 9

Provisions dealing with electric and magnetic fields associated with the electricity transmission network must be based on the International Commission on Non-ioninsing Radiation Protection *Guidelines for limiting exposure to time varying electric magnetic fields (up to 300 GHz)* (Health Physics, 1998, 74(4): 494–522) and recommendations from the World Health Organisation monograph *Environment Health Criteria* (No. 328, June 2007) or revisions thereof and any applicable New Zealand standards or national environmental standards.

# 8. MANAGING THE ADVERSE EFFECTS OF THIRD PARTIES ON THE TRANSMISSION NETWORK

### **POLICY 10**

In achieving the purpose of the Act, decision-makers must to the extent reasonably possible manage activities to avoid reverse sensitivity effects on the electricity transmission network and to ensure that operation, maintenance, upgrading, and development of the electricity transmission network is not compromised.

### POLICY 11

Local authorities must consult with the operator of the national grid, to identify an appropriate buffer corridor within which it can be expected that sensitive activities will generally not be provided for in plans and/or given resource consent. To assist local authorities to identify these corridors, they may request the operator of the national grid to provide local authorities with its medium to long-term plans for the alteration or upgrading of each affected section of the national grid (so as to facilitate the long-term strategic planning of the grid).

### 9. MAPS

### **POLICY 12**

Territorial authorities must identify the electricity transmission network on their relevant planning maps whether or not the network is designated.

# 10. LONG-TERM STRATEGIC PLANNING FOR TRANSMISSION ASSETS

#### POLICY 13

Decision-makers must recognise that the designation process can facilitate long-term planning for the development, operation and maintenance of electricity transmission infrastructure.

#### **POLICY 14**

Regional councils must include objectives, policies and methods to facilitate long-term planning for investment in transmission infrastructure and its integration with land uses.

This note is not part of the national policy statement but is intended to indicate its general effect.

This national policy statement comes into force 28 days after the date of its notification in the New Zealand Gazette. It provides that electricity transmission is a matter of national significance under the Resource Management Act 1991 and prescribes an objective and policies to guide the making of resource management decisions.

The national policy statement requires local authorities to give effect to its provisions in plans made under the Resource Management Act 1991 by initiating a plan change or review within four years of its approval.

  - (ii) then perpendicular to the coastline out to the 12 nautical mile limit (40°47.5′S 176°34.1′E);
  - (iii) then south along the 12 nautical mile limit to a point (41°01.0'S 176°22.3'E);
  - (iv) then west towards the Whareama River at (41°01.0'S 176°06.5'E);
  - (v) and then north-east following the coastline to the point of commencement.

    - (i) at a point on the coastline at Paritu (38°57.0'S 177°54.2'E);



- (ii) then due east for 200 nautical miles to a point (38°57.0'S 177°25.0'W);
- (iii) then due south to a point  $(43^{\circ}15.0'S 177^{\circ}25.0'W)$ ;
- (iv) then  $45^{\circ}$  north-west to a point  $(39^{\circ}18.6'S 177^{\circ}45.0'E)$ ;
- (v) then due north to a point (39°13.3′S 177°44.9′E);
- (vi) then generally north-easterly to a point on the coastline at Waikokopu (39°04.4'S 177°49.6'E);
- (vii) then generally northerly along the mean high-water springs mark to the point of commencement.

- **3. Rates of Common Fund interest**—(1) The rate of Common Fund interest on deposits (other than investment deposits repayable at the end of fixed term or protection deposits) shall be that specified in Schedule 1 for the appropriate type of deposits.

### Preamble

The variations set forth in the Schedule below are variations to Standards in the *Australia New Zealand Food Standards Code* published by the National Health and Medical Research Council in the *Commonwealth of Australia Gazette*, No. P 27, on 27 August 1987, which have been varied from time to time.

These variations are published pursuant to section 23A of the Food Standards Australia New Zealand Act 1991.

#### Citation

These variations may be collectively known as the Australia New Zealand Food Standards Code – Amendment No. 97 – 2008.

#### Commencement

These variations commence on 13 March 2008, with the exception of Items [1] and [4] which commence on 27 September 2009.

#### **SCHEDULE**

#### [1] Standard 1.3.2 is varied by omitting the Purpose, substituting –

This Standard regulates the addition of vitamins and minerals to foods, and the claims which can be made about the vitamin and mineral content of foods. Standards contained elsewhere in this Code also regulate claims and the addition of vitamins and minerals to specific foods, such as the mandatory replacement of non-iodised salt with iodised salt in bread (New Zealand only) and the mandatory addition of thiamin and folic acid to wheat flour for making bread (Australia only) in Standard 2.1.1, the addition of vitamin D to table edible oil spreads and margarine in Standard 2.4.2, the addition of vitamins to formulated caffeinated beverages in Standard 2.6.4, the addition of vitamins and minerals to special purpose foods standardised in Part 2.9 and the addition of iodine to certain salt products in Standard 2.10.2.

This Standard defines a number of products composed of cereals and qualifies the use of the term "bread". It also requires the mandatory fortification of wheat flour for making bread with thiamin and folic acid (Australia only) and the mandatory replacement of non-iodised salt with iodised salt in bread (New Zealand only).

[4.2] inserting after clause 4 –

- 5 Mandatory addition of iodised salt to bread (New Zealand only)

Clause 5 will be reviewed when sufficient monitoring data are available to assess the impact of this mandatory requirement. Standard 2.10.2 sets out the compositional requirements for iodised salt.
