Fisheries Act 1996

Fisheries (Seabird Sustainability Measures—Bottom Longlines) Notice (No. 2) 2008 (No. F441)

Pursuant to section 11 of the Fisheries Act 1996, the Minister of Fisheries gives the following notice.

Notice

1. Title—This notice is the Fisheries (Seabird Sustainability Measures—Bottom Longlines) Notice (No. 2) 2008.

2. Commencement—This notice comes into force on 12 April 2008.

3. Interpretation—In this notice, unless the context otherwise requires:

“Act” means the Fisheries Act 1996;

“aerial extent” means the section of the streamer line backbone running from the vessel stern, to where the backbone of the streamer line enters the water;

“bottom longline” means a line to which 7 or more hooks (whether baited or not) are attached, and is sunk using weights;

“hauling” means the period from when line retrieval commences to when all of the hooks are onboard;

“nautical dawn” means the time at sunrise when the centre of the sun is at a depression angle of 12 degrees below the ideal horizon for the location of fishing;

“nautical dusk” means the time at sunset when the centre of the sun is at a depression angle of 12 degrees below the ideal horizon for the location of fishing;

“offal” means solid fish parts, including heads, guts, frames, tails, tentacles and fish trimmings, or parts thereof including minced parts; and

“set”, in relation to a bottom longline, means releasing the bottom longline into the water.

4. Streamer line required—A commercial fisher using bottom longlines as a method of fishing from a vessel 7 metres or greater in overall length must:

(a) carry a streamer line on board the vessel; and

(b) permit inspection of the streamer line at any reasonable time by a fisheries officer or an observer appointed under section 223(2) of the Act.

5. Use of streamer line required during setting of bottom longlines—A streamer line must be used on vessels 7 metres or greater in overall length during the setting of bottom longlines, in accordance with clause 6 of this notice.

6. Streamer line specifications—(1) For vessels over 20 metres in overall length, the streamer line must meet the following specifications:

- (a) The streamer line must be attached to the vessel so that when deployed the baits are protected by the streamer line, even in cross wind;
- (b) the streamer line must be a minimum of 150 metres in length;
- (c) the streamer line must achieve a minimum aerial extent of 50 metres;
- (d) streamers must be brightly coloured;
- (e) streamers must be spaced at a maximum of 5 metres apart, beginning not more than 5 metres from the stern of the vessel and extending along the full aerial extent of the line;
- (f) when deployed, each of the streamers must reach the sea surface in the absence of wind and swell. Streamer length will therefore vary depending on the height of their attachment point above the water; and
- (g) the streamer line must be suspended from a point on the vessel at least 5 metres above the water in the absence of swell.

(2) For vessels 7 metres–20 metres in overall length, the streamer line must meet the following specifications:

- (a) The streamer line must achieve a minimum aerial extent of 50 metres;
- (b) streamers must be brightly coloured;
- (c) streamers must be spaced at a maximum of 5 metres apart, beginning not more than 5 metres from the stern of the vessel and extending along the full aerial extent of the line;
- (d) when deployed, each of the streamers must reach the sea surface in the absence of wind and swell. Streamer length will therefore vary depending on the height of their attachment point above the water; and
- (e) the streamer line must be suspended from a point on the vessel at least 5 metres above the water in the absence of swell.

(3) The specifications in subclauses (1) and (2) do not apply to additional or secondary seabird scaring devices fishers may choose to use (such as a second tori or streamer line).

7. Restrictions on use of bottom longlines—No commercial fisher may set bottom longlines to take fish, aquatic life, or seaweed between the hours of 0.5 hours before nautical dawn and 0.5 hours after nautical dusk, unless line weighting is employed in accordance with clause 8 of this notice.

8. Line weighting—(1) For the purposes of clause 7, lines must be:

- (a) an integrated weighted line with a lead core of at least 50g/m; or
- (b) when externally weighted gear is used and the hook-bearing line is 3.5 millimetres or greater in diameter, every 60 metres of hook-bearing line must have at least 4 kilograms of metal weight or 5 kilograms of non-metal weight attached; or
- (c) when externally weighted gear is used and the hook-bearing line is less than 3.5 millimetres in diameter, every 60 metres of hook-bearing line must have at least 0.7 kilogram of weight attached.

(2) Regardless of the type of line weighting used under clause 8(1):

- (a) any rope or line used to attach weights to the hook-bearing line must not be longer than 20 metres; and
- (b) no more than 3 floats (up to 150 millimetres in diameter) may be attached to the hook-bearing line for every 60 metres of line, unless an additional 1 kilogram weight is added to the line per additional float; and
- (c) floats greater than 150 millimetres in diameter are not permitted to be attached to the hook bearing line.
- (d) When a separate rope or line is not used to attach a marker buoy to the hook-bearing line, and a marker buoy is attached directly, no hooks may be attached to the line within 30 metres on either side of the marker buoy.

9. Restriction of offal or fish discharge while setting and hauling bottom longlines—(1) No person may discharge offal or fish during setting of bottom longlines.

(2) Offal or fish may be discharged during the hauling of bottom longlines provided it is discharged from the side of the vessel that is opposite to the side on which the hauling station is located.

(3) Subclause (1) does not apply to:

- (a) fish that are legally undersize; or
- (b) fish that are listed on the Sixth Schedule of the Fisheries Act 1996 and that are likely to survive.

10. Revocation—The Fisheries (Seabird Sustainability Measures—Bottom Longlines) Notice 2008 (No. F430)* is revoked.

11. The Schedule—(1) The Schedule provides further guidelines on the design and deployment of streamer lines as seabird scaring devices.

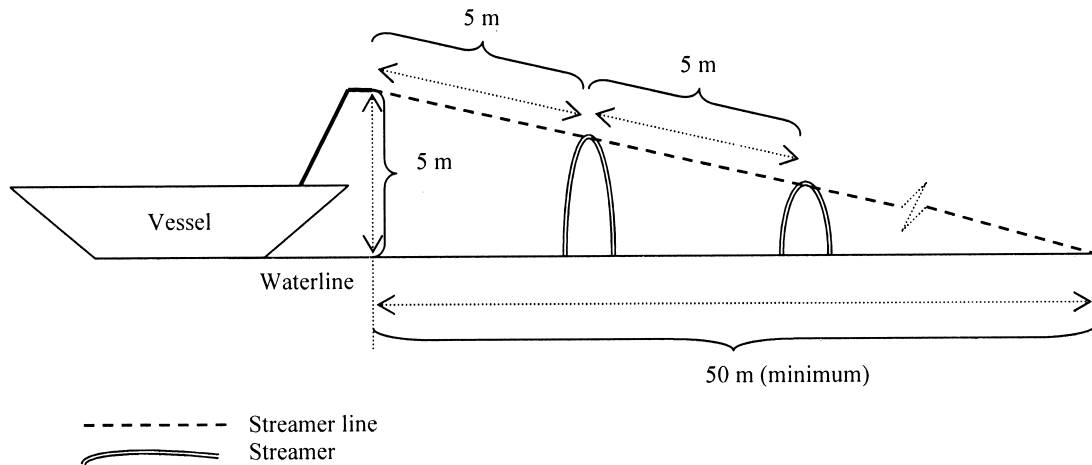
(2) The Schedule is not part of the specifications.

(3) If there is any inconsistency between the guidelines in the Schedule and the specifications, the specifications prevail.

- (i) The streamer line needs to protect baited hooks from seabirds. This means that the streamer line should be positioned in such a way that streamers are flapping in an unpredictable fashion, above the area in which the baited hooks enter the sea, so that seabirds are deterred from attempting to take bait from the hooks. In order to achieve this even during cross-winds, it is expected fishers will have to make adjustments to the configuration of the streamer line depending on the conditions.
- (ii) It is generally recognised as best practice to maximise the aerial extent of the streamer line, because this maximises the area in which the baited hooks are protected from seabirds. Best practice would be to achieve an aerial extent of 100 metres or more. In order to maximise aerial extent, it is necessary to create tension in the streamer line. This can be achieved by:
 - towing an object on the terminal end of the streamer line; or
 - towing extra length of streamer line; or
 - increasing the diameter of the in-water section of the streamer line.
- (iii) In order to be effective at scaring seabirds away from the line of baited hooks, the streamer lines should not become tangled, either with each other or with the branchline. Each streamer shall be attached to the streamer line in a manner to prevent fouling of individual streamers with the streamer line, and to ensure individual streamers reach the waterline in the absence of wind or swell. Swivels or a similar device can be placed in the streamer line in such a way as to prevent streamers being twisted around the streamer line. Each streamer may also have a swivel or other device at its attachment point to the streamer line to prevent fouling of individual streamers.
- (iv) Streamers are to be spaced at 5-metre intervals along the aerial extent of the line. The total number of streamers in use will vary depending on how the line is configured. Streamers that are hanging in the water can be prone to tangling. Because the far end of the streamer line will frequently be in the water, fishers may not wish to have streamers the whole way down the line. However, it is important that streamers are present to deter birds from taking baited hooks all along the part of the line that remains above water, as outlined in the specifications.
- (v) To ensure streamers are visible to birds, they should stand out against the surroundings. Streamers should be made of brightly coloured fluorescent plastic tubing or other material. Bright colours such as red, yellow, orange or pink are most effective during day setting. For night setting, the streamers should be of a colour that contrasts with the surroundings. Colours such as blue and green are less likely to be effective, because they are less likely to be highly visible to birds.
- (vi) A complete additional streamer line should be carried as a spare.
- (vii) When externally weighted gear is used, it is not necessary for all the weight specified to be applied at 60-metre intervals along the hook-bearing line. It is equally permissible for multiple weights of smaller sizes to be attached to the hook-bearing line at shorter intervals, as long as the total weight attached along every 60 metres of hook-bearing line meets the requirement. For example, under clause 8(1)(a) of this notice, 4 kilograms of metal weight is required for every 60 metres of line. It is permissible to attach the following combinations, or any other variation that totals 4 kilograms:
 - one 4 kilogram metal weight every 60 metres along the hook bearing line; or
 - one 2 kilogram metal weight every 30 metres along the hook bearing line; or
 - one 1 kilogram metal weight every 15 metres along the hook-bearing line.

Clause 1: Title, commencement and expiry—(1) This notice is the Authorised Futures Dealers Notice 2008.

(2) This notice comes into force on the day after the date of its publication in the *New Zealand Gazette*.

(3) This notice expires on the close of 31 March 2013.

Clause 2: Interpretation—(1) In this notice, unless the context otherwise requires:

“Act” means the Securities Markets Act 1988.

“AFS Licence” means an Australian financial services licence granted under the Corporations Act 2001.

“ASIC” means the Australian Securities and Investments Commission.

“Commission” means the Securities Commission.

“company” means HiFX Limited.

“Corporations Act 2001” means the Corporations Act 2001 of the Commonwealth of Australia.

“product disclosure statement” means a document:

- (a) that describes and contains the offer of, and relates specifically to, the specified futures contracts;
- (b) that is identical to a document that is:
 - (i) a product disclosure statement in terms of the Corporations Act 2001; and
 - (ii) signed by the persons (if any) who are required by law to sign that document;
- (c) by means of which it is lawful under the laws of Australia to make an offer of the specified futures contracts to the public in Australia; and
- (d) that is not an “offer information statement” or “profile statement” (as those terms are defined in section 9 of the Corporations Act 2001).

“Regulations” means the Futures Industry (Client Funds) Regulations 1990.

“specified futures contract” means a futures contract that is a forward foreign exchange contract, that is issued by the company and described in the product disclosure statement.

(2) Any term or expression that is defined in the Act or the Regulations and used, but not defined, in this notice has the same meaning as in the Act or the Regulations.

Clause 3: Retail and Wholesale Client Authorisation—

(1) The company is authorised to carry on the business of dealing in specified futures contracts to which the company is, or intends to be, a party.

(2) The authorisation in this clause 3 is subject to the conditions that:

- (a) the company does not enter into specified futures contracts with any person other than a person who has entered into a written agreement with the company, and then only in accordance with the terms of that agreement;
- (b) the company is licensed as an Australian Financial Services Licensee under the Corporations Act 2001 and holds an AFS Licence which authorises the company to advise retail and wholesale clients on,

and deal with or on behalf of retail and wholesale clients in, specified futures contracts;

- (c) there is a product disclosure statement relating to the specified futures contracts at the time that the specified futures contracts are made available to New Zealand investors or the company gives advice or assistance to, or induces or attempts to induce, New Zealand investors in relation to the acquisition or disposal of any specified futures contract;
- (d) before the company enters into a specified futures contract with any person, that person has received copies of the following:
 - (i) A product disclosure statement relating to that specified futures contract; and
 - (ii) every supplementary product disclosure statement relating to that specified futures contract in use at the time of the entry by the company into the specified futures contract;
- (e) the company must hold client funds in a segregated client funds account as if the funds were subject to the provisions of its AFS licence, the Corporations Act 2001 and any regulations made under the Corporations Act 2001 in relation to the protection of client money and client property;
- (f) the company maintains proper records:
 - (i) to record dealings in respect of specified futures contracts with clients;
 - (ii) to record client money, funds and property held or received in connection with dealings in specified futures contracts; and
 - (iii) which are audited or reviewed, and reported on, in accordance with the company’s AFS Licence;
- (g) the company maintains adequate professional indemnity insurance for its business at all times;
- (h) the company maintains at all times an external dispute resolution scheme that is available to its New Zealand clients who are members of the public; and

Statement of Significant Accounting Policies for the Year Ended 31 March 2007

A. Basis of Preparation

The Community Trust of Southland was formed under the Trustee Banks Restructuring Act 1988 and is incorporated under the Charitable Trusts Act 1957. The financial statements presented are those for The Community Trust of Southland (“the trust”) making up the parent. The group consists of The Community Trust of Southland (“the trust”), its wholly owned subsidiary companies Southland Community Trust Charities Limited and Invest South Limited Group.

The financial statements comply with the Financial Reporting Act 1993, the Community Trusts Act 1999 and the Companies Act 1993. They comprise statements of the following: Significant accounting policies, financial performance, movements in trust funds, financial position, cash flows, as well as notes to these statements.

The financial statements are prepared on the basis of historical cost except that investment assets are stated at valuation, as is the trust’s property at 62 Don Street, Invercargill.

B. Consolidation Method

The financial statements of the trust’s wholly owned companies are included in the financial statements of the group using the purchase method of consolidation.

C. Associates

Associates are entities in which the group has significant influence, but not control over the operating and financial policies. The financial statements include the group’s share of the net surplus of associates since acquisition on an equity accounted basis.

D. Goodwill Arising on Acquisition of Associates

Goodwill arising on the acquisition of an associate represents the excess of the purchase consideration over the fair value of the identifiable assets acquired. Goodwill is stated at cost and amortised to the statement of financial performance on a straight line basis over the period during which benefits are expected to be derived – a period not exceeding 20 years.

E. Trust Capital

Following the sale of the trust’s shares in Trust Bank New Zealand Limited in April 1996 for \$158,460,000, the trustees agreed that the value of the trust at that time should be maintained for the benefit of current and future generations living in the region. For this purpose, the trustees agreed that \$158,460,000 would be considered as the “trust capital” value of the parent. Trustees

further agreed that over the long term, the net assets of the parent would not be allowed to reduce to a level below the inflation-adjusted real value of this trust capital.

F. Capital Maintenance Reserve

The capital maintenance reserve represents the additional amount necessary to preserve the real value of the trust capital allowing for inflation as measured by the Consumers Price Index (all groups) and payments of grants out of capital.

G. Grants Maintenance Reserve

While the trustees have adopted a long-term investment strategy, they accept that annual returns from investments are likely to fluctuate from year to year. In recognition of this, a grants maintenance reserve is maintained. In years when net income from investments is higher than the grant levels, surplus income will be transferred to this reserve. In years when there is insufficient income to sustain the level of grants, an appropriate amount will be transferred from the grants maintenance reserve to income.

H. Basis of Recognising Components of the Financial Statements

The following general accounting policies are adopted:

Assets

A transaction results in an asset being recognised in the statement of financial position when it will probably give rise to ongoing benefits for the group and those benefits can be measured with reliability.

Liabilities

A transaction results in a liability being recognised in the statement of financial position when it will probably give rise to the need for the group to sacrifice assets in the future and those sacrifices can be measured with reliability.

Revenue

Revenue is recognised in the statement of financial performance when a transaction gives rise to an increase in the value of the group's net assets, and that increase can be measured with reliability.

Expenses

An expense is recognised in the statement of financial performance when a transaction results in a decrease in the value of the group's net assets, and that decrease can be measured with reliability.

Classification of Assets and Liabilities Between Current and Non-current

An amount is classified as current when it is expected to be settled or extinguished within one year of the date of the financial statements. All other amounts are classified as non-current.

I. Property, Plant and Equipment (Parent)

Property, plant and equipment are initially stated at cost and then depreciated on a straight line basis. Land and buildings are stated at valuation as determined by an independent registered valuer. The basis of valuation of the land and buildings is highest and best use. Revaluation surpluses are taken directly to the revaluation reserve. Decreases in value are debited directly to the revaluation reserve to the extent they reserve previous surpluses and are otherwise recognised as expenses (and income on subsequent reversal) in the statement of financial performance. The estimated useful lives of fixed assets are as follows:

J. Property, Plant and Equipment (Group)

Property, plant and equipment are initially stated at cost and then depreciated using maximum rates approved for taxation purposes. The rates and method applied are as follows:

Furniture and fittings	11.4% – 18.0% diminishing value
Office equipment	22.0% – 60.0% diminishing value
Motor vehicles	7.5% diminishing value
Other assets	48.0% diminishing value

K. Investments with Fund Managers

Investments with fund managers are stated at market value. Realised and unrealised gains or losses on holding these investments are recognised in the statement of financial performance. These gains or losses are shown in the statement of financial performance as income from revaluation of investments.

L. Other Investments

Cash investments are stated at cost plus interest credited or accrued to balance date.

M. Accounts Receivable

Accounts receivable are stated at expected realisable value.

N. Rental Payments

Invest South Limited Group leases its premises in addition to certain items of plant and equipment. Operating lease payments, where the lessors effectively retain substantially all the risks and benefits of ownership of the leased items, are included in the determination of the operating surplus/(deficit) in equal instalments over the lease term.

O. Loan Funding Advances

Invest South Limited (a subsidiary) has advanced monies to non-related entities as part of its core business activity. Interest is charged on these advances and accrued where necessary. The investments are recorded at expected realisable value.

P. Impairment

If the estimated recoverable amount of an asset is less than its carrying amount, the asset is written down to its estimated recoverable amount and an impairment loss is recognised in the statement of financial performance.

Q. Grants

Grants are recognised when they are approved by the trustees. Unpaid grants are recorded as a liability.

R. Goods and Services Tax

The parent is not registered for goods and services tax. The parent financial statements are prepared using GST inclusive accounting. The subsidiary of Invest South Limited Group is registered for GST and all assets and liabilities have been stated exclusive of GST with the exception of receivables and payables which are stated inclusive of GST.

S. Income Taxation

From 1 April 2004, section CB4(1)(m) of the Income Tax Act 1994, exempts the trust from income tax. Invest South Limited Group follows the income taxes payable method for accounting for income tax.

T. Statement of Cash Flows

Operating cash flows includes interest and dividends paid or credited to investment funds under management. Cash movements in funds invested are recognised in investing activities.

U. Inventories

Stock and work in progress are stated at the lower of cost and net realisable value. Cost is determined on a first in, first out basis (or weighted average cost method).

V. Changes in Accounting PoliciesNon Current Grants Committed but not Paid

The group has changed its accounting policy for non-current grants committed but not paid to comply with FRS-15: Provisions, Contingent Liabilities and Contingent Assets.

Grants Recognised as an Expense

The group has changed its accounting policy for treatment of grants. In the current year they are recognised as an expense, instead of as a distribution. This is consistent with the statement of concepts.

Other Changes

With the exception of the above changes in accounting policies, accounting policies have been applied on a consistent basis with those to the previous year.

W. Changes to Comparatives

Certain comparatives have been changed to give a more meaningful comparison.

The agreement provides that in the event of default, Invest South Limited has the right to put the shares back to Enno Oudshoorn and Klaas Smak at original cost. Default occurred on the loan advanced to Tulip International Limited and the company was placed into receivership.
- Woodlands Apiary Limited have defaulted on their loan payments and on 8 May 2007, Invest South Limited exercised its power under the loan agreement and appointed John White as receiver.

Exposure to currency, interest rate and credit risk arises in the normal course of the fund managers' management of the group's investments. 20. International Financial Reporting Standards

In December 2002, the New Zealand Accounting Standards Review Board announced that the New Zealand International Financial Reporting Standards (NZ IFRS) will apply to all New Zealand reporting entities for the periods commencing on or after 1 January 2007. Entities have the option to adopt NZ IFRS for periods beginning on or after 1 January 2005. The trust has decided to adopt IFRS effective from 1 April 2008.

The trust has started to assess the key differences in accounting policies between NZ IFRS and current NZ GAAP with a view to determining the impacts on the financial statements that are expected to arise on transition. As the trust has not yet completed an analysis of the differences between existing NZ GAAP and NZ IFRS, it is unable to reliably estimate the key differences in accounting policies or quantify the impacts to the financial statements that are expected to arise on transition to NZ IFRS.

21. Segmental Information

The trust's specified area includes all of the areas of Invercargill City Council, Southland District Council, Gore District Council, the Heriot and Tapanui areas of Clutha District Council, and the Wakatipu Basin area of Queenstown Lake District Council. The trust's principal activities are to invest the trust capital, both within the specified area and outside of the region, and to distribute grants for charitable, cultural, philanthropic, recreational and other purposes being purposes beneficial to the community principally within the trust's specified area.

22. Financial Instruments*General*

The group states its investments in managed funds at estimated market value. The trustees consider that the fair value of the financial assets is identical to the value in the statement of financial position.

Concentration of Credit Risk

The group from time to time has significant funds in trading bank deposits. The group limits risk by spreading the deposits over several trading banks. The group has not required collateral or other security to support its financial instruments. The group further limits risk through its policy of placing investment funds with five separate fund managers, with each fund manager having an investment mandate which requires that they diversify their investments on the group's behalf. The group has sought and obtained the advice of professional financial advisors prior to making its investment allocation and placement decisions.

Interest Rate Risk

The bank deposits are sensitive to changes in interest rates, as are a proportion of the funds managed by the fund managers.

23. Related Parties

There were no related party transactions during the year (2006: Nil).

24. Subsequent Events

Following balance date, Invest South Limited received \$105,066 from Bush Road Limited, being a pro rata share repurchase. Invest South Limited has also appointed John White as receiver of Woodlands Apiary Limited as at 8 May 2007. The financial effects of these events have not been recognised in the financial statements.

(2006: There were no significant events of which readers of the financial statements need to be aware).

- whether the accounting policies are appropriate to the trust's and group's circumstances, consistently applied and adequately disclosed.
