### Financial Reporting Act 1993

#### Financial Reporting Act (The Bank of Tokyo - Mitsubishi Ufj, Ltd.) Exemption Notice 2008

- in the case of copies of financial statements or group financial statements for that period that are required to be delivered for registration under section 19 of the Act, the exemption is granted before those documents are required to be delivered for registration under that section; or

- in any other case, the exemption is granted before the financial statements or group financial statements for that period are required to be completed; and

- subsequent accounting periods.

- Interpretation**—In this notice, unless the context otherwise requires:

**Act** means the Financial Reporting Act 1993.

**exempt overseas company** means The Bank of Tokyo - Mitsubishi Ufj, Ltd.

**specified financial statements**, in relation to the exempt overseas company, means the group financial statements that are required to be prepared in respect of the exempt overseas company in accordance with the laws of Japan.

**US GAAP** means generally accepted accounting principles in the United States of America.

**6. Exemptions for directors of exempt overseas companies**—(1) Every director of an exempt overseas company is exempted from the following provisions in respect of the exempt overseas company:

- Sections 10(1) and 11 of the Act to the extent that these sections require stand-alone overseas company financial statements to be prepared in accordance with New Zealand generally accepted accounting practice;
- section 13 of the Act to the extent that it requires group financial statements to be prepared in relation to the exempt overseas company to comply with section 14 of the Act; and
- section 19(3) of the Act to the extent that it requires copies of the financial statements of the exempt overseas company, together with a copy of the auditor's report on those statements, to be delivered to the Registrar for registration.

(2) Subclauses (1)(a) and (c) do not apply in relation to the New Zealand branch accounts that are required to be prepared in relation to the group's New Zealand business prepared in accordance with New Zealand generally accepted accounting practice as if the members of the group were companies formed and registered in New Zealand.

(3) Subclause (1)(c) does not apply in relation to the group financial statements that are required to be prepared in relation to the exempt overseas company under section 13 of the Act.

- if, in complying with US GAAP, the specified financial statements do not give a true and fair view of the matters to which they relate, the directors of the exempt overseas issuer add information and explanations that will give a true and fair view of those matters; and
- the specified financial statements are accompanied by a report by an approved auditor that complies with the requirements of Part 210 of the Code of Federal Regulations (United States of America).

#### Statement of Reasons

This notice, which comes into force on its notification in the *New Zealand Gazette* and expires on 30 July 2012, exempts the directors of The Bank of Tokyo - Mitsubishi Ufj, Ltd., a company that was incorporated in Japan, from various provisions of the Financial Reporting Act 1993 ("the Act").

The effect of the exemptions is to allow The Bank of Tokyo - Mitsubishi Ufj, Ltd. to provide the group financial statements that it is required to prepare under financial reporting requirements in Japan.

The principal differences in financial statements provided by overseas companies relying on the exemptions are:

- the directors of the overseas company will prepare and register financial statements for the New Zealand

business and consolidated financial statements only (not stand-alone parent company financial statements);

- the consolidated financial statements will comply with generally accepted accounting principles in the United States of America (rather than generally accepted accounting practice in New Zealand); and
- the consolidated financial statements will be audited in accordance with the requirements set out in Japanese legislation and the auditor's report will provide the information required by Japanese legislation instead of the Act.

The Registrar considers that it is appropriate to grant the exemptions because:

- the Registrar has had regard to the financial reporting and audit requirements that must be complied with by The Bank of Tokyo - Mitsubishi Ufj, Ltd. in its home jurisdiction, under which it is not required to prepare stand-alone parent company financial statements;
- The Bank of Tokyo - Mitsubishi Ufj, Ltd. will still be required to file financial statements for the group's New Zealand business prepared in accordance with New Zealand generally accepted accounting practice as if the members of the group were companies formed and registered in New Zealand; and
- the Registrar is satisfied that the consolidated financial statements required to be prepared under Japanese financial reporting laws provide sufficient information to avoid any detriment to members of the public who have dealings with The Bank of Tokyo - Mitsubishi Ufj, Ltd.; and
- the exemptions address the particular difficulties experienced by The Bank of Tokyo - Mitsubishi Ufj, Ltd. in complying with the Act. The exemptions are not broader than what is reasonably necessary to address these difficulties and still require that group financial statements be filed in New Zealand.

#### Alternative Constitution for the Board of Trustees of Te Kura Mana Māori o Maraenui (1806), Opotiki

Pursuant to section 105A of the Education Act 1989 ("the Act"), I hereby give the following notice.

##### Notice

1. The board of trustees of Te Kura Mana Māori o Maraenui shall be known as Te Poari o Te Kura Mana Māori o Maraenui ("the board").

2. The board, hereafter referred to as the poari, shall be constituted as follows:

- Up to 12 trustees appointed by the kai-kōkiri kaupapa ("KK") as parent representatives (refer paragraph 5) following the process set out in this notice;
- the principal of Te Kura Mana Māori o Maraenui;
- one staff representative appointed by the kai-kōkiri kaupapa following the process set out in this notice; and
- up to five trustees co-opted by the poari or appointed by a body corporate approved by the poari. There shall not be more than 14 trustees at any one time and co-option/appointment shall only be available if there are fewer than 12 parent representatives.

3. In accordance with section 94C of the Act, the poari may not have more trustees co-opted or appointed by a body corporate than parent representatives.

4. The appointment of parent representatives and the staff representative on the poari shall be managed by a person appointed by the poari. This person, known as the kai-kōkiri kaupapa ("KK"), shall not be considered for selection as a representative of the parent community or the staff on the poari and shall not be the principal.

5. The KK shall appoint parent representatives on the recommendation of a hui of parents of students enrolled at Te Kura Mana Māori o Maraenui and the school community ("parent/community hui"). The school community shall be defined as te hunga tāwharau o te kaupapa o te kura<sup>1</sup>. Parents are those persons defined in section 92(1) of the Act.

6. The KK shall appoint a staff representative on the recommendation of a hui of board staff of Te Kura Mana Māori o Maraenui ("staff hui"). Board staff are those current staff that are permanently employed or have worked for the poari for two months or more.

7. The KK shall fix dates for two hui to be held in May 2008 (parent/community hui and the staff hui). The appointment of the first trustees under this notice shall take place following these hui.

8. Two hui (parent/community hui and the staff hui) must be held every election year (as defined in section 92 of the Act) after 2008. The hui dates shall be set by the KK and shall be between 1 February and the third Tuesday in May.

9. The parent/community hui shall recommend up to 12 people to be appointed to the poari. The staff hui shall recommend one person to be appointed to the poari.

10. Board staff may not be appointed as parent representatives and may not participate in both the staff hui and parent/community hui. Board staff who have opted to participate in the parent/community hui are not eligible to be appointed as the staff representative.

11. If a board staff member is also eligible to participate in the parent/community hui, they may opt to participate in that hui instead of the staff hui. Board staff must make this decision known, in writing, to the KK at least seven days before the earliest hui in an election year. If no preferred option is made, board staff shall participate only in the staff hui. Board staff may only participate in one type of hui between the main hui in election years unless their eligibility status changes.

12. Following a hui, the KK shall appoint trustees in accordance with the recommendation of the hui.

13. The term of office for the parent and staff representatives shall commence on the day after that on which they are appointed and shall end at the close of the day before the day on which new representatives are appointed in an election year after 2008.

14. All current elected, co-opted and selected trustees on the board of trustees of Te Kura Mana Māori o Maraenui shall leave office at the end of the day before the day on which the new trustees take office in 2008.

15. If a casual vacancy for a staff representative occurs, the poari shall appoint a KK as soon as practicable to run a staff hui. The KK shall then appoint a replacement staff representative on the recommendation of the hui for the remainder of the departing trustee's term of office.

16. If a casual vacancy for a parent representative arises, then the poari must:

- (a) subject to paragraphs 17 and 18, resolve not to fill the vacancy and the vacancy shall cease to exist; or

- (b) appoint a KK who shall call a parent/community hui in accordance with paragraph 5 and appoint a replacement parent representative on the recommendation of the hui for the remainder of the departing trustee's term of office.

17. If the effect of not filling a casual vacancy for a parent representative would be to leave the poari with fewer parent representatives than trustees co-opted by the poari or appointed by a body corporate, then the poari must appoint a KK to call a hui in accordance with paragraph 5. The KK shall then appoint a replacement parent representative on the recommendation of the hui for the remainder of the departing trustee's term of office.

18. The poari may choose to leave any casual vacancy open, by not appointing a KK, if the vacancy occurred after 1 October in the year before an election year.

19. Subject to paragraphs 2 and 3, the poari may co-opt trustees.

20. Subject to paragraphs 2 and 3, the poari may grant a body corporate the right to appoint trustees. The poari may revoke any right of appointment granted without notice and the right to appoint shall cease immediately.

21. The term of office for trustees co-opted or appointed by an approved body corporate shall be for a term not exceeding three years. The resolution co-opting a trustee or granting the right to appoint may specify a shorter term of office.

22. The KK is responsible for:

- (a) notifying the parent and school community and the staff of the details of any relevant hui; and  
 (b) establishing the lists of the parents and the staff and ensuring all the parents and staff participating in the hui are eligible to do so and are not in breach of paragraph 11; and  
 (c) keeping a list of those who attend any hui; and  
 (d) obtaining written confirmation from those recommended by the hui that they wish to be a trustee and are not ineligible to be trustees under sections 103 and 103A of the Act; and  
 (e) taking responsibility for the way in which persons to be recommended by the hui are identified; and  
 (f) notifying the poari, the Secretary for Education (or authorised representative) and the public of those who have been appointed as parent and staff representatives on the poari.

23. The poari may claim reimbursement for the same expenses as would be paid to a board of trustees for the conduct of an election including fees for the KK (in the role akin to returning officer) in accordance with guidelines that are current at the time.

24. A trustee's office on the poari becomes vacant in the circumstances set out in section 104 of the Act.

25. Changes to the constitution of the board shall be subject to the approval of the Minister of Education and must be notified in the *New Zealand Gazette*.

- (b) Todd must enter into a deed in favour of and enforceable by the clearing manager providing that the clearing manager may set-off any amount owing by Todd under that third party guarantee against any amount payable by the clearing manager to Todd as if Rule 9.4.3 of Part H of the Rules applied to that amount owed by Todd;
- (c) Todd must ensure that any acceptable security that it provides from time to time under Rule 2.2.2 of Part H of the Rules secures its obligations under the third party guarantee that it provides under paragraph (a) of this clause in addition to its own obligations; and
- (d) Todd must at all times maintain a minimum level of security under paragraph (c) of this clause that equals an amount that would be determined from time to time under Rule 3.1.1 of Part H of the Rules if Todd and Bay of Plenty Energy were a single participant.

**4. Reasons for granting the exemption**—The reasons for granting this exemption are:

- (a) The exemption is granted on the condition that Todd provides a level of security which covers both Todd’s and Bay of Plenty Energy’s prudential requirement under the Rules so that the overall market prudential requirements will remain the same;
- (b) the clearing manager reviewed the proposed exemption and advised that the exemption would be practicable and would not result in a reduction in present levels of security;
- (c) Todd and Bay of Plenty Energy have informed the Commission that the consequences of not granting the exemption would be that Bay of Plenty Energy would incur additional costs if it were required to provide any other form of security, for example the operational costs of setting up and managing a letter of credit and the financial costs of obtaining a letter of credit at less favourable rates than Todd; and



- (d) there will be little or no impact on other participants and service providers and the exemption will not affect any other rules.

**5. Urgency**—(1) This exemption is granted under urgency in reliance on Regulation 194(4).

(2) This exemption expires at the close of 31 July 2008, being the earliest date that will enable the Commission to have regard to the views of participants.

(3) Pursuant to Regulation 194(5)(c), the Commission will publicise the exemption on the Commission's website and will have regard to any views that participants make known to it by 5.00pm on Friday, 9 May 2008.

#### *Land Transport Rule: Traction Engines [2008]* (Rule 63001)

This proposed Rule is intended to ensure the safe operation of traction engines in public places by specifying the qualifications for users of traction engines and the requirements for vehicle certification.

#### *Land Transport Rule: Vehicle Equipment (Immobilisers) Amendment [2008]* (Rule 32017/3)

This proposed Rule will amend *Land Transport Rule: Vehicle Equipment 2004*.

It would require that a new or used light passenger vehicle that is less than eight years old, and that enters New Zealand from the date the Rule comes into force, be fitted with an immobiliser in order to be certified for use on road.

This proposal is aimed at reducing opportunistic vehicle theft.

## Tertiary Education Commission

#### Amendment to the Constitution of Christchurch Polytechnic Institute of Technology Council 2008

1. This notice may be cited as the Amendment to the Constitution of Christchurch Polytechnic Institute of Technology Council 2008 and will come into force on the date of its publication in the *New Zealand Gazette*.

2. There shall be a council to be known as the CPIT Council (Te Kaunihera o Te Wānanga o Ōtautahi) which shall govern the Christchurch Polytechnic Institute of Technology ("CPIT").

3. The CPIT Council shall be constituted as follows:

- (a) Four members appointed by the Minister for Tertiary Education.
- (b) The Chief Executive Officer of CPIT.
- (c) One permanent member of the academic staff of CPIT elected by the permanent members of that staff.
- (d) One permanent member of the general staff of CPIT elected by the permanent members of that staff.
- (e) One member who is or has been a student of CPIT who shall represent the students of CPIT and who shall be appointed in accordance with the constitution of the Christchurch Polytechnic Students Association.
- (f) One member appointed by the CPIT Council after consultation with the Canterbury Employers Chamber of Commerce.
- (g) One member appointed by the CPIT Council after consultation with the New Zealand Council of Trade Unions.
- (h) One member nominated by Te Rūnanga a Ngāi Tahu after consultation with their community.
- (i) One member nominated by Te Puni Kōkiri or other relevant Crown agency after consultation with their community.
- (j) One member nominated by the Ministry of Pacific Island Affairs or other relevant Crown agency after consultation with the Pacific Island communities.
- (k) One member nominated by the Office of Disability Issues or other relevant Crown agency after consultation with their community.
- (l) One member nominated by the Office of Ethnic Affairs or other relevant Crown agency after consultation with the Asian communities.
- (m) Up to three members co-opted by the CPIT Council after consultation with community and industry groups to ensure that the overall membership of the CPIT Council reflects the social communities (ethnic and socio-economic diversity and the gender make-up of the New Zealand population) and employing sectors relevant to CPIT and includes members with the range of competencies required for the good governance of the institute.

4. In the event the CPIT Council and a nominating organisation are unable to agree on a person for appointment after a consultation period not exceeding six months, then the relevant nominating organisation's nominees shall be accepted by the CPIT Council.



5. The term of office of members of the CPIT Council, vacation of office, disclosure of members' interest and casual vacancies are covered by sections 173–176 of the Education Act 1989 ("the Act").

6. Subject to section 173 of the Act, the maximum term for any member, other than the chief executive officer, the student member and co-opted members, shall be three consecutive four-year terms.

7. The powers of the CPIT Council shall not be affected by vacancy in the membership thereof.

8. The CPIT Council's functions, duties and powers are set out in sections 180, 181 and 193 of the Act.

9. The CPIT Council may pass statutes for the good government and discipline of the institute and may delegate any of its functions or powers (except the power to appoint a chief executive).

10. The Christchurch Polytechnic Notice 1990 (published in the *New Zealand Gazette*, 1 November 1990, No. 191, page 4180) is revoked.
