Amended Boundaries.

Bounded on the north by the southern boundary of allotment No. 15 of the Parish of Pepepe and by the Tutaiakohea Creek to the Waikato River; on the north-east by the centre of the Waikato River from the Tutaiakohea Creek aforesaid, to the north-western boundary of the parish of Pukete; on the south-east by the north-western boundary of the parish of Pukete aforesaid, from the Waikato River aforesaid, to the southern

boundary of allotment No. 69A of the parish of Horotiu, thence by said southern boundary and by the southern boundaries of allotments Nos. 38, 60, 61, 62, and 64, all of the parish of Horotiu aforesaid, to the Waipa River; and on the west by the Waipa River aforesaid, to the road near the mouth of the Timaru or Blue Nose Creek, thence westward by said road for a distance of about 88 chains, thence by a right line bearing due north to the Hakarimata range, thence by said range and by a right line bearing north-east to the south-western boundary of allotment No. 15 of the parish Pepepe the point of commencement.
