BY virtue of the powers and authority vested in me as Superintendent by the eleventh section of "The Auckland Waste Lands Act, 1867," and, upon the recommendation of the Auckland Provincial Council, made in conformity thereto, I do hereby proclaim and declare that I have made the following Reserves, and dedicated the same to the public purposes respectively hereunder set forth, that is to say:—
