1. Complaints will be reported to Parliament, if at all, as mere *ex parte* statements, unless the Commissioners are satisfied that the persons thereby in anywise prejudicially affected have had notice of the intention to prefer the same in time to appear in opposition.

2. In general, publication of the substance of an intended complaint in the Hawke's Bay Government Gazette, ten days or more before the day of hearing, is to be deemed sufficient notice to all persons whom it may concern resident, or having an agent resident, within the Province: Provided that, as against natives, such publication must be in the Maori tongue.
