Complains that they were large owners in the Papakura Block, which was sold by Tareha and Wiremu Ngamaiai, and that complainants of the hapu received no part of the money. Ask Commissioners to enquire into the case, and to make it clear how the price of the land (£9500) was paid, and to order the Provincial Government or the sellers to pay the complainants and the rest of the hapu a fair share of the money.
