PROCLAMATION.

By JOHN DAVIES ORMOND, Esquire, Superintendent of the Province of Hawke's Bay, in the Islands of New Zealand.

WHEREAS by a Proclamation under the hand of Donald M'Lean, Esq., Superintendent of the Province of Hawke's Bay, dated the 3rd day of June, 1865, the land described in the Schedule hereto was, *inter alia*, reserved for public purposes; and whereas it is desirable to revoke the said Proclamation so far as it relates to the said land described in the said Schedule.

Now, therefore, I, the said JOHN DAVIES ORMOND, Superintendent as aforesaid, by virtue and in exercise of all powers in anywise enabling me in this behalf, do hereby revoke and annul the said Proclamation so far as it relates to the said land described in the Schedule hereto and no further.
