PROCLAMATION

By His Honor ISAAC EARL FEATHERSTON, ESQUIRE, Superintendent of the Province of Wellington, in the Islands of New Zealand.

WHEREAS by the Land Regulations now in force in the Province of Wellington, it is declared that all Reserves for the sites of Townships, or suburban lands for the sites of Agricultural and Small Farm Settlements, or for any other purpose of public advantage, safety, convenience, health, or enjoyment, shall be determined by the Superintendent, who shall notify the same by Proclamation, wherein the object shall be specified for which any reserve shall be made. And whereas, it would be of public advantage if certain land in the Moroa Block, in the Wairarapa District, was set apart for a Race Course: Now therefore, I, Isaac Earl Featherston, Superintendent of the Province of Wellington, in virtue of the power and authority vested in me in this behalf, Do hereby Proclaim and declare, that part of Section Number Four (4), in the Moroa Block, in the Wairarapa District, containing One hundred and twenty-one (121) acres, more or less; bounded North, by a public road,

East, by other part of the said Section No. 4, purchased by Mary Ann Nix, and by Section No. 1; South, by Section No. 5; and West, by the Tauherinikau River, is hereby reserved and set apart by me for the purpose aforesaid.

Appointing District of "Manawatu" under the Native Districts Regulation Act, 1858.

Present:—

HIS EXCELLENCY THE GOVERNOR IN COUNCIL.

WHEREAS by an Act of the General Assembly of New Zealand, intituled the "Native Districts Regulation Act, 1858," it is provided that it shall be lawful for the Governor in Council from time to time to appoint Districts for the purposes of the said Act, being Districts over which the Native title shall not for the time being have been extinguished:

Now, therefore, His Excellency the Governor, by and with the advice and consent of his Executive Council, doth hereby order, appoint, and declare that the Territory hereafter described shall be a District for the purposes of the said Act, that is to say: All territory lying within a boundary line commencing at the mouth of the Wangaehu River; thence by that river to the Ruahine Range; thence following the Ruahine and Tararua Ranges to Paekakariki Hill, thence westerly across Paekakariki Hill to the Sea; and thence by the coast line (including the Island of Kapiti) to the commencing point:

And doth appoint and declare that the said District shall be called the "Native District of Manawatu."

And doth declare that this Order shall take effect from and after the 31st day of March, 1862.

Notice is hereby given, that the most rigorous proceedings will be taken against any person enticing away, harbouring, concealing, or employing Deserters. The enactments relating to the above offence are subjoined for information.

**CLAUSES OF IMPERIAL ACTS
RELATING TO DESERTERS.**

NAVAL DESERTION.

10 and 11 *Vic.*, chap. 62, sec. 11.
"And be it enacted, That every person

who, by words, or any other means whatsoever, shall persuade any person in Her Majesty's Navy to desert, or improperly absent himself from his duty, shall forfeit and pay the sum of twenty pounds for every such act; and every person who shall assist or procure any person in Her Majesty's Navy to desert, or improperly absent himself from his duty; or shall conceal, employ, or continue to employ any person belonging to Her Majesty's Navy, who shall be a deserter, or improperly absent from his duty, knowing him to be such a deserter, or so improperly absent, shall forfeit and pay the sum of thirty pounds for every such assistance, procurement, concealment, employment, or continuing of employment as aforesaid."

MARINE DESERTION.

21 Vic., cap. 7, sec. 54

"Any person who shall, in any part of Her Majesty's dominions, by words or by any other means whatsoever, directly or indirectly, procure any Marine to desert; or shall by words or by any other means whatsoever, attempt to procure or persuade any Marine to desert; and any person who, knowing that any Marine is about to desert, shall aid or assist him in deserting; or, knowing any Marine to be a deserter, shall conceal such deserter, or aid or assist such deserter in concealing himself, or aid or assist in his rescue, shall be deemed guilty of a misdemeanor, and shall, on conviction thereof, be liable to be punished by fine or imprisonment, or both, as the Court before which such conviction shall take place may adjudge."

MILITARY DESERTION.

21 Vic., cap. 9, sec. 88.

"Any person who shall in any part of Her Majesty's dominions, or by any means whatsoever, directly or indirectly, procure any Soldier to desert, or attempt to procure or persuade any Soldier to desert, and any person who, knowing that any Soldier is about to desert, shall aid or assist him in deserting; or, knowing any Soldier to be a deserter, shall conceal such deserter, or aid or assist such deserter in concealing himself, or aid or assist in his rescue, shall be deemed guilty of a misdemeanor, and shall, on conviction thereof be liable to be punished by fine or imprisonment, or both, as the Court before which such conviction shall take place may adjudge."

PROCLAMATION.

By JOHN WILLIAMSON, Esquire,
Superintendent of the Province of Auckland, in the Colony of New Zealand.

WHEREAS by the "Diseased Cattle Act, 1861," it was provided that the Governor in Council might by warrant under his hand from time to time delegate to the Superintendent of any Province within the colony of New Zealand, all or any of the powers vested in the Governor or Governor in Council by the said Act, subject to such regulations as he might think fit, and might from time to time rescind such delegation; and whereas the said Governor hath with the advice and consent of the Executive Council of New Zealand delegated to John Williamson, Esquire, so long as he shall hold the office of Superintendent of the Province of Auckland, the several powers vested in the said Governor by the second, fourth, fifth, seventh, ninth, and tenth sections of the said Act, subject to being rescinded as in the said Act provided, and subject to the regulations issued by the Governor in Council, on the first day of October, One thousand eight hundred and sixty-one, and to any other regulations to be from time to time duly made.

Now, therefore, I, the said John Williamson, by virtue of such powers in me vested do hereby proclaim and declare,—That after the date hereof, the several colonies of Australia, that is to say, the colony of New South Wales, of Victoria, of South Australia, of Western Australia, and Queensland, as well as the colony of Tasmania, and the colony of the Cape of Good Hope, and the islands of Great Britain and Ireland, shall be deemed to be, for the purposes of the above recited Act, infected districts within the meaning of the said Act, and no cattle shall be allowed to be imported from the above

mentioned districts into the Province of Auckland until further notice; and that in case any cattle shall be imported from the said districts contrary to this Proclamation, such cattle shall be destroyed forthwith in such manner and at such places as the Superintendent may proclaim and appoint. Provided, however, that the Superintendent of the Province may allow any cattle to be landed from vessels from the Islands of Great Britain and Ireland subject to such conditions and restrictions as he may deem expedient, and the circumstances of the case may require.
