PROCLAMATION.

By His Honor ISAAC EARL FEATHERSTON, ESQUIRE, Superintendent of the Province of Wellington, in the Islands of New Zealand.

I, ISAAC EARL FEATHERSTON, Superintendent of the Province of Wellington in pursuance of the Regulations in this behalf, Do hereby Proclaim and notify that the Sections of Land in the Warehama Block in the East Coast District of the Province of Wellington, specified in the Schedule hereto, except such as may be reserved under the provision hereafter mentioned, will be put up for sale by public auction, at the Crown Land Office in the Town of Wellington, on Tuesday the twenty-first day of May, One thousand eight hundred and sixty-one, at one o'clock in the afternoon.

If at any time during the sale it may appear to the Commissioner of Crown Lands beneficial or expedient for the public service to reserve from sale either of the Sections specified in the said Schedule, or vary the order in which they are to be put up, he is hereby authorised to do so.
