PROCLAMATION.

By His Honor ISAAC EARL FEATHERSTON, Esq., Superintendent of the Province of Wellington in the Islands of New Zealand.

WHEREAS by the Land Regulations now in force in the Province of Wellington it is declared that all Reserves for the Sites of Townships or Suburban Lands, for the Sites of Agricultural and Small Farm Settlements, or for any other purpose of public advantage, safety, convenience, health, or enjoyment shall be determined by the Superintendent who shall notify the same by Proclamation, wherein the object shall be specified for which any Reserve shall be made: And whereas it would be of public advantage if certain lands in the Agricultural Reserve, in the Rangitiki District, were set apart for Educational purposes: Now therefore I, Isaac Earl Featherston, Superintendent of the Province of Wellington, in virtue of the power and authority vested in me in this behalf, Do hereby proclaim and declare that part of Section, Number twenty (No. 20), in the Agri-

cultural Reserve at Rangitiki, containing eighty (80) acres, two (2) rods, and two (2) perches, more or less,—Bounded North by land selected by James Hughes Hallett; East, by other part of the said Section selected by George Mastersou; and South and West by public roads, also part of Section, Number thirty-one (31) in the said Reserve, containing two hundred and fourteen (214) acres, more or less, bounded North by a public road; East by other part of the said Section, selected by John Alexander Gilfillan and John Gordon Gilfillan; South, by other part of the said Section selected by James Boyle; and West by a public road are hereby reserved and set apart by me for the purpose aforesaid.

Given under my hand and issued under the Public Seal of the Province of Wellington, at Wellington, this Twenty eighth day of November, One thousand eight hundred and sixty-one.
