A PROCLAMATION.

"Execution of Criminals Act, 1858," to come into operation in the Province of Wellington.

By His Excellency Sir GEORGE GREY, Knight, Commander of the Most Honorable Order of the Bath, Governor and Commander-in-Chief in and over Her Majesty's Colony of New Zealand, and its Dependencies, and Vice-Admiral of the same, &c., &c., &c.

WHEREAS by the "Execution of Criminals Act, 1858," it is enacted that the said Act shall come into operation in such part of the Colony of New Zealand as the Governor shall by Proclamation from time to time appoint to be Districts for that purpose:

Now I, George Grey, Governor of the said Colony, in pursuance and exercise of the said power, do hereby appoint and proclaim the Province of Wellington to be a District within which the said Act shall, from the date hereof, come into operation.

Appointing the Public Gaol of Wellington to be a place for the Execution of Criminals.

A PROCLAMATION.

To provide for the Protection of certain Birds lately introduced into the Colony.

By His Excellency Sir GEORGE GREY, Knight, Commander of the Most Honorable Order of the Bath, Governor and Commander-in-Chief in and over Her Majesty's Colony of New Zealand, and its Dependencies, and Vice-Admiral of the same, &c.

WHEREAS by the 9th section of the "Protection of certain Animals Act, 1861," it is provided that the Governor of New Zealand may, by Proclamation, declare that any Animals or Birds other than those specified in the said Act shall be protected and come under the operation of such of the provisions of the said Act as may be specified in such Proclamation.:

And whereas it is expedient that certain Birds recently imported into this Colony, and the increase arising therefrom, should be protected for a certain period:

Now, therefore I, George Grey, in virtue of the provision before recited, do hereby proclaim and declare that all Birds of the species hereinafter named respectively, that is to say, the Bird known as the "Indian Goose," and the Bird known as the "Diver," shall henceforth be protected and come under the operation of the Second, Sixth, Seventh, Eight, Eleventh

Twelfth, and Thirteenth Sections of the said Act.

Warrant authorising Convict Prison Regulations (supplementary) for the Province of Wellington.

By His Excellency Sir GEORGE GREY, Knight, Commander of the Most Honorable Order of the Bath, Governor and Commander-in-Chief in and over Her Majesty's Colony of New Zealand and its Dependencies, and Vice-Admiral of the same, &c., &c., &c.

WHEREAS by an Act of the General Assembly of New Zealand, intituled "The Secondary Punishment Act, 1854," it is enacted amongst other things "that it shall be lawful for the Governor from time to time to make such Rules and Regulations as to him shall seem meet for the employment, safe custody, management and discipline of the Convicts under sentence of penal servitude," &c.

Now therefore, I, George Grey, the Governor of the said Colony, do hereby, under and by virtue of the powers before recited, make and publish the following Regulations to be in force within the Province of Wellington, in addition and without prejudice to the Regulations published on the 31st day of May, 1859, that is to say:—

Prisoners of the first class will be allowed to smoke for fifteen minutes during the time set apart for breakfast and dinner, but at no other time,

Prisoners of the second class will not be allowed to smoke at any time.

RULES AND REGULATIONS RESPECTING THE FIRING FOR FOUR RIFLES, WITH CASES.

PRESENTED TO THE VOLUNTEERS IN NEW ZEALAND BY MESSRS. HERBERT & CO., OF LONDON.

Prizes.

1. First prize.—A Rifle and case, bore No. 451, and 1,000 rounds of ammunition.

2nd prize.—A Medium Rifle and case.

3rd do. do. do.]

4th do. do. do.]

Time and place of firing.

2. The firing to take place at such hours and places as the Officers Commanding at the different stations may deem convenient, commencing on Monday, the 3rd March. Should the weather prove unfavorable at any time appointed, the firing may be postponed at the discretion of the Officer Commanding at the Station.

Who eligible to compete.

3. The firing to be open to all Volunteers actually sworn in as such (Officers of the Force included). All intending competitors to send in their names on or before the 20th February next, to the Senior Officer of the Corps to which they belong, who shall forthwith cause lists to be compiled from the names sent in, but if he considers that any such person shall not have attended, when required, sufficiently regularly at drills, parades, training or exercise, he is authorised to prevent such person from firing for the prizes.

List of persons firing.

4. A list giving each competitor a number *only*, to be given to the Officer and Marker, another list to be made out with each competitor's name and corresponding number on it to be kept by the Officer Commanding and Officer stationed at the spot where the competitors fire from.

Competitors absenting themselves.

5. Should any competitor absent himself without leave when his turn comes to fire, he is to forfeit his chance, and a shot is to be fired in the air (which the marker will score as a miss), in order to keep the numbers on the lists correct.

Arms and Ammunition to be used.

6. Rifles supplied by Messrs. Hebbert & Co., and Ammunition supplied by the Government.

Mode of firing.

7. Without artificial rest. 1st range, standing; 2nd range, kneeling; 3rd range, in any position.

Wooden Targets when required to be ordered by the Officer Commanding, to be made at the different Stations, 6 feet by 2 feet, painted as shewn at the end.

Ties.

9. Ties to fire 5 rounds at 400 yards at one Target. In this case, shots to be measured from the centre of the Bull's Eye. Ties to be fired for and decided previous to forwarding the lists, and names to be placed on the lists in their proper order according to the number of points made.

Ring Shots

10. Competitors to have the benefit of any shot on the Ring.

Ricochets.

11. Any shots which touch the ground before hitting the Target (ricochets) be noted R in the column for misses.

Score.

12. All hits first count according to where the bullet "first strikes the Target.

Award of Score.

13. All differences as to points &c., to be decided by the Officer commanding the Corps at the Station, before any returns of the firing are finally made up.

Commanding Officers.

14. Officers Commanding Corps to be on the ground. One Officer to be appointed to call the names of competitors at the *place of firing* and another to remain near the target.

Marker.

15. A marker to be appointed by the Officer Commanding at each Station, who will be under the officer appointed to remain at the target.

Medical Officer.

16. The Medical Officer to attend. Where there are no Surgeons of Militia appointed, a Medical Practitioner to be employed.

Returns of firing.

17. A return of the names of all competitors, with the number of points scored by each, to be forwarded by the Officer Commanding at each Station to the Deputy Adjutant General at Auckland, according to the accompanying form, as soon as possible after the firing has ceased.

Caution against accidents

18. The attention of the Commanding Officers is particularly called to the following rules to prevent accidents:—

No competitor is to *cap* or *cock* his rifle before coming to the *spot* from which he is to fire.

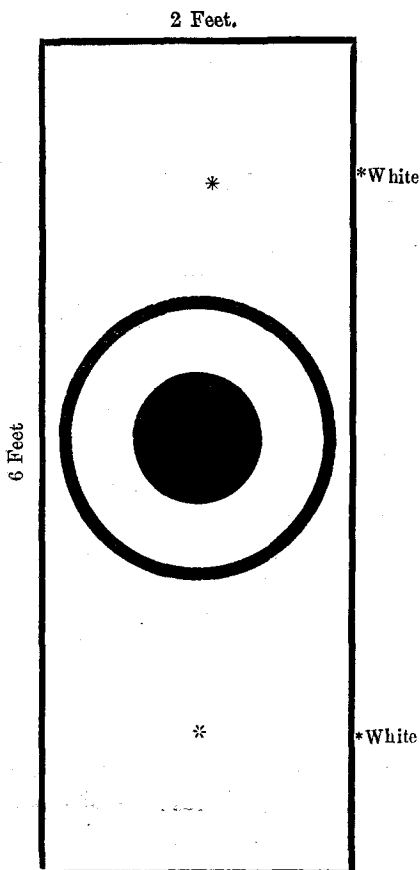
No competitor is to let the cock of his rifle down when an unexploded cap is on the nipple, but to keep it at half-cock.

NEW ZEALAND GOVERNMENT
PRIZES FOR THE BEST RIFLE
SHOTS.**

Prizes.

1. The first prize to be Fifty Pounds, the winner also to keep and wear the Champion Pouch and Belt for the best shot in New Zealand during the year in which he wins it.

The 2nd Prize to be Thirty-five Pounds.

3rd " " Thirty Pounds.
4th " " Twenty-five Pounds.
5th " " Twenty Pounds.
6th " " Seventeen Pounds Ten Shillings.

Time and place of firing.

2. The firing to take place at such hours and places as the Officers Commanding at the different stations may deem convenient, commencing on Tuesday, the 1st April. Should the weather prove unfavorable at any time appointed, the firing may be postponed at the discretion of the Officer Commanding at the Station.

Who eligible to compete.

3. The firing to be open to any person sworn in as a Militiaman since the 1st January, 1860, and to all Members of Volunteer Corps (Officers of both forces included.) All intending competitors to send in their names on or before the 20th March next, to the Senior Officer of the Corps to which they belong, who shall forthwith cause lists to be compiled from the names sent in, but if he considers that any such person, whether a Militiaman or Volunteer, shall not have attended, when required, sufficiently regularly at drills, parades, training or exercise, he is authorised to prevent such person from firing for the prizes.

List of persons firing.

4. A list giving each competitor a number only, to be given to the Officer and Marker, another list to be made out with each competitor's name and corresponding number on it to be kept by the Officer Commanding and Officer stationed at the spot where the competitors fire from.

Competitors absenting themselves.

5. Should any competitor absent himself without leave when his turn comes to fire, he is to forfeit his chance, and a shot is to be fired in the air (which the marker will score as a miss), in order to keep the numbers on the lists correct.

Arms and Ammunition to be used,

6. Rifles and Ammunition supplied by Government. N.B.—Spare Rifles will be furnished on the days of firing, to those who may require them.

7. Without artificial rest. 1st range, standing; 2nd range, kneeling; 3rd range, in any position.

Ties.

9. Ties to fire five rounds at four hundred yards at one Target. In this case, shots to be measured from the centre of the Bull's eye. Ties to be fired for and decided previous to forwarding the lists, and names to be placed on

the lists in their proper order according to the number of points made.

Ring Shots.

10. Competitors to have the benefit of any shot on the Ring.

Ricochets.

11. Any shots which touch the ground before hitting the Target (ricochets) to be noted, be in the column for misses.

Score.

12. All hits to count according to where the bullet "first" strikes the Target.

Award of Score.

13. All differences as to points, &c., to be decided by the Officer Commanding the Corps at the Station, before any returns of the firing are finally made up.

Commanding Officers.

14. Officers Commanding Corps to be on the ground. One officer to be appointed to call the names of competitors at the *place of firing*, and another to remain near the Target.

Marker.

15. A marker to be appointed by the Officer Commanding at each Station, who will be under the Officer appointed to remain near the Target.

Medical Officer.

16. The Medical Officer to attend. Where there are no Surgeons of Militia appointed, a Medical Practitioner to be employed.

Returns of Firing.

PLEURO PNEUMONIA.

By His Excellency SIR HENRY EDWARD FOX YOUNG, Knight, Companion of the Most Honorable Order of the Bath, Captain-General and Governor-in-Chief of the Colony of Tasmania and its Dependencies.

A PROCLAMATION.

WHEREAS the infectious disease known or described as Pleuro Pneumonia has appeared amongst Cattle in certain parts of the neighbouring Colony of Victoria, and it is necessary to take measures to prevent the introduction into this Colony of such disease: Now therefore I, SIR HENRY EDWARD FOX YOUNG, Knight, Companion of the Most Honorable Order of the Bath, Captain-General and Governor-in-Chief as aforesaid, with the advice of the Executive Council, and in pursuance of the provisions of the Act of Parliament of Tasmania, 25 Victoria, No. 4, do, by this my Proclamation, prohibit the introduction into this Colony, or into any Port thereof other than the Port of Hobart Town and the Port of Port Arthur, of any Cattle whatever, from any part of the Colony of Victoria, excepting Cattle from the District of Port Albert and shipped from the Port of Port Albert: And I do further notify and proclaim that all Cattle introduced into this Colony contrary to this Proclamation will be seized and forfeited to the Crown: And I do further notify and proclaim that, at the said Ports of Hobart Town and Port Arthur, for the purposes of this Proclamation, the following restrictions and regulations are to be observed; namely—All Cattle arriving in the said Ports of Hobart Town and Port Arthur from any part of the Colony of Victoria, excepting the Port of Port Albert, are to be landed at the nearest place to the sheds appropriated for the inspection of such Cattle so soon as such sheds shall be erected, and in the mean time at such place or places as may from time to time be in that behalf appointed; and immediately upon the landing of such Cattle they are to be removed to such sheds, or to such other place or places as may from time to time be in that behalf appointed, and are to be forthwith inspected by the person in that behalf appointed; and such Cattle as shall, upon such inspection by such person so to be appointed as aforesaid, be found and declared by him to be infected with the said disease of Pleuro Pneumonia

shall be immediately destroyed and their carcasses disposed of in such manner as the Governor shall direct; and all such Cattle as shall, upon such inspection, be found and declared by such person so to be appointed as aforesaid not to be infected with the said disease, shall be immediately removed to the Slaughter Yards at the said Ports of Hobart Town and Port Arthur, as the the case may be, there to remain until they shall be slaughtered.
