SIR—, I have the honour to inform you, that, Captain Jackson has communicated to me the existence of a Sunken Rock on which the sea breaks heavily, discovered by him, his vessel the *Shepherdess* having struck upon it, some seven years ago. Captain Jackson has not been able to ascertain its true position, the Rocks probably lay about 2½ miles S.S.E. from the landing place at Stony Hurst, and in the track of Steamers and vessels trading to Port Cooper.

## PROCLAMATION,

By His Honor ISAAC EARL FEATHERSTON, ESQUIRE, Superintendent of the Province of Wellington, in the Islands of New Zealand.

WHEREAS by an Act of the Provincial Council of the Province of Wellington, Session III, No. 4, Intituled "An Act to consolidate the law relating to District Highways," it was enacted among other things that the Superintendent might for the purposes of the said Act from time to time by Proclamation, divide the Province or any part thereof into Districts, and might in like manner sub-divide alter or re-unite the same. And Whereas it is expedient to proclaim the portion of the province hereinafter mentioned to be a District for the purposes of the said Act. NOW THEREFORE I ISAAC EARL FEATHERSTON, Superintendent of the Province of Wellington, in virtue of the power and authority vested in me, in this behalf, do hereby proclaim and declare that the Block of Land known as the Hundred of Masterton; in the Wairarapa Valley in the said province the boundaries of which are as follows;—viz. North a line commencing at the North-East corner of Section Number Seventy-one and running to a point Sixty Chains from the Wai-poua River at the Pa-kai-ko-kiri kiri and from thence in a straight line till it strikes the Wai-poua River, East the Ruamahunga River, South the Waingarua River, West the Tararua Range, shall form and constitute a District for the purposes of the District Highways Act and shall be called the "Masterton District."

Given under my hand and issued under the Public Seal of the Province of Wellington, at Wellington, this twenty-eighth day of February, one thousand eight hundred and sixty two.

## PROCLAMATION\*

By JAMES A. R. MENZIES, Esquire,  
Superintendent of the Province  
of Southland.

WHEREAS His Excellency th Governor in Council has been pleased to delegate under the "Diseased Cattle Act,

1861." to the Superintendent of the Province of Southland the several powers vested in the Governor by the 2nd, 4th, 5th, 7th, 9th, and 10th sections of the said Act, subject to the Regulations contained in the Order in Council of 1st October 1861;

And whereas by a Proclamation given under my hand, dated 2nd October 1861, it was amongst other things declared that the Inspector was thereby prohibited from granting a Certificate to land any Cattle imported from the Colony of Victoria; And whereas it is expedient to make further provision in that behalf:

Now, therefore, I, the said Superintendent, in virtue of the powers vested in me, do hereby proclaim that the Inspector of Cattle under the said Act shall not be authorised to grant a Certificate to land in the Province of Southland Cattle coming from any of the Australian Colonies, namely, Queensland, New South Wales (excepting as hereinafter mentioned), Victoria, South Australia, Western Australia, and Tasmania, from the date hereof: Provided that the Cattle arriving in the Province of Southland from the Port of Newcastle, in the Colony of New South Wales, in a vessel which shall have put to sea with the same on or before the 24th of December current (and which shall not thereafter have touched at the same, or at any other port until her arrival at a port within the Province of Southland), shall, under the provisions of sub-section d, section 4, of the said Act, be permitted to land upon the Quarantine Ground as the same has been defined in the Proclamation of 2nd October 1861 aforesaid, there to remain until the said Inspector shall permit the same to be removed from thence; the said Quarantine Ground being bounded on the west by the Bluff Harbour, on the north by the eastern arm of the said harbour, and by a right line extending due east from its eastern extremity until it intersects the east boundary of the Campbelltown Hundred; on the east by the east boundary of the Campbelltown Hundred, from the said point of intersection to the sea coast; on the south by the ocean.
